## Attachment 1 to Action 2 of Council Bill 120835

#### Amendment B to CB 120835 - SODA Zones

**Sponsor:** Councilmember Strauss

Adding Reporting Dimensions and Requiring Impact Evaluation

**Effect:** This amendment would add reporting dimensions to the annual report on the effect of CB 120835's application. The bill requires this report's publication by the Seattle Police Department with input from the City Attorney's Office. Additionally, the amendment would require that the Office of the City Auditor (City Auditor) conduct a phased evaluation of the bill's impacts, on a timeline that the Council and City Auditor would develop collaboratively.

#### 1. Amend Section 12A.21.040 as follows:

C. This Chapter 12A.21 and the effect of its application shall be reviewed at least every two years by the City Council. For each year, the Seattle Police Department, with input from the City Attorney's Office, shall publish a report no later than the end of the first quarter of the following year that provides the following information:

- 1. How many SODA orders were issued for each SODA zone;
- 2. How many arrests were made for violating the orders in each SODA zone;
- 3. Demographic information on those receiving orders and/or violating orders;
- 4. Analysis of illegal drug trafficking and drug use in SODA zones, including year-over-year statistics of drug-related crimes and whether dispersion of illegal drug trafficking and public use occurred in surrounding areas;
  - 5. The number of individuals who were referred to diversion services;
- 6. Analysis of the degree to which individuals with active SODA orders are believed to violate or to have violated them;

((and))

7. For the initial report, analysis of the prevalence of charges and convictions for crimes listed in Section 12A.21.020 for each SODA zone compared to the prevalence before the effective date of this ordinance;

8. For subsequent reports, analysis of the prevalence of charges and convictions for crimes listed in Section 12A.21.020 for each SODA zone compared to the prevalence as reflected in the previous report; and

9. Analysis of the extent to which charges and convictions for crimes listed in

Section 12A.21.020 may have been dispersed from each SODA zone into other areas of the city.

This report shall be provided to the City Clerk, the City Council, and published on the Seattle Police Department website.

## 2. Add a new Section 2 and renumber subsequent sections as appropriate:

Section 2. It is the intent of the Council that a phased evaluation of this ordinance be conducted by the Office of City Auditor (City Auditor).

A. At a minimum, this evaluation shall consist of: (1) a scoping exercise, to be initiated prior to the ordinance's implementation date, to determine what evaluative dimensions not referenced in Seattle Municipal Code subsection 12A.21.040.C would best contribute to an understanding of the ordinance's impacts and can be accomplished by the City Auditor with existing resources; (2) identification of evaluative dimensions that would enhance an understanding of the ordinance's impacts and would require incremental resources; (3) identification of potential implementation challenges and strategies that could mitigate them; (4) an evaluation of the implementation process; and (5) an impact evaluation consistent with the dimensions identified in the scoping exercise described in this subsection.

- B. The Council and the City Auditor shall collaboratively identify target completion dates for each of the deliverables required as components of the evaluation.
- C. The City Auditor's evaluation of the implementation process and the evaluation of the ordinance's impact ("impact evaluation") will require access to the data and analysis referenced in Seattle Municipal Code subsection 12A.21.040.C. To the extent that the City Auditor is not provided access to these products or that the products as delivered differ from their descriptions in this ordinance, the City Auditor may be unable to complete the requested deliverables.
- D. The City Auditor should consider including, in the impact evaluation, such dimensions as:
- 1. Disposition, at the King County Jail and any other contracted correctional facilities, of those convicted of the crimes listed in Seattle Municipal Code Section 12A.21.020;
- 2. For those receiving SODA orders, a comprehensive outcomes analysis including a racial and socioeconomic equity component;
- 3. Community response to the establishment of SODA zones and to any dispersal of activity related to crimes listed in Seattle Municipal Code Section 12A.21.020 out of any SODA zone into other areas of Seattle;
- 4. The degree to which medical, social, and legal service providers can substantiate that the existence, and specific boundaries of, SODA zones has been a barrier to the receipt of services for their clients with active SODA orders, including clients' ability to access public defenders and other attorneys;
- 5. Opportunities to confirm, refute, or refine any findings or recommendations from relevant audits previously completed by the City Auditor; and
  - <u>6. Potential or actual unintended consequences of this ordinance.</u>

## Amendment C to CB 120835 - SODA Zones

**Sponsor:** Councilmember Strauss

Adding Re-evaluation Requirements for SODA Zones

**Effect:** This amendment would add an element to the review of CB 120835's application. (The bill requires that this review take place at least every two years.) - ((1-)) a. How many SODA orders were issued for each SODA zone;
- ((2.)) b. How many arrests were made for violating the orders in each

SODA zone;

((3-)) c. Demographic information on those receiving orders and/or violating orders; and

((4.)) d. Analysis of illegal drug trafficking and drug use in SODA zones, including year-over-year statistics of drug-related crimes and whether dispersion of illegal drug trafficking and public use occurred in surrounding areas.

This report shall be provided to the City Clerk, the City Council, and published on the Seattle Police Department website.

2. This review shall include a presentation by the Seattle Police Department, with input from the City Attorney's Office, to the City Council Public Safety Committee, or successor committee, that re-evaluates each SODA zone and makes a recommendation for its continuance with existing borders, for its continuance with adjusted borders, or for its discontinuation as a SODA zone. Such recommendations shall have basis in the factors set forth in subsection 12A.21.040.C.1, in addition to other relevant data collected by the Seattle Police Department and City Attorney's Office, including quarterly crime trends (1) within each SODA zone and (2) in the several blocks surrounding each SODA zone compared to the same trends (1) within other areas of open-air drug activity that are not SODA zones and (2) citywide.

#### Amendment A to CB 120836 - Prostitution Crimes and Diversion

Sponsor: Councilmember Moore

Technical amendment

**Effect:** This amendment would change a word in the bill's definition of "commit prostitution" with respect to the Seattle Municipal Code (SMC) crime of prostitution loitering. The change would clarify that both buyers and sellers may commit prostitution with respect to that crime. This amendment would have no operational impact.

# 12A.10.010 Prostitution loitering

A. As used in this Section 12A.10.010:

1. "Buyer" means a person who pays a fee or offers to pay a fee.

((1.)) <u>2.</u> "Commit prostitution" means to engage, agree, or offer to engage in sexual conduct with another person in ((return)) exchange for a fee but does not include sexual conduct engaged in as part of any stage performance, play, or other entertainment open to the public.

((2.)) 3. "Public place" is an area generally visible to public view and includes streets, sidewalks, bridges, alleys, plazas, parks, driveways, parking lots, automobiles (whether moving or not), and buildings open to the general public including those that serve food or drink, or provide entertainment, and the doorways and entrances to buildings or dwellings and the grounds enclosing them.

4. "Seller" means a person who receives a fee or has been offered to receive a

fee.

#### Attachment 4 to Action 2 of Council Bill 120836

## Amendment B to CB 120836 - Prostitution Crimes and Diversion

**Sponsor:** Councilmember Hollingsworth

Clarifying reporting requirements

**Effect:** For required annual reporting included in the bill, this amendment would require that data about the Seattle Municipal Code crime of prostitution loitering disaggregate those charged as buyers and those charged as sellers. This data counts arrests, referrals to the City Attorney's Office for prosecution, and referred cases dismissed before or during trial.

Amend Section 12A.10.040 as follows:

F. City annual reporting and recommendations. The Office of the Inspector General (OIG) and/or an independent, academically based research organization engaged by OIG shall review implementation of this Section 12A.10.040. A preliminary report shall be provided to the Council by June 30, 2026. The following data, or an explanation of why the data is unavailable, and written recommendations shall be provided by the OIG to the Council by December 31, 2026, and at least annually by December 31 until 2030:

1. The number of 911 calls about prostitution loitering on a quarterly basis (including baseline years of 2019-2023 and the first half of 2024);

- 4. The numbers of each type of arrests for the crimes described in subsection 12A.10.040.A, with arrests for prostitution loitering as a buyer disaggregated from arrests for prostitution loitering as a seller;
- 5. The number of individuals transported for booking at jail and of that number: the name of the jail, the number of individuals who are booked into jail, the number of individuals the jail did not accept, the number of individuals transported to a medical facility;

- 6. The number of individuals released without booking into jail or being transported to a medical facility;
  - 7. The number of individuals administratively booked;
- 8. The number of prostitution and prostitution loitering cases referred to the City Attorney's Office for prosecution, with referrals for prostitution loitering as a buyer disaggregated from referrals for prostitution loitering as a seller;
- 9. The number of referred cases dismissed before or during trial, including prefiling diversion, with dismissals of cases for prostitution loitering as a buyer disaggregated from dismissals of cases for prostitution loitering as a seller;

# Attachment 5 to Action 4 of Council Bill 120836

## Amendment D to CB 120836 – Prostitution Crimes and Diversion

**Sponsor:** Councilmember Strauss

Adding Reporting Dimensions and Requiring Impact Evaluation

**Effect:** This amendment would add reporting dimensions to the annual report on the effect of CB 120836's application. The bill requires this report's publication by the Seattle Police Department with input from the City Attorney's Office. Additionally, the amendment would require that the Office of the City Auditor (City Auditor) conduct a phased evaluation of the bill's impacts, on a timeline that the Council and City Auditor would develop collaboratively.

## 1. Amend Section 12A.10.040 as follows and renumber as appropriate:

E. City annual reporting and recommendations. The Office of the Inspector General (OIG) and/or an independent, academically based research organization engaged by OIG shall review implementation of this Section 12A.10.040. A preliminary report shall be provided to the Council by June 30, 2026. The following data, or an explanation of why the data is unavailable, and written recommendations shall be provided by the OIG to the Council by December 31, 2026, and at least annually by December 31 until 2030:

- 1. The number of 911 calls about prostitution loitering on a quarterly basis (including baseline years of 2019-2023 and the first half of 2024);
- 2. The number of documented contacts between police officers, including community service officers, and individuals encountered during enforcement of the crimes described in subsection 12A.10.040.A;
- 3. The number of attempts by police officers, including community service officers, to contact and coordinate efforts for diversion, referral to social services, safe house placement, and other alternatives to booking as described in subsection 12A.10.040.D;

- 4. Data describing the number of individuals who were referred to diversion services, broken out by type of service and provider;
- ((4.)) <u>5.</u> The numbers of each type of arrests for the crimes described in subsection 12A.10.040.A;
- ((5.)) 6. The number of individuals transported for booking at jail and of that number: the name of the jail, the number of individuals who are booked into jail, the number of individuals the jail did not accept, the number of individuals transported to a medical facility;
- ((6.)) 7. The number of individuals released without booking into jail or being transported to a medical facility;
  - ((7.)) 8. The number of individuals administratively booked;
- ((%)) 9. The number of prostitution and prostitution loitering cases referred to the City Attorney's Office for prosecution;
- ((9-)) 10. The number of referred cases dismissed before or during trial, including pre-filing diversion;
  - ((10.)) 11. The reasons for dismissal of referred cases;
- ((11.)) 12. The results of any interviews of SPD personnel with experience in the field implementing this Section 12A.10.040 and their suggestions, if any, for improving the law or related policies; and
- ((12.)) 13. Any other information deemed by OIG as helpful for the purpose of review required by this subsection 12A.10.040.E or providing written recommendations. OIG will work with SPD to determine reporting requirements and periodicity.
- 2. Add a new Section 6 and renumber subsequent sections as appropriate:

Section 6. It is the intent of the Council that a phased evaluation of this ordinance be conducted by the Office of City Auditor (City Auditor).

A. At a minimum, this evaluation shall consist of: (1) a scoping exercise, to be initiated prior to the ordinance's implementation date, to determine what evaluative dimensions not referenced in Seattle Municipal Code subsection 12A.10.040.E (City annual reporting and recommendations) would best contribute to an understanding of the ordinance's impacts and can be accomplished by the City Auditor with existing resources; (2) identification of evaluative dimensions that would enhance an understanding of the ordinance's impacts and would require incremental resources; (3) identification of potential implementation challenges and strategies that could mitigate them; (4) an evaluation of the implementation process; and (5) an impact evaluation consistent with the dimensions identified in the scoping exercise described in this subsection.

B. The Council and the City Auditor shall collaboratively identify target completion dates for each of the deliverables required as components of the evaluation.

C. The City Auditor's evaluation of the implementation process and the evaluation of the ordinance's impact ("impact evaluation") will require access to the data and analysis referenced in Seattle Municipal Code subsection 12A.10.040.E (City annual reporting and recommendations). To the extent that the City Auditor is not provided access to these products or that the products as delivered differ from their descriptions in this ordinance, the City Auditor may be unable to complete the requested deliverables.

D. The City Auditor should consider including, in the impact evaluation, such dimensions as:

- 1. Disposition, at the King County Jail and any other contracted correctional facilities, of those convicted of the crimes listed in Section 12A.11.020;
- 2. For those receiving SOAP orders, a comprehensive outcomes analysis including a racial and socioeconomic equity component;
- 3. Community response to the establishment of SOAP zones and to any dispersal of activity related to the crimes listed in Section 12A.11.020 out of any SOAP zone into other areas of Seattle;
- 4. The degree to which medical, social, and legal service providers can substantiate that the existence, and specific boundaries of, SOAP zones has been a barrier to the receipt of services for their clients with active SOAP orders, including clients' ability to access public defenders and other attorneys;
- 5. Opportunities to confirm, refute, or refine any findings or recommendations from relevant audits previously completed by the City Auditor;
  - 6. Potential or actual unintended consequences of this ordinance;
- 7. Efficacy of the ordinance in disrupting commercial sexual exploitation, focusing on commercial sexual exploitation in SOAP Zone 1; and
- 8. The efficacy of diversion, referral to social services, safe house placement, and other alternatives to booking, and an analysis of what resources and opportunities may help those receiving these resources.
