

13 and staff and committee resources are not limited to matters contained in the Work Program.


14 Section 2. Where conflicts exist between the attached work program and the duties of

### **AFFORDABLE HOUSING ON PUBLICLY-OWNED LAND**

Review consultant work related to community planning and project feasibility for development of affordable housing on publicly owned land in the City. This effort will produce an inventory of all publicly owned land in the City and identify 1 or 2 sites in 2017 for development as affordable housing.

### **CONSOLIDATED PLAN FOR HOUSING AND COMMUNITY DEVELOPMENT**

Review and adopt the 2017 Update to the Consolidated Plan.

### **FAIR HOUSING**

Review and adopt Assessment of Fair Housing Plan. This federally mandated plan is intended to: dismantle patterns of segregation; reduce racial and ethnic concentrations of poverty; identify and address disproportionate housing needs; increase housing mobility for low-income households; reduce disparities in housing choice and access to community assets based on protected classes; and equitably expand neighborhood assets and enhance quality of life for all.

### **FORT LAWTON**

Review and consider modifications, if appropriate, to the Fort Lawton Redevelopment Plan.

---

### **HOUSING AFFORDABILITY AND LIVABILITY AGENDA**

Review and consider legislation implementing recommendations of the Housing Affordability and Livability Agenda (HALA) Committee, including: use of surplus property for housing, tenant protection proposals, short term rentals regulation, etc. Review annual report tracking progress in achieving goals for development of rent and income restricted housing (20,000 over ten years) and market rate housing (30,000 over ten years).

**HOUSING LEVY AND LEVY OVERSIGHT COMMITTEE**

Review and adopt the Administrative and Finance Plan for the 2016 Housing Levy. Review annual report on 2009 Housing Levy.

Review annual report on Housing Levy programs. Receive recommendations from the Housing Levy Oversight Committee. Review proposed changes in Levy administrative and financial policies as needed.

**MULTIFAMILY TAX EXEMPTION (MFTE) PROGRAM**

Consider potential changes to the MFTE Program in light of the Housing Affordability and Livability Agenda (HALA) recommendations. Review annual report on MFTE program.

---

**RENTERS COMMISSION**

Appoint members to the new 15 person Renters Commission. This commission will advise and make recommendations to the Mayor and City Council on public policy matters of importance to renters citywide.

**SEATTLE HOUSING AUTHORITY (SHA) HOUSING PROJECTS**

Review reports on Yesler Terrace Redevelopment project and Seattle Senior Housing Program. Consider legislation, as necessary, related to these and other SHA owned properties which include City funding and/or restrictions.

**HUMAN RESOURCES****CAREER QUEST AND TALENT MANAGEMENT**

Monitor the development of the Human Resources Consolidation Strategic Plan, Talent Management System, and the Career Quest Program.

---

**LABOR AND PERSONNEL LEGISLATION**

Review quarterly employment ordinances, annual pay zone ordinance, potential cost of living adjustment ordinance, legislation authorizing collective bargaining agreements, and other personnel legislation proposed by the Executive.

Monitor the creation and work program for the new Community Involvement Commission and the Community Involvement plans being created by City departments.

**HISTORIC PRESERVATION**

### **CHINATOWN-INTERNATIONAL DISTRICT (ID), CAPITOL HILL AND LITTLE SAIGON SMALL BUSINESS**

Monitor the progress of the organization(s) receiving funding to provide assistance to the small business community. Support the Ethnic Business Coalition's design and implementation of strategies that will mitigate tenant vacancies in Chinatown-ID.

---

### **CITY CONTRACTING POLICIES AND PRACTICES**

Review City contracting policies and practices, including requirements and technical assistance for women and minority owned enterprises, priority hiring, etc.

Monitor OED study on the status of legacy businesses.

Monitor land use efforts concerning protections for industrial lands, particularly for Port-related and other maritime uses. Monitor Stadium District recommendations. Review Puget Sound Regional Council (PSRC) report on Industrial Lands. Consider recommendations to improve manufacturing workforce development. Review implications of new Seaport Alliance between Seattle and Tacoma Ports.

---

## **NEIGHBORHOOD BUSINESS DISTRICT SUPPORT**

Monitor and examine implementation of the Only in Seattle program and consider expanding neighborhood business district priorities and programs in 13 neighborhoods.

---

## **NEW MARKETS TAX CREDIT (NMTC) PROGRAM AND OTHER LENDING PROGRAMS**

Participate in the Committee that makes decisions regarding allocation of NMTCs. Review annual report on NMTC program.

---

## **OFFICE OF FILM AND MUSIC**

Review and monitor economic development-related legislation including but not limited to City nightlife ordinances, talent and job development initiatives, and business capacity in neighborhood districts.

---

## **PRIORITY HIRE**

Monitor implementation of the Priority Hire program.

---

## **WORKFORCE DEVELOPMENT AND HIGHER EDUCATION POLICIES AND INVESTMENTS**

Review the Office of Economic Development's ongoing policy and programmatic work in workforce development including recommendations made by the Workforce Development Council of Seattle and King County. Advocate for provision of financial empowerment services for those accessing training/educational services. Continue to explore development of higher education/skill/entrepreneurial training center in Southeast Seattle.

## **WORKFORCE DEVELOPMENT COUNCIL WORKFORCE ECOSYSTEM PROJECT**

Pursuant to 2015 Statement of Legislative Intent (SLI) 15-1-A-1, review OED's report of the organizational assessment study ("Workforce Ecosystem Project") conducted by the Workforce Development Council.

Monitor and address impacts to private property related to aging drainage infrastructure.

**COLLECTION OBLIGATIONS**

Monitor garbage, recycling, and compost collection including obligations to Business Improvement Areas.

---

## **SOLID WASTE FUND ISSUES**

Address Solid Waste Fund issues including contract renewals, capital improvement implementation such as the North Transfer Station re-opening, rates and rate design proposals, and bond sales.

## **UTILITIES - SPU WATER FUND**

### **WATER FUND ISSUES**

Address Water Fund issues including regional water management relations, rates and rate design proposals, easements, grant agreements, revenue stabilization subfund report review, water system plan update, Cedar River Habitat Conservation Plan (HCP) implementation, bond sales, and sale of surplus property such as unneeded reservoir sites.

## **UTILITIES - SPU-WIDE, REGIONAL AND OTHER ISSUES**

### **GREEN STORMWATER INFRASTRUCTURE**

Assess potential opportunities to expand and accelerate implementation of the green stormwater infrastructure.

### **COMMITTEE COORDINATION AND LEGISLATION**

Coordinate the committee's work program in consultation with the Committee Chair and their staff. Review Executive proposed legislation assigned to Committee.

### **COMMUNITY BENEFITS AGREEMENTS**

Research, assess, and develop policy options for utilization of Community Benefits Agreements (CBAs). Options would include, but not be limited to establishing when CBAs could be required as a condition of development and what role the City would play in developing and enforcing CBAs.

### **EQUITABLE TRANSPORTATION**

Explore opportunities to increase access to transit and transportation systems for users of all financial means.

---

### **PARKING ORDINANCES, INCLUDING SCOFFLAW ORDINANCE**

Explore solutions to disparate and geographic impacts of the City's parking regulations.

### **STREETCAR SAFETY DESIGN WORKGROUP**

## **PROJECT AND PROGRAM OVERSIGHT**

### **ALASKAN WAY TUNNEL/SR-99 OVERSIGHT**

Monitor progress on Washington State Department of Transportation (WSDOT) State Route 99/Tunnel replacement including but not limited to (1) demolition of the viaduct and decommissioning of the Battery Street Tunnel; (2) construction of a new Alaskan Way surface street and new Elliott Way; (3) tolling-related issues; and (4) agreements with the State of Washington regarding the responsibilities and funding to accomplish the above.
