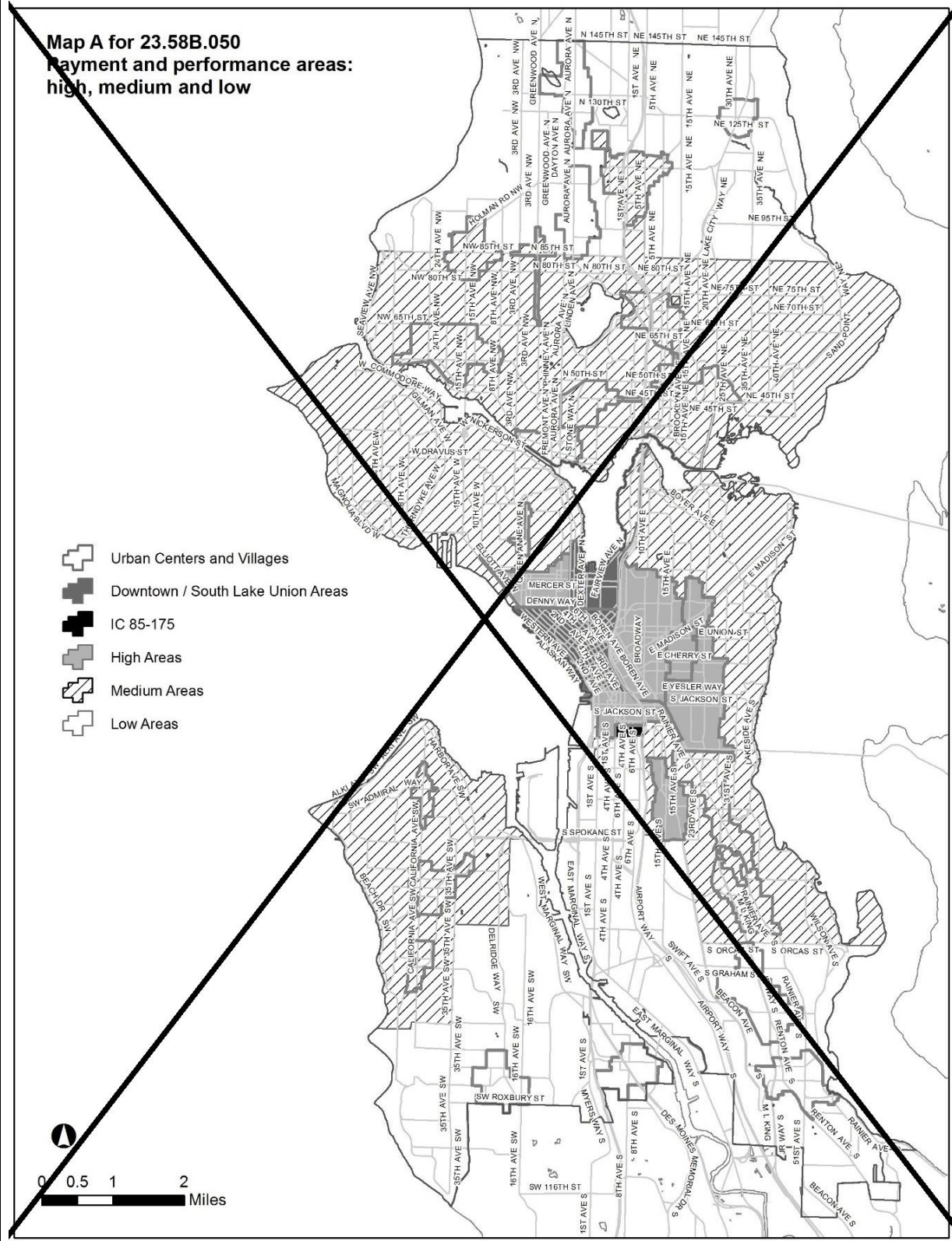

**BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

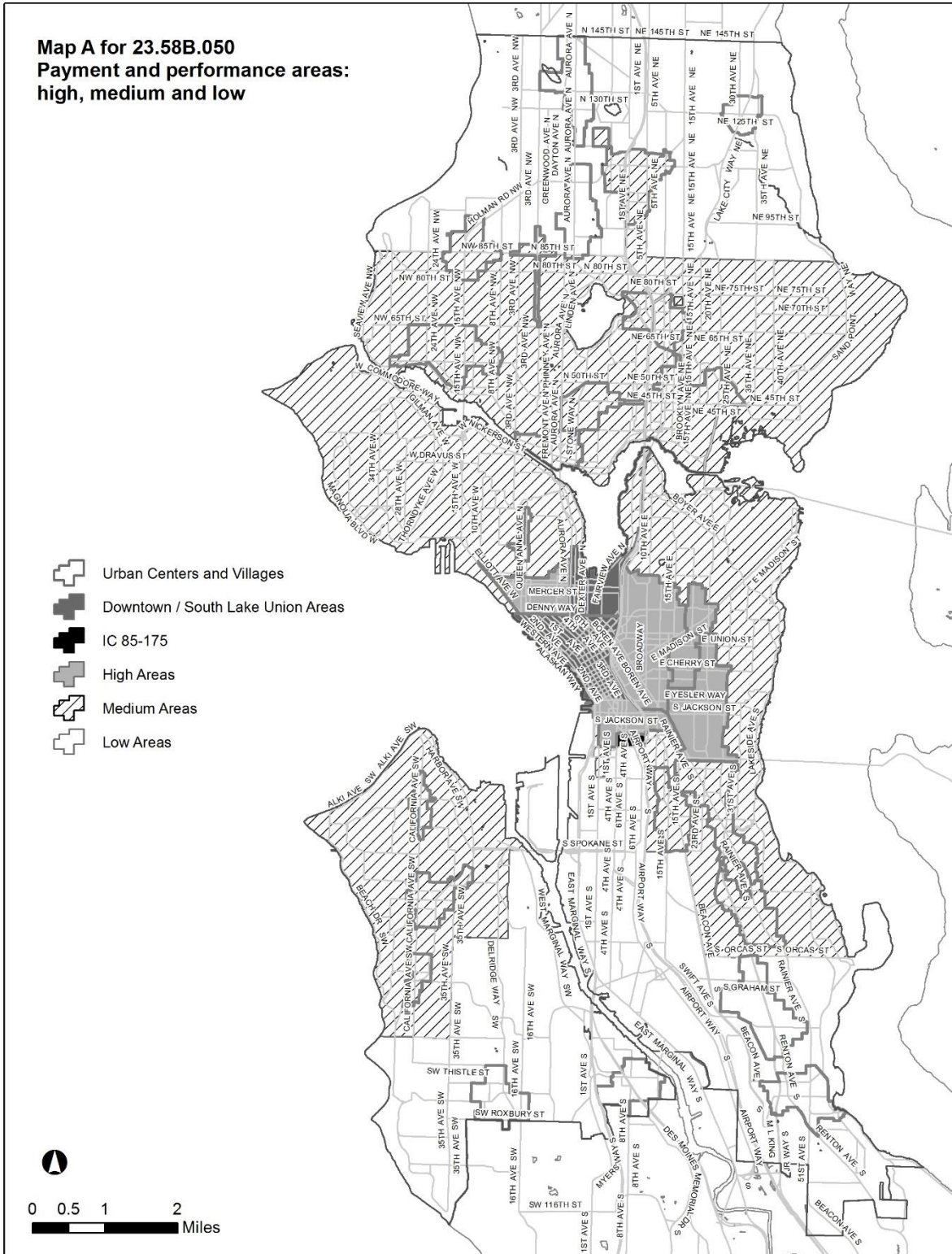
Section 1. Section 94 of Ordinance 125791 is amended by striking through its adopted Map A for 23.58B.050 and substituting a new one as follows:

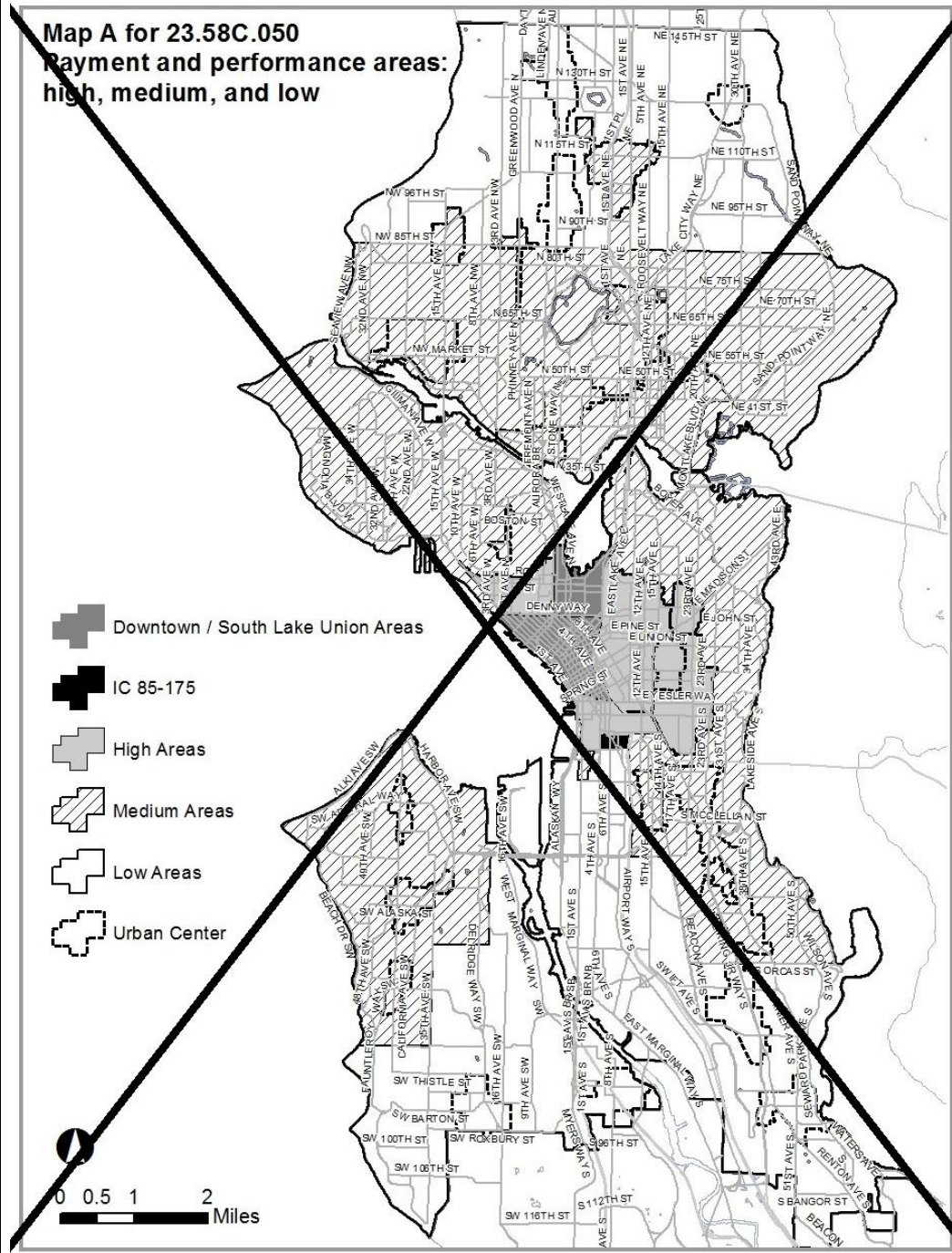

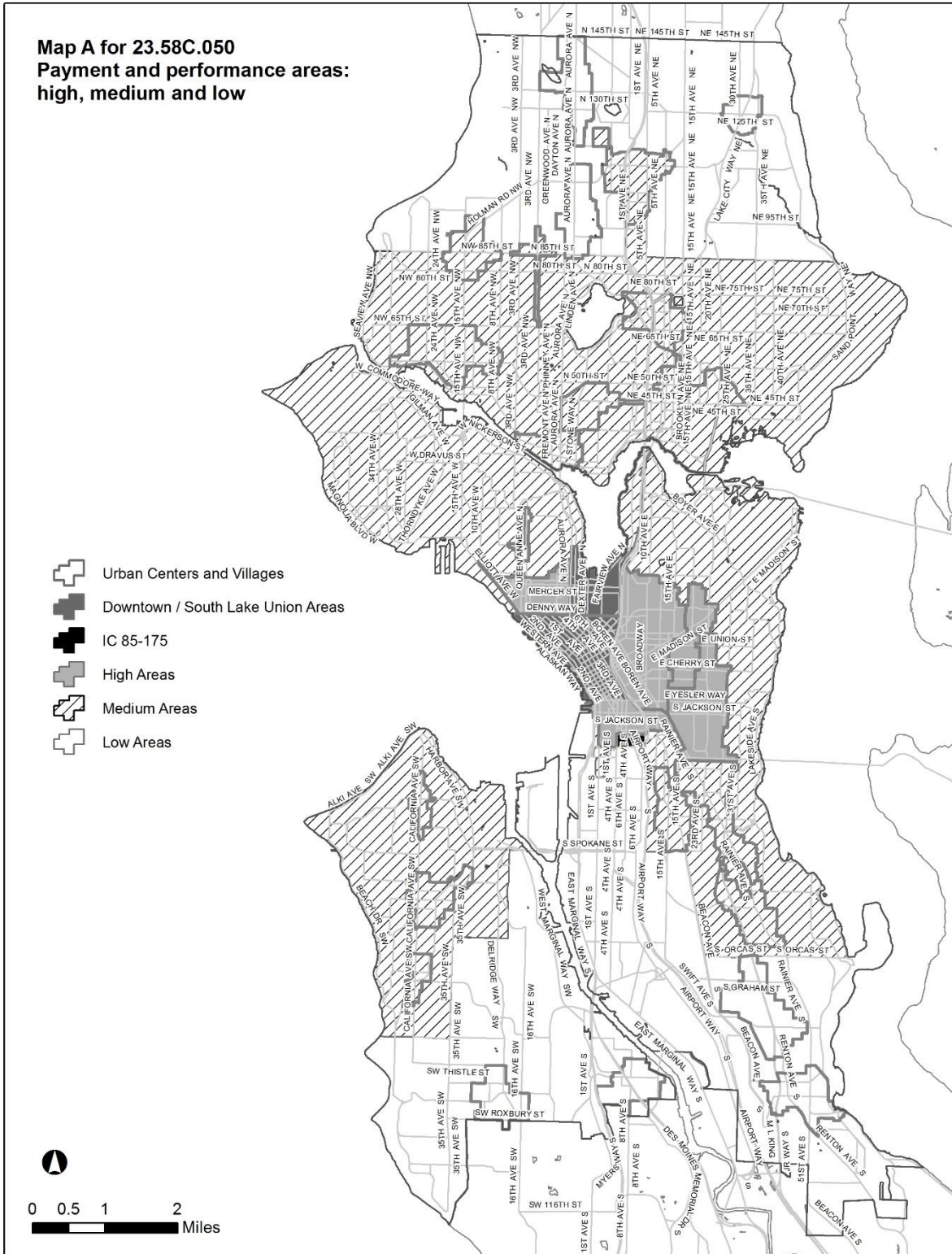
1 Section 2. Section 97 of Ordinance 125791 is amended by striking through its adopted
