Dear Mayor Durkan:

Helping the Seattle Transportation Benefit District (STBD) grow to serve 71% of Seattle households with effective, frequent public transit has been a rewarding part of my last four years, and it is one that I would love to continue even as we look to the renewal or other continuation of this program in 2020. I'm now the only member of the board who has served since the board's founding after passage of the 2014 STBD levy, and I use the knowledge that I've gained over this time to be a more effective co-chair: I am able to provide context to SDOT and my fellow board members that is valuable as we decide on policy positions. This has helped us to foster a collaborative relationship with SDOT and the larger city and county governments. Our reputation as a good faith partner of local institutions has allowed our feedback to be taken seriously and affect programs such as One Center City, Sound Transit System Expansion, and equitable regional Fare Enforcement Policy.

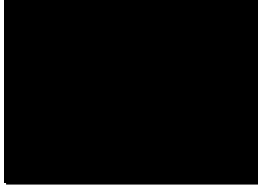
In my life outside of the board, I've continued to be involved in my local neighborhood transportation advocacy. As someone who doesn't own a car, and who travels almost exclusively by transit and walking, I'm personally invested in creating an equitable built environment. Though members of the TAB do not directly represent populations, my deep involvement in transit and transportation issues in my community has given me insight into the North Downtown Mobility Action Plan, the Mercer Adaptive signals, and Key Arena transportation demand management has informed the stances I've taken on the board.

Over the four years I have served on the board, we have suggested that STBD invest in connecting Seattle residents to trails with Trailhead Direct; encouraged SDOT to prioritize transit riders' time and convenience with the expansion of transit priority on 3rd, 5th, and 6th Ave; and challenged the City to perform Race and Social Justice Initiative analyses on all capital and service investments we request. The Transportation Benefit District is entering an exciting time as we look towards its continuation in 2020, and what improvements that may bring. I hope for your support in continuing my work on the board.
