Equitable Development

City has set a high bar – an equitable city for all

- From the Race and Social Justice Initiative to the current Equitable Development work
- Most recently, Comprehensive Plan and Equity Analysis
 - Increasingly diverse region
 - Growing equity gap
 - Areas of high displacement and low access to opportunity

Equitable Development Implementation Plan

May presentation to PLUZ Committee

- City's EDI Framework
- Systemic Changes needed within City's structure, to eliminate racial inequities
- Discussed Citywide targeted strategies, e.g.
 - Minimum wage
 - HALA
 - Equity and the Environment

Implementation and Investment Strategies

- Equity Drivers:
 - ✓ Improve mobility & opportunity;
 - ✓ Prevent displacement;
 - ✓ Build on cultural assets; and
 - ✓ Develop healthy and safe neighborhoods.
- Community-initiated projects
- OPCD building internal/external EDI capacity
- Public and private partnerships

Rainier Beach Innovation District

Current Status:

- Strong community organizational support
- Communities of Opportunity (COO) help build community capacity
- \$75,000 Kresge grant for community asset study and concept level business feasibility study
- \$100,000 Wells Fargo Planning Grant, contingent on neighborhood plan approval

Rainier Beach Innovation District

Next Steps

- Adopt updated Rainier Beach Neighborhood Plan, by resolution
- Share *ACT's Case Study for Food Innovation District* to City decision-makers and community partners
- Further develop project concept and feasibility
- Continue to explore community partnerships
- Continue work with community to identify potential sites
- Rezone to support jobs, education/training, entrepreneurship

Rainier Beach/Othello Multicultural Community Center (MCC)

Current Status

- Southeast Economic Opportunity Center's (SEEOC) "front door" to bridge community and services
- \$300,000 HUD Sustainable Communities Initiative
- \$50,000, City, shared capital campaign with SEEOC
- COO support community capacity building and consultant support to develop project

Rainier Beach/Othello Multicultural Community Center (MCC)

Next Steps

- Work with SEEOC to incorporate MCC within campus
- Work with SEEOC to gain site control of identified site
- Establish owner structure

Southeast Economic Opportunity Center (SEEOC)

Current Status

- Community effort with Homesight as developer
- Confirm core program elements and preliminary program partners
- \$1.89M, City, for feasibility study (underway) and site acquisition

Southeast Economic Opportunity Center (SEEOC)

Next Steps

- \$1.5M State Capital Funds for site acquisition
- Currently negotiating with SHA for site
- State approval of site and release of funds
- Acquire site

William Grose Center for Cultural Innovation

Current Status

- Africatown and Black Community Alliance lead and coordinate with community; align with 23rd Avenue Action Plan
- \$50,000, City, feasibility study underway

William Grose Center for Cultural Innovation

Next Steps

- Complete business feasibility study
- Continue to explore possible use of Fire Station 6
- Create partnerships with business, philanthropy, investors, operator, developer
- Rezone consistent with community's 23rd Avenue Action Plan (Union-Cherry-Jackson)

Little Saigon Landmark Project

Current Status

- Friends of Little Saigon, with Seattle Chinatown International District Public Development Authority (SCIDpda) support, continue to drive the project to fulfill community objectives
- Working to gain site control
- \$40,000, City, and \$100,000, SHA, preliminary feasibility study completed

Little Saigon Landmark Project

Next Steps

- Gain site control before land values escalate even more
- Establish owner/operator partnership

City Capacity Building

OPCD, CBO and City departments are expanding their capacity to implement the City's equity agenda

Continue working with decision-makers and community leaders

Expand our work in the community, working closely with Dept. of Neighborhoods, to build community capacity
