1. BILL SUMMARY

Legislation Title: A RESOLUTION amending Resolution 31645; updating Seattle City Councilmember participation, for 2016 and 2017, on King County Committees, Regional Committees, State Committees, and City of Seattle Committees.

This resolution assigns City Councilmembers to “external” committees for 2016 and 2017.

Every two years, the City Council revises the assignment of Councilmembers to “external” committees for the next biennium. This resolution amends Resolution 31645 to make corrections and additions to Seattle City Councilmember participation, for 2016 and 2017, on King County Committees, Regional Committees, State Committees, and City of Seattle Committees.
