1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to taxation; stating an intent to adopt legislation imposing a local sales and use tax at the maximum rate authorized to fund investments in affordable and supportive housing.

Summary and background of the Legislation: The legislation states the City’s intent to authorize the imposition of a .0146 percent sales and use tax to fund affordable and supportive housing. The State Legislature authorized this tax through passage of Substitute House Bill (SHB) 1406 during the 2019 session. The tax will be credited against the state sales and use tax collected in the City so that the total tax paid by the consumer will not increase. The amount the City can collect annually will be limited to the amount of taxable retail sales in the City in state fiscal year 2019. It is estimated this tax will generate approximately \$4 million a year. The tax expires twenty years from the date it is authorized by the City.

SHB 1406 goes into effect July 29, 2019. It requires the City to first adopt a resolution stating its intent to impose the new sales tax and then an ordinance authorizing the new sales tax.

The revenue generated from the tax can be used for acquiring, rehabilitating, or constructing affordable housing. It can also be used to fund the operations and maintenance costs of new units of affordable or supportive housing. The housing or services funded must serve persons at or below 60% of median income. The City may bond against the revenue generated from the tax to fund eligible costs.
