1. BILL SUMMARY

1. **Legislation Title:** AN ORDINANCE granting Swedish Health Services permission to continue operating and maintaining a pedestrian tunnel under and across Minor Avenue, between Columbia Street and Marion Street, for a ten-year term, renewable for two successive ten-year terms; specifying the conditions under which this permit is granted; providing for the acceptance of the permit and conditions; and ratifying and confirming certain prior acts.

2. **Summary and background of the Legislation:**
 This legislation will allow the Swedish Health Services to continue maintaining and operating the existing pedestrian tunnel under and across Minor Avenue, between Columbia Street and Marion Street. The tunnel permit is for a period of ten years, commencing on the expiration of the last term on January 14, 2017. The permit may be extended for two successive 10-year terms. The legislation specifies the conditions under which permission is granted.

The City originally granted permission for the tunnel by Ordinance 113238 in December 15, 1986. The ratify and confirm clause is required in order to grant permission for the existing skybridge retroactively to January 14, 2017.
