2012	Resolution 31399	<ul style="list-style-type: none"><li>• Acknowledged role of non-profit conservancies in other cities, recommends City pursue similar arrangement for Waterfront Program</li></ul>
2014	Letter	<ul style="list-style-type: none"><li>• Letter from Central Waterfront Committee to City recommending Friends for operations and management</li></ul>
2015-2017	Agreements	<ul style="list-style-type: none"><li>• Successful operating agreements between City and Friends to program and activate waterfront spaces</li></ul>
2016	Ordinance 125248	<ul style="list-style-type: none"><li>• Authorized joint funding agreement with non-profit partner Friends of Waterfront Seattle to finance Pier 62/63 Phase 1 Rebuild</li></ul>

2019	Ordinance 125760	<ul style="list-style-type: none"> <li>• Established the Waterfront Local Improvement District (LID)</li> </ul>
	Ordinance 125761	<ul style="list-style-type: none"> <li>• Reconfirmed Friends of Waterfront Seattle philanthropic commitment</li> <li>• Authorized OWCP and SPR to enter into a two-year pilot O&amp;M agreement on Piers 58 and 62 with Friends</li> <li>• Created the Central Waterfront Oversight Committee</li> </ul>
	Ordinance 125762	<ul style="list-style-type: none"> <li>• Approved the Protest Waiver Agreement with property owners located within the LID.</li> </ul>

# OVERSIGHT COMMITTEE



- Mayor/Council appointed. 19 members, including:
  - At-Large (6)
  - LID Tenant/Owner (8)
  - Non-Profit (5)
- Advises on central waterfront operations, maintenance, safety, cultural and recreational programming
- Identifies “Performance Standard” in coordination with Friends and City
  - Based on 2018 O&M analysis and national best practices
- Provides annual report to Mayor and Council
