1. BILL SUMMARY

a. Legislation Title:

AN ORDINANCE related to public defense legal services; and authorizing an interlocal agreement with King County for public defense legal services.

b. Summary and background of the Legislation: This legislation authorizes the Director of the City Budget Office to enter into an Interlocal Agreement (ILA) with the King County Department of Public Defense (KC DPD) to provide indigent defense legal services in Seattle Municipal Court.

The current ILA was negotiated and legislated with KC DPD effective September 2014. After being extended, the current ILA expires on December 31, 2017. The term of the new proposed ILA is January 1, 2018 through December 31, 2022 with an option of extending by mutual agreement for up to a total of ten additional years (through December 2032).

This legislation is necessary since public defense services are a constitutional requirement and a requirement of Chapter 10.101 RCW. The current and the proposed ILA follow the standards for the delivery of public defense services pursuant to RCW 10.101.030 and Washington State Supreme Court Rules related to Standards for Indigent Defense (i.e., caseload limits, administrative costs, attorney-supervision-paraprofessional staffing, limitations on private practice, and attorney qualifications).
