Enclosed please find my qualifications and application as I wish to be considered as a candidate for a vacant position on Seattle's Design Review Board. It is my belief that my experience in architecture, planning, and urban design would allow me to serve as a valuable contributor and member of the board. As a resident of Downtown Seattle I have a strong vested interest in ensuring a high quality built environment that satisfies the needs of all while creating an aesthetically memorable place.

Through my professional experience I have assembled a diverse and well-rounded background shaping the built environment and urban form. In my work with the City of Bellevue my focus has been on facilitating the creation of quality urban spaces and design excellence. In my original position with the City of Bellevue I utilized my architecture and design experience as a Land Use Planner on the Urban Design team. This work primarily consisted of executing administrative design reviews for urbanizing neighborhoods in Bellevue such as Downtown and BelRed. These reviews considered excellence in site planning, building form and massing, articulation, streetscapes, and materiality. Following, I moved to a role with the Planning and Community Development Departments as the Community Development Program Manager. My primary projects currently include the development of Height and Form standards for high-rise development and the development of design guidelines as they relate to Downtown Bellevue and the Downtown Livability Initiative. This includes massing, tower separation, building/sidewalk relationships, and open space. Additionally I serve as the Project Manager for a recently launched study that will examine land use and urban design for a downtown adjacent neighborhood and a potential pedestrian connection that will serve as a landmark for downtown and its adjacent neighborhoods.

Prior to my positions with the City of Bellevue my professional background has included design related positions in transit and urban development. While working with the Metropolitan Atlanta Rapid Transit Authority I worked on several projects to improve the aesthetic quality of rail stations as well as the surrounding public spaces. This work included a rebranding and design of the wayfinding system. Additionally, I worked on defining and conceptualizing transit oriented development opportunities. In more traditional architectural roles, my work has included urban multi-family housing, office, transit-oriented developments, and master development plans. The sum of my experience has provided me with a well-rounded knowledge of the full life span of a project as well as the array of consequences within the urban environment.

As a Downtown Seattle resident and parent I possess a keen interest in how we shape and mold our urban environment for residents of all ages. This applies to the manner in which we experience the urban form, and creating environments that encourage livability and interaction of residents of all ages. Creating generations of residents with a vested interest in the livability and walkability of our urban environments is essential for long-term sustainability and community building.

Following your review of my qualifications, I would welcome the opportunity to speak with you at greater length at your earliest convenience. It is my belief that my comprehensive background and long-term vested interest in creating urban environments beneficial to residents of all ages would allow me to be a valuable member of the City of Seattle's Design Review Board.
