

MASTER SERVICE AGREEMENT BETWEEN THE DEPARTMENT OF PARKS AND RECREATION (PARKS) AND THE ASSOCIATION OF RECREATION COUNCIL (ARC)

ARTS

1% FOR ART PROGRAM

Monitor anticipated collections, expenditures, and project management of the 1% for Art program, and consider potential amendments to program provisions.

ARTS CULTURAL DISTRICTS AND CULTURAL SPACE

Monitor implementation of Cultural Districts, including the Arts & Cultural District for the Central Area; consider proposals for the creation of new art districts; consider affordability for cultural commercial spaces; and review potentially forthcoming legislation.

CREATION, ACTIVATION AND PRESERVATION (CAP) OF CULTURAL SPACE

Monitor implementation of "The CAP Report: 30 Ideas for the Creation, Activation, and Preservation of Cultural Space;" particularly review of the budget proviso in Green Sheet 70-1-A-1-2018 incentivizing cultural uses in older buildings and subsidizing permit fees for arts organizations and review of the response to Statement of Legislative Intent (SLI) 71-1-A-1-2018 regarding creation of a cultural space management public development authority.

Monitor the Office of Arts and Culture's budget and review arts-related legislation as necessary.

BAIL REFORM

Monitor and participate in a Seattle Office for Civil Rights (SOCR)-led work group preparing responses to SLI 303-1-A-2-2018, exploring reform of bail practices and pre-trial release strategies with a racial equity lens.

BIAS CRIME AUDIT

Review Phase 2 of the City Auditor's "Review of Hate Crime Prevention, Response and Reporting in Seattle"; and co-convene a public meeting with the Department of Justice Community Relations Services (CRS) regarding a regional approach to responding to hate crimes.

CIVIL LEGAL AID

Monitor implementation of the pilot program and explore the inclusion of direct representation of King County Department of Public Defense's criminal defense clients in civil proceedings, with a primary focus on eviction. Support data collection regarding the impacts of indigent individuals having representation in eviction proceedings with the goal of creating a right to counsel in eviction proceedings, if supported by the data.

EMPLOYMENT BIAS

Monitor employment bias testing results, community education, and outreach.

EXISTING PROTECTIONS

Monitor the implementation of the all-gender restroom, conversion therapy, first-in-time, and alternative source of income ordinances, including the review of forthcoming reports and assessments.

FAIR HOUSING

Participate in the Fair Housing Working Group and review Fair Chance Housing rulemaking and implementation. Monitor fair housing testing results and community outreach.

PRISONER REENTRY

Monitor and participate in the taskforce preparing recommendations on prisoner reentry and staff SLI 402-2-A-1-2018, exploring preliminary reentry recommendation.

RACE AND SOCIAL JUSTICE INITIATIVE (RSJI)

Develop training for the legislative department with the RSJI change team. Apply the racial equity toolkit to legislative department policies, specifically to the public comment rules and procedures.

SEXUAL HARASSMENT

Work with SOCR to examine how current sexual harassment policies and practices impact people experiencing sexual harassment. Items to address include, but are not limited to, the statute of limitations on sexual harassment complaints, an Employee Climate Survey, a Human Resource Division Director Survey, and exploring innovations in sexual harassment trainings.

STAFFING AND WORKLOAD

Analyze current staffing levels in relation to workload for SOCR to assess potential resource and staffing additions for the 2019 budget process.

STRUCTURE AND FUNCTION

Monitor the Racial Equity Toolkit (RET) process and the consultant assisting with it regarding the structure and function of SOCR within the Executive branch, and draft potential legislation to implement recommendations from the RET.

ZERO DETENTION

Monitor Zero Detention projects.

ECONOMIC DEVELOPMENT

BUSINESS IMPROVEMENT AREA (BIA) FORMATION AND MODIFICATION

Review and consider proposed legislation for new or revised BIAs.

CITY CONTRACTING POLICIES AND PRACTICES

Review City contracting policies and practices, including requirements and technical assistance for women and minority owned enterprises, priority hiring, etc.

COMMERCIAL AFFORDABILITY

Monitor implementation of the Mayor's Commercial Affordability recommendations, including the Office of Economic Development's (OED) plans to improve King Street Station, and the efforts of the Mayor's Small Business Advisory Council.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FLOAT LOANS AND SECTION 108 LOANS

Review and consider approval of proposed Section 108 loans and possible CDBG float loans. Monitor the Section 108 loan pool via quarterly and annual reports; and review recommendations, if any, to strengthen Section 108 policies.

EFFORTS TO CORRECT ECONOMIC DISPARITIES

Monitor City efforts to identify effective approaches to asset building; job training in key sectors such as technology, restaurants, biotech, and life sciences; access to banking and other financial services; educational attainment; family support; access to health care, healthy foods, and other ways to address historic trends in disparities.

LEGACY BUSINESSES

Monitor the design and implementation of a Legacy Business Designation Program and distribution of resources to support legacy businesses. Review the response to SLI 170-2-A-1-2018, providing a report on financial tools that can be used to provide assistance for Legacy Businesses.

MAJOR EVENTS

Review implementation of Resolution 30340 for major events in Seattle.

NEIGHBORHOOD BUSINESS DISTRICT SUPPORT

Monitor and examine implementation of the Only in Seattle program and consider expanding neighborhood business district priorities and programs in 13 neighborhoods.

NEW MARKETS TAX CREDIT (NMTTC) PROGRAM AND OTHER LENDING PROGRAMS

Participate in the committee that makes decisions regarding allocation of NMTTCs. Review annual report on the NMTTC program.

OFFICE OF FILM AND MUSIC

Review and monitor economic development-related legislation including but not limited to City nightlife ordinances, talent and job development initiatives, and business capacity in neighborhood districts.

SMALL BUSINESS SUPPORT

Monitor the progress of the (1) organization(s) receiving funding to provide technical assistance to the small business community; and (2) organization(s) receiving funding to provide community based economic development programs that are focused on businesses in the Central Area, the Chinatown-International District, and other areas identified as being at high risk of displacement. This includes monitoring the work of the Ethnic Business Coalition to support minority businesses and communities with technical assistance, marketing programs, micro-financial assistance, and advocacy. Monitor impacts on small businesses affected by City construction projects.

SPECIAL EVENTS AUDIT

Respond to the December 2017 special events audit recommendations pertaining to OED to examine whether cost recovery is aligned with the City's intentions in Ordinance 124860 and related code provisions, and consider opportunities for improvement.

WORKFORCE DEVELOPMENT AND HIGHER EDUCATION POLICIES AND INVESTMENTS

Review OED's ongoing policy and programmatic work in workforce development, including recommendations made by the Workforce Development Council of Seattle and King County. Advocate for provision of financial empowerment services for those accessing training/educational services. Continue to explore development of a higher education/skill/entrepreneurial training center in Southeast Seattle. Monitor the Youth Employment Initiative and Employee Pathways/Green Jobs and consider implementation of recommendations.

EXTERNAL COMMITTEES AND BOARDS AND COMMISSIONS OVERSIGHT ASSIGNMENTS

BOARDS AND COMMISSIONS - OVERSIGHT AND/OR APPOINTMENT AUTHORITY

Monitor and consider commission recommendations and make recommendations on appointments as needed for the Economic Development Commission; Seattle Arts Commission; Seattle Commission for People with Disabilities; Seattle Human Rights Commission; Seattle Investment Fund LLC-Advisory Board; Seattle Lesbian, Gay, Bisexual, Transgender, Queer (LBGTQ) Commission; Seattle Women's Commission; Special Events Committee; and Museum Development Authority.

EXTERNAL COMMITTEES - COUNCIL PARTICIPATION

Participate as a member of the following external committees: King County Regional Transit Committee, King County Regional Water Quality Committee, King County Flood Control District Advisory Committee, Economic Development District (EDD), Economic Development Council, Water Resource Inventory Area (WRIA) 9: Green Duwamish, Investment Committee for the New Market Tax Credits Program, Labor-Management Leadership Committee.

GENERAL SUPPORT AND OTHER ISSUES

COMMITTEE COORDINATOR

Coordination of committee's work program.

DEPARTMENT HEAD APPOINTMENTS OR REAPPOINTMENTS

Review qualifications of the individual(s) nominated by the Mayor. Confirm the appointment, if appropriate.

UTILITIES - SPU DRAINAGE AND WASTEWATER

DRAINAGE AND WASTEWATER FUND ISSUES

Address Seattle Public Utilities (SPU) Drainage and Wastewater Fund issues including rates, combined sewer overflow program, stormwater code update, green stormwater infrastructure, utility purchase of service related to transportation and other City functions, capital program implementation, grant acceptance, land transactions, and state and federal stormwater requirements.

PRIVATE PROPERTY IMPACTS

Monitor and address impacts to private property related to aging drainage infrastructure.

SUPERFUND

Continue to monitor efforts to assess and manage potential liabilities and clean-up activities at several sites in the city, including the Duwamish River. Monitor City negotiations with Puget Sound Energy and other potentially liable parties relating to responsibility for clean-up of Gas Work Parks including methods to be used for compliance with the state Model Toxics Control Act.

UTILITIES - SPU SOLID WASTE

CLEAN CITY PILOT PROGRAMS

Review and monitor the implementation of the three pilot programs added to the Clean City Program: Encampment Trash Collection Pilot, Litter Abatement Pilot, and Sharps Collection Pilot.

COLLECTION OBLIGATIONS

Monitor garbage, recycling, and compost collection, including obligations to Business Improvement Areas.

ELECTRIC FLEET

Per the Committee's September 12, 2017 letter regarding the collections contract, the Committee will monitor and review progress on the development of an electric fleet pilot program.

SOLID WASTE FUND ISSUES

Address Solid Waste Fund issues including contract renewals, capital improvement implementation, rates and rate design proposals, and bond sales.

UTILITIES - SPU WATER

WATER FUND ISSUES

Address Water Fund issues including regional water management relations, rates and rate design proposals, easements, grant agreements, revenue stabilization subfund report review, water system plan updates, Cedar River Habitat Conservation Plan implementation, bond sales, and sale of surplus property, such as unneeded reservoir sites.

UTILITIES - SPU-WIDE, REGIONAL AND OTHER ISSUES

CALL CENTER

Review and monitor the performance of the SPU call center, including customer wait times. The Committee will investigate and identify potential problem areas such as staffing availability and training, and coordinate with Council and SPU on possible ways to resolve the issue.

EMPLOYEE TO MANAGER RATIO

Review reporting in response to SLI 13-1-A-1-2018 relating to recommendations from the 2009 State Auditor's report analyzing SPU's managerial practices.

GREEN STORMWATER INFRASTRUCTURE

Monitor expansion of green stormwater infrastructure.

RATE AFFORDABILITY STUDY

Monitor and review progress on the Affordability, Risk and Resiliency Work Plan as outlined in the final Strategic Business Plan. The Council requested SPU review utility-wide policies affecting affordability of utility services and accountability to customers, and assess the resiliency of SPU's systems due to internal and external factors. For each effort, SPU shall provide a status report and written final plan to Council prior to the start of the 2021- 2023 business planning process.

SHIP CANAL WATER QUALITY PROJECT

Review and monitor the development and construction of the Ship Canal Water Quality Project; a joint Seattle / King County underground storage tunnel, which will hold polluted water from Ballard, Fremont, Wallingford, and north Queen Anne, helping to prevent it from overflowing into the Lake Washington Ship Canal.

SPU-WIDE ISSUES

Address SPU-wide issues including utility low-income assistance, audits, Strategic Plan implementation, SPU impacts of updated essential public facilities requirements, public opinion survey proposals, SPU implementation of race and social justice programs, grants/loans, efficiency of SPU customer service, and practices for customers who get behind in their bills.

SYSTEM DEVELOPMENT CHARGES

Monitor the implementation of system development charges as outlined in the final Strategic Business Plan. This includes the adjustment for water tap fees and water connection charges to reflect current costs and the development of a formal policy proposal to update water connection charge calculations to include incurred interest on existing assets and establish new sewer and drainage connection charges.

Ongoing oversight of the City Auditor function.

SURPLUS PROPERTY

Review all parcels proposed for sale or transfer, except those covered in other Council committees.

BOARDS AND COMMISSIONS

BOARDS AND COMMISSIONS OVERSIGHT AND APPOINTMENT AUTHORITY

Monitor the work of and make recommendations on appointments or confirmations, as needed, for the Community Involvement Commission, the Seattle Renters Commission, and the Seattle Youth Commission. Review annual work plans as appropriate.

BUDGETARY AND FINANCIAL REPORTING AND OVERSIGHT

BUDGET REVIEW AND ADOPTION

See Budget Committee.

CITY DEBT AND INVESTMENT REPORTING

Review quarterly reports by the Director of Finance, required under Seattle Municipal Code (SMC) Section 3.39.035, on revenues, the City's cash pool, investments, interfund loans, debt, debt service, and debt guarantees. Review reports on socially responsible banking.

BEACON HILL TOWN CENTER SAFETY PLANNING

Monitor and review the Seattle Department of Transportation's (SDOT) multi-modal transportation study for North Beacon Hill, including a comprehensive traffic analysis and street-level design concepts for Beacon Avenue.

DISTRICT 2 LAND USE AND ZONING

Review potential proposed changes to the urban village boundaries around the light rail stations in Southeast Seattle that would expand the area where development could occur. Changes are being considered for all of the villages (North Beacon Hill, North Rainier, Columbia City, Othello and Rainier Beach). Review the rezone contemplated for the Rainier Beach urban village, centered on the light rail station. Legislative review and action would occur in the Select Committee on Mandatory Housing Affordability.

GEORGETOWN TO SOUTH PARK TRAIL PROJECT

Monitor and review project. The project would create a walkable, bikeable path uniting the Georgetown and South Park neighborhoods. The path would enhance walkability between Georgetown and South Park's historic "Main Streets" and connect the heart of the Duwamish Valley.

MOUNT BAKER TOWN CENTER

Monitor and review project. This project will implement pedestrian and bicycle safety improvements identified in the Accessible Mt. Baker plan and also concerns the town center near the Mount Baker light rail station in the North Rainier Valley.

RAINIER AVENUE ROAD SAFETY CORRIDOR PROJECT

Monitor and review SDOT's multimodal study of the Rainier Avenue South corridor and the associated Road Safety Corridor project. Continue working with the community and SDOT on improving the safety of Rainier Avenue South.

REDEVELOPMENT PLAN FOR GOODWILL INDUSTRIES SITE

Monitor and review the redevelopment plan for the Goodwill Industries site. Goodwill Industries, the Seattle Chinatown International District Preservation and Development Authority, Capitol Hill Housing, and Lake Union Partners are collaborating on a feasibility study and set of master development scenarios for the redevelopment of the Goodwill property located at 1400 South Lane Street. The Goodwill site, encompasses almost eight acres and is located at the southeast corner of Little Saigon. Goodwill's vision for the redevelopment includes the addition of both market rate and affordable housing and other uses consistent with Goodwill's mission, community priorities, and a requirement to generate funds to support the redevelopment.

SODO AND CHINATOWN BUSINESS IMPROVEMENT AREA (BIA)

Review and consider BIA legislation.

SOUTHEAST SEATTLE ECONOMIC OPPORTUNITY CENTER

Monitor development of the Southeast Seattle Economic Opportunity Center. The Southeast Economic Opportunity Center (SEOC) is a community-led project that will increase access to economic opportunity for multicultural communities in southeast Seattle. The SEOC will be a culturally relevant and welcoming place where people in southeast Seattle and beyond can access opportunities for higher education, good paying jobs, and support to start and keep a business. Integrating shared space for cultural organizations and workforce housing will help stabilize communities at risk of displacement and engage diverse residents.

EQUITY

BANNING SALARY HISTORY QUESTIONS DURING INITIAL INTERVIEW

Review and consider new legislation barring employers from asking job candidates about their salary history or benefits during the initial interview.

EQUITABLE DEVELOPMENT IMPLEMENTATION PROJECTS

Monitor the development of capital projects in the Equitable Development Implementation Plan, including the following community-sponsored projects: 1) Rainier Beach Food Innovation District; 2) Multicultural Community Center; 3) South East Economic Opportunity Center; 4) William Grose Center for Cultural Innovation; and 5) Little Saigon Landmark Project. Legislative review and action would occur in the Human Services, Equitable Development, and Renters' Rights Committee.

EQUITABLE POLICIES IN EDUCATION AND ACHIEVEMENT

Monitor the implementation and expansion of the Seattle Promise College Tuition Program which will provide a second year of college for current 13th Year Promise Scholarship students enrolled at South Seattle College. Review the equity of the program citywide to ensure underrepresented students are provided the opportunity to attend college.

EQUITY CONTRACTING

Work with Women and Minority Owned Business (WMBE) organizations to develop models and processes that assist them explore opportunities with the City of Seattle, State of Washington, University of Washington and other jurisdictions, and allow the City of Seattle to leverage its expertise with other jurisdictions to assist local WMBE organizations.

GOVERNMENT-PROVIDED ENVIRONMENTAL AND HAZARD SIGNS

Examine issues related to government-provided environmental and hazard signs along the Duwamish river, where information is not often presented in languages spoken by refugee and immigrant communities.

NON-TRADITIONAL APPROACHES ACROSS THE CRIMINAL JUSTICE SYSTEM FOR YOUTH

Explore community alternatives to the criminal justice system and incarceration for youth and adults, including improving strategies for youth rehabilitation, alternatives to youth detention, and alternative housing options to youth incarceration.

Consider the findings and recommendations of the Prisoner and Community Corrections Re-entry Work Group.

Monitor implementation of the Democracy Vouchers program (I-122), review the experience of the 2017 election. Consider legislative changes recommended by the Seattle Ethics and Elections Commission.

Review and consider new training and policy in the Legislative Department related to appropriate & ethical communication.

REVIEW OF CITY CHARTER AND COUNCIL RULES

Review and consider amendments to Council Rules and City Charter.

INTERGOVERNMENTAL - REGIONAL ISSUES

OFFICE OF INTERGOVERNMENTAL RELATIONS

Participate in the development of City priorities for local, regional, tribal, state, and federal governments to develop the partnerships needed to successfully advance common interests.

POTENTIAL ANNEXATIONS

Staff discussions and legislation related to the Duwamish Annexation Area and the North Highline Annexation Area proposals. This includes negotiations with King County and special districts related to service transition.

SISTER CITIES PROGRAM

Review legislation that modifies the status of existing sister city affiliations and the current moratorium on sister cities. Consider the annual review of existing sister cities relationships.

STATE AND FEDERAL LEGISLATIVE AGENDA

Participate in the development of the City's State and Federal legislative agendas.

TECHNOLOGY

BROADBAND AND WI-FI INTERNET ACCESS

Oversee City efforts to promote competition among broadband providers, including options to make greater use of City-owned fiber, and monitor City efforts to provide public Wi-Fi access to disadvantaged and underserved communities. Review quarterly cable provider build out reports (SMC 21.60/DoIT Directors Rule 2015-01). Review and take action on proposed legislation as needed.

CABLE FRANCHISES

Monitor Wave, CenturyLink, and Comcast cable franchises. Review and consider potential actions in preparation for anticipated renewal of the Wave franchise.

CITYWIDE IT PORTFOLIO REVIEW

As part of Seattle IT's consolidation in 2016, Seattle IT is now responsible for managing all IT projects for the City. All projects that are in the Project Management Lifecycle (PMLC) execution and closeout stages are required to submit monthly status reports. Monitor and review Citywide IT Portfolio reports.

COMMUNITY TECHNOLOGY ADVISORY BOARD (CTAB)

Make Council appointments to CTAB, and consider confirmation of Mayoral appointees to CTAB; review reports and presentations.

DATA MANAGEMENT, SHARING, AND PROTECTION

Monitor and review recommendations and reports related to Executive Order 2017-05: Examining and Managing Risks Related to Data Controlled by the Seattle Information Technology Department.

DIGITAL EQUITY INITIATIVE

Review policy and measurements for City efforts to provide all residents improved access to technology, and examine where technology access may be disproportionately denied. Monitor implementation of Digital Equity Initiative Action Plan strategies.

POTENTIAL LEGISLATION

Review and consider miscellaneous legislation from the Seattle Information Technology Department. Potential legislation for 2017 includes items related to wireless mesh and the Puget Sound Emergency Radio Network.

PRIVACY INITIATIVE

Monitor the Privacy Initiative and the implementation of its policies and principles throughout the City organization. Review and take action on proposed budget or other legislation as needed.

SMART CITIES METROLAB NETWORK ARRAY OF THINGS PROJECT

Monitor the deployment of Array of Things (AoT) nodes, which are urban sensing boxes that will collect real-time data on the City's environment and infrastructure for research and public use. The project is part of the White House's MetroLab Network program to support more inclusive, innovative, data-driven solutions to urban challenges.

SURVEILLANCE ORDINANCE

Review and consider legislation related to the Surveillance Ordinance, Ord. 125376. The Surveillance Ordinance, which took effect on September 1, 2017, outlines requirements that include: surveillance impact reports, surveillance technology review and approval by City Council before acquisition, Council review and approval via ordinance for existing technologies, and reporting about surveillance technology use and community impact.

TECHNOLOGY GRANTS

Review proposed legislation for Technology Matching Fund grant awards.

TECHNOLOGY & EQUITY

TAXI, FOR-HIRE, AND TRANSPORTATION NETWORK COMPANIES (TNC)

Examine issues and regulatory policies related to rights of drivers, fair compensation, data collection and analysis, and equity in the taxicab, for-hire, and transportation network companies industry.

HOUSING, HEALTH, ENERGY AND WORKERS' RIGHTS COMMITTEE

AMI IMPLEMENTATION

Monitor City Light's capital program implementation, including the Denny Substation and the new underground network in South Lake Union. Explore opportunities to promote electric vehicle charging stations.

Monitor the City's progress on enrolling eligible customers in the Low Income Assistance program and recommend changes to the approach taken by City Light and the Human Services Department (HSD) as appropriate.

Monitor Board of Health meetings and provide research and analyses for items under the Board's consideration.

COMMUNITY HEALTH ENGAGEMENT LOCATION SITE

Review feasibility study for SLI 261-1-A-1-2018 in establishing a safe consumption site, and monitor planning and execution of establishing a safe consumption site in the City, pursuant to GS 259-10-A-1-2018.

FIRST RESPONDER CALLS

In conjunction with the Gender Equity, Safe Communities, New Americans, and Education Committee, review the response to SLI 196-1-A-2-2018, monitor and implement city-wide recommended approaches by the Seattle Fire Department (SFD) and the Seattle Police Department (SPD) to build a first responder partnership by fire and police departments to enable individuals experiencing mental and behavioral health issues or domestic violence to receive appropriate assistance from dispatch. Review recommendations from SFD regarding the establishment of a nurse triage line for lower acuity calls and to provide the caller with more appropriate care.

HEALTHY FOODS AND FOOD DESERTS

Explore policies to identify food deserts and improve local healthy food options in food deserts throughout Seattle as recommended in "Healthy Foods Here: Recommendations for Future Programming," pursuant to the response to SLI 30-1-A-2-2018. Monitor State action regarding the provision of funding for mental health services in Seattle and the region and develop efforts to increase and leverage City funding for mental health services.

PUBLIC HEALTH EDUCATION AND PREVENTION

In conjunction with the Gender Equity, Safe Communities, New Americans, and Education Committee, assess Seattle-King County Public Health education and prevention efforts and explore creation of original City programming in partnership with City entities and schools to promote public health awareness, expand availability of hygiene stations, including services for women, and financial literacy programming.

In collaboration with the King County Council and Seattle-King County Public Health, develop amendments to the Regional Health Improvement Plan to improve provision of health care to all residents, with particular attention to women, communities of color, immigrants, the LGBTQIA community, and other populations whose access to comprehensive health care may be at risk due to federal policy.

REGIONAL POLICY COMMITTEE (RPC)

Monitor and provide analysis for RPC agenda items that impact Seattle-King County Public Health programming, such as the Mental Illness and Drug Dependency II tax.

HOUSING

ADDITIONAL FUNDING FOR AFFORDABLE HOUSING

Review the response to SLI 230-1-A-1-2018 regarding unmet requests for funding of affordable housing projects and recommendations for funding such projects. Examine potential strategies for funding additional affordable housing, including workforce and multi-use housing.

AFFORDABLE HOUSING IN NORTHGATE AREA

Review the Affordable Housing Strategic Plan for the Northgate Area. This plan will include: an inventory of possible sites for development of 1200 - 1400 additional affordable units in projects that include other community desired services (health care, early learning centers, open space, etc.) in the Northgate neighborhood; findings and recommendations from the housing charrette convened in early January; and an implementation plan including a timeline with major milestones for development of affordable units and options for expediting the development of such units.

Consider legislation to protect workers from wage theft, exploitation and retaliation. Consider ways to provide and strengthen worker protections and benefits.

CHILD EDUCATION ACTIVITIES LEAVE

Review City policies for unpaid leave to attend a child's educational activities at a day care facility or school.

DOMESTIC WORKERS

Review proposals and legislation to create a Domestic Worker's Bill of Rights and a City commission to facilitate labor protections and benefits for domestic workers.

Manage the development of legislation to facilitate the construction of accessory dwelling units and backyard cottages.

FORT LAWTON ZONING CHANGES

Review zoning legislation to facilitate the development of affordable housing at Fort Lawton.

INCENTIVE ZONING

Review legislation to update the City's incentive zoning regulations.

PLANNING AND LAND USE - OTHER LAND USE AND ENVIRONMENTAL REGULATIONS

GREEN BUILDING

Pursuant to SLI 61-1-A-1-2018, Council requests that the Executive report on options to improve transparency into SDOT spending through the budget structure. Pursuant to SLI 62-1-A-1-2018, Council requests that SDOT provide a report on federal funding opportunities and options for delivering the seven Bus Rapid Transit Corridor projects identified in the Move Seattle Levy.

ONE CENTER CITY

Monitor SDOT efforts to re-evaluate Downtown transportation systems including managing near-term construction impacts (Viaduct Removal, Transit Tunnel Closure) and long-term transportation system functions. Pursuant to SLI 56-1-A-1-2018, Council requests that the Executive identify and report on tools to reduce alley congestion in the Downtown core. Pursuant to SLI 58-1-A-1-2018, Council requests that the Executive report on the potential for using automated enforcement to reduce "block-the-box" incidents and transit lane violations.

STREETCAR OVERSIGHT

Monitor construction of the Center City streetcar line and operations of the First Hill and South Lake Union streetcar lines. Pursuant to SLI 55-1-A-2-2018, Council requests that SDOT provide a report on recommendations to improve speed and reliability on the existing South Lake Union and First Hill streetcar lines.

TRANSPORTATION - POLICIES AND PROGRAMS

BICYCLE THEFT

Promote education and coordination of efforts to address bicycle theft in Seattle (see also Gender Equity, Safe Communities, New Americans and Education Committee).

COMMUTE TRIP REDUCTION AND TRANSPORTATION DEMAND MANAGEMENT

Explore options for increasing participation in Commute Trip Reduction (CTR) programs, including potential requirements for mandatory pre-tax CTR deductions. Pursuant to SLI 57-1-A-1-2018, Council requests that the Executive develop a proposal to implement a new fee to support monitoring and compliance of required Transportation Management Plans.

EMERGING TRANSPORTATION ISSUES

Monitor emerging technological changes and cultural shifts with implications for the City's transportation network. Monitor SDOT management of Seattle Transportation Benefit District Proposition 1 funding for increased transit service.

STREET VACATION PETITIONS AND POLICY

Review street vacation petitions for the Washington Convention Center, Broad Street/Mercer Teardrop (Mercer West), and other emergent project proposals. Review and propose amendments to the street vacation policies.

TRANSPORTATION IMPACT FEES

Explore the feasibility of impact fees to address the transportation impacts of growth in Seattle.

VISION ZERO IMPLEMENTATION

Review SDOT proposals for implementing the Vision Zero safety program. Review safety data collection procedures and after-action follow-up. Improve pedestrian and bicycle safety.

TRANSPORTATION - REGIONAL PROJECTS

ALASKAN WAY TUNNEL/SR-99 OVERSIGHT

Monitor progress on the Washington State Department of Transportation's project to replace the viaduct with a tunnel and new surface street. Monitor tolling-related issues and agreements with the State of Washington regarding responsibilities and funding for this project.

SOUND TRANSIT LIGHT RAIL

Monitor and engage in Sound Transit activities to implement ST2 and ST3 projects in Seattle. Co-host the Sound Transit Elected Leadership Stakeholder Group to make recommendations on the preferred alignment for the West Seattle and Ballard light rail projects.

SR-520 OVERSIGHT

Review legislation and agreements related to the Washington State Department of Transportation's SR-520 project. Monitor final design and construction activities related to the Montlake Lid, Portage Bay Bridge, Delmar Lid, and Montlake Cut crossing.
