1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to committee structure, membership, meeting times, and duties of the standing committees of the Seattle City Council for 2016 and 2017, and superseding Resolution 31499.

Summary and background of the Legislation:

This resolution establishes the committee structure, membership, meeting times, and duties of the standing committees of the Seattle City Council for 2016 and 2017, including assignment of public development authorities to standing committees for general oversight and review.

Every two years, the City Council reorganizes itself, and establishes standing committees for the next biennium. This resolution supersedes Resolution 31499 which set the committee structure for 2014 and 2015.
