

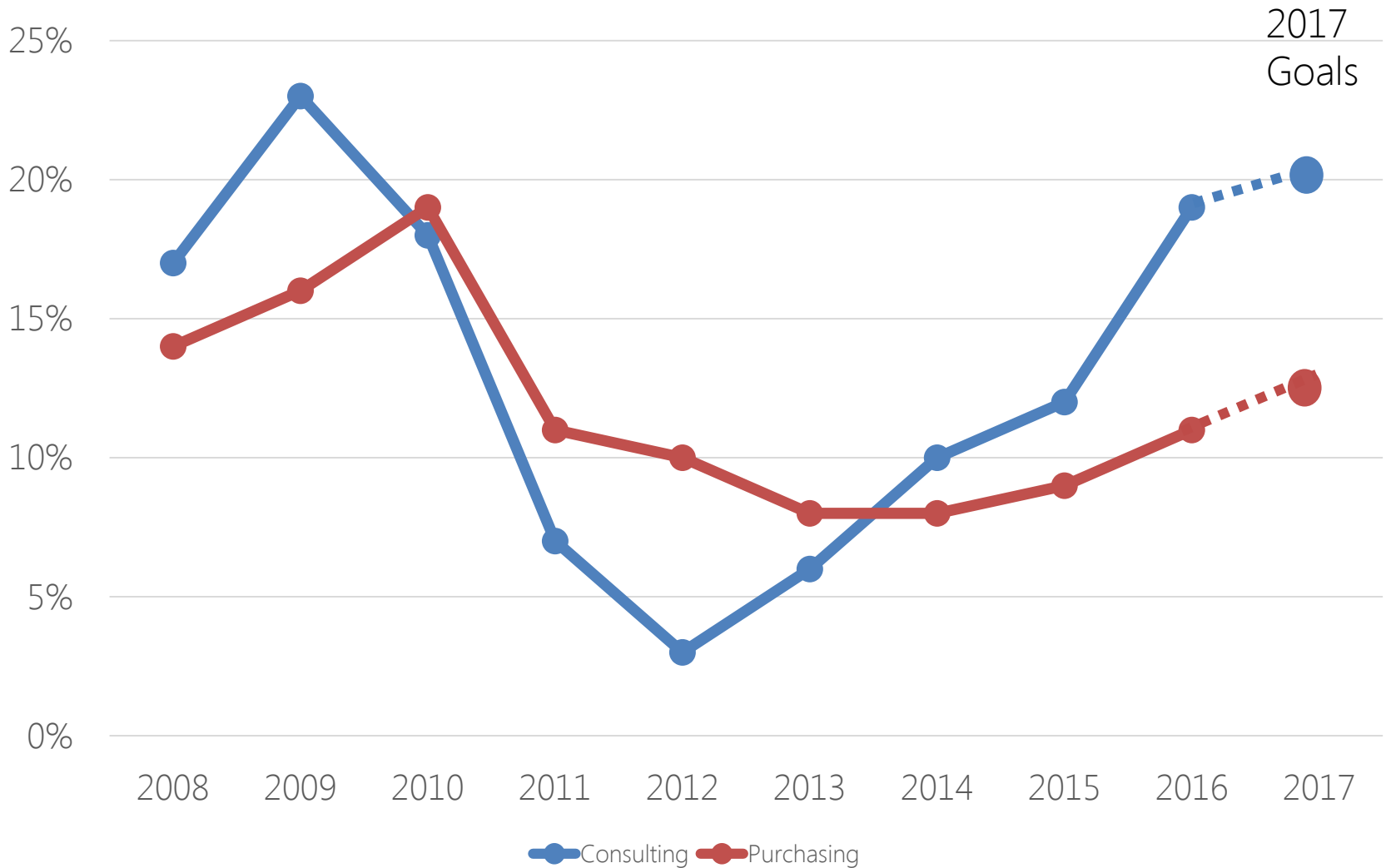

# SDOT WMBE Inclusion Performance Consultant & Purchasing

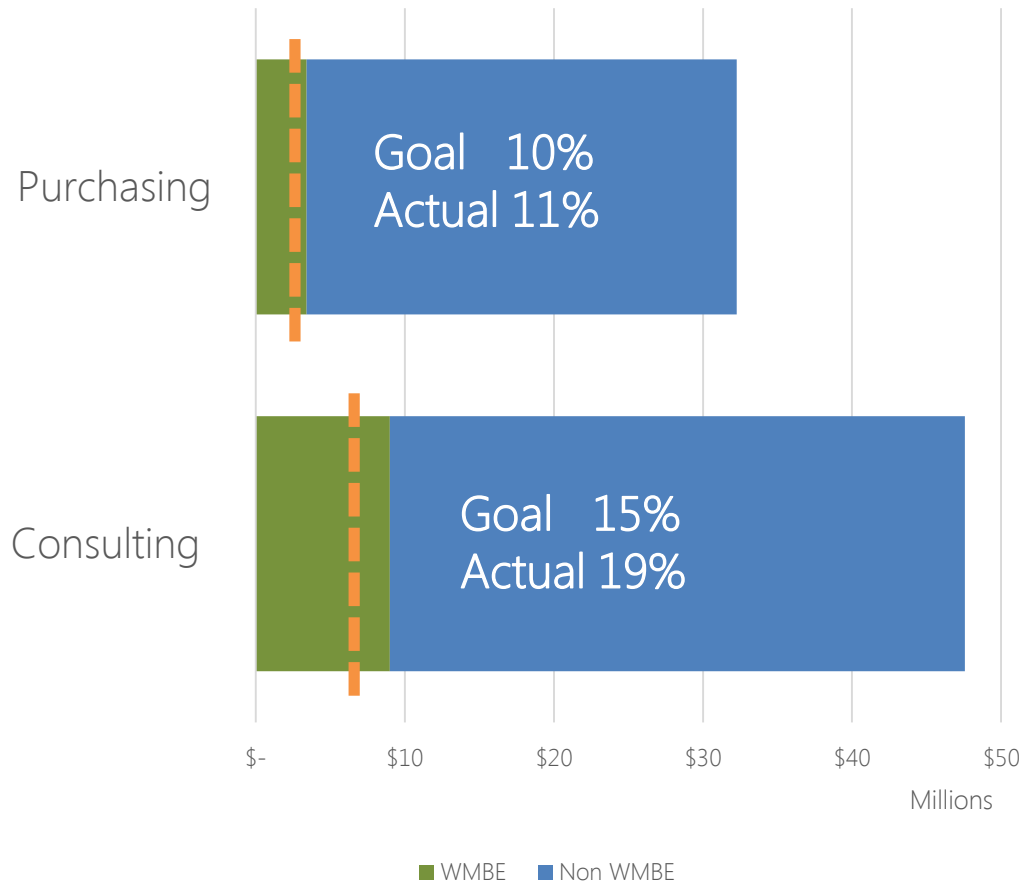

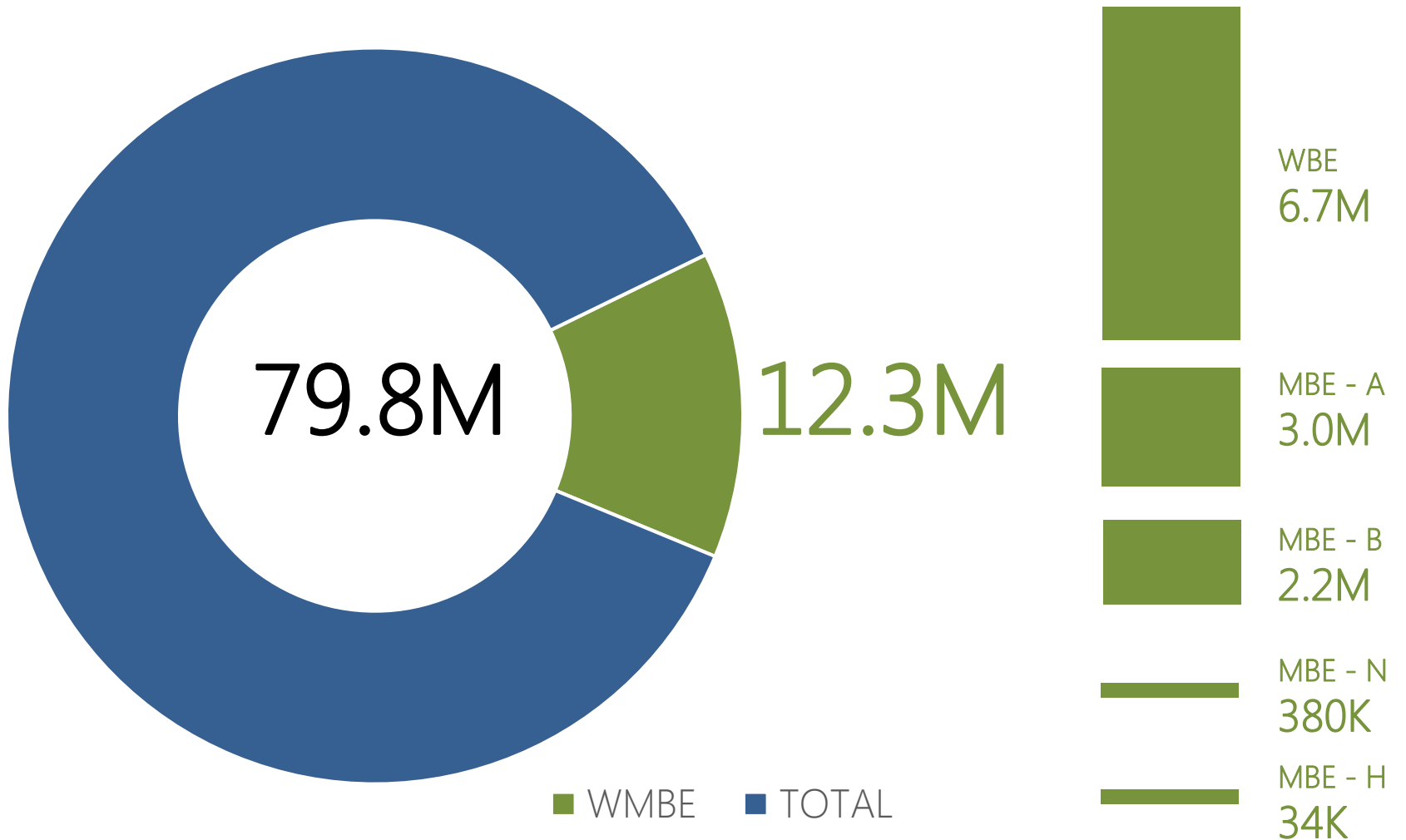

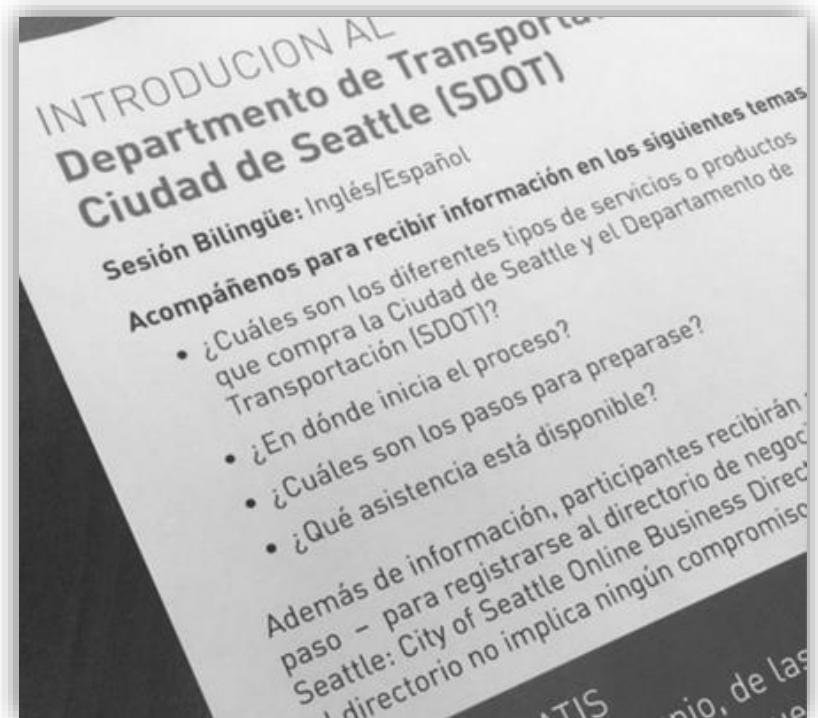
