**1. BILL SUMMARY**

**Legislation Title:** A RESOLUTION relating to the Seattle Department of Parks and Recreation; authorizing the Superintendent of Parks and Recreation to submit application(s) for grant funding assistance for Washington Wildlife and Recreation Program (WWRP) project(s) to the Recreation and Conservation Funding Board as provided in chapter 79A.25 RCW, Title 286 WAC, and other applicable authorities.

**Summary and background of the Legislation:** This proposed legislation authorizes the Department of Parks and Recreation (DPR) to submit grant applications to the State of Washington Recreation and Conservation Office (RCO) for state funding assistance in the amount of \$500,000 to support renovation of the Brighton Playfield; \$500,000 to support the renovation of the Smith Cove Playfield; and \$475,000 to support improvements to the Arboretum Waterfront Trail. This resolution is required as part of the formal RCO grant application process. Improvements funded by the RCO grant and City match are:

Brighton Playfield Renovation and Turf Conversion: Renovate/replace an existing 200,000 SF lighted multi-sport natural turf playfield with a new 200,000 SF synthetic all-season multi-sport playfield (supporting: baseball, softball, soccer, lacrosse and other field sports or leisure play). In addition, new LED lights will replace existing lighting, new accessible pathways, and spectator seating will be added.

Smith Cove Playfield Renovation: Renovate an existing 5.6 acre natural turf multi-sport playfield with drainage, irrigation and an updated natural grass system. Additional amenities will include accessible pathways and spectator seating.

Arboretum Waterfront Trail Renovation: The Arboretum Waterfront Trail is located on the north side of State Route 520 (SR 520) on the south side of Union Bay on Lake Washington. The Union Bay shoreline supports the largest existing wetland in Seattle. The Trail is approximately 0.5 mile long and runs through wetlands and some stretches of open water, linking Foster Island on the east to the former Museum of History and Industry on the west. The types of trail construction in the project area include sawdust/wood chip surfacing, new boardwalk trails and fixed and floating concrete and steel grating trails with ADA access. DPR's required matching funds for the Arboretum Waterfront Trail are appropriated in the Seattle Parks and Recreation's 2016-2021 Capital Improvement Program.

DPR applies for RCO grants each year and has garnered a strong success rate in securing additional funding for planned capital projects. In 2016, DPR will complete three RCO applications in the Washington Wildlife and Recreation Program (WWRP). The total funding request will be \$500,000 each for two projects and \$475,000 for one project, totaling a \$1,475,000 funding request in the WWRP category.

The RCO grants require a local match, and will fund only projects that are included in DPR’s comprehensive plan (Seattle Parks and Recreation Plan 2000). The recommended projects meet both criteria. DPR’s required matching funds for the Brighton Playfield and Smith Cove Playfield Renovations, and the Arboretum Waterfront Trail Improvements are appropriated in the Seattle Parks and Recreation’s 2016-2021 Capital Improvement Program.

RCO will announce the grant award recommendations in November 2016, but the actual grant awards will not be allocated until 2017. Project planning and design for Brighton Playfield and Smith Cove Playfield projects is anticipated to begin in 2016 with construction planned to start in 2017 after a contract for the grant funding has been fully executed. RCO funding will support currently unfunded project elements.

The RCO WWRP is reimbursement grant funding and requires a 1:1 match. \$1,475,000 in funds from the Seattle Parks and Recreation’s 2016-2021 Capital Improvement Program will be used to match the \$1,475,000 grant request for these projects.
