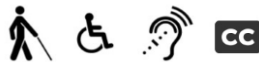

- Support safe access to abortion and other reproductive healthcare services for all.

Amend the language under the heading “Economic Development & Small Business” in Exhibit 1 of RES 32155 as follows:

- ~~Support special events and World Cup activations by allowing flexible movement of food and drink.~~ Support special events and World Cup activations regarding food and drink.

- Secure Capital funding for decarbonization projects, including, but not limited to, creation of the Seattle Center Eco-district.
- Support policies and investments to fight climate change, support climate adaptation, and assist local government removal of fish passage barriers.
