1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to a public safety bill of rights for the Seattle public; renumbering Subchapter VI as Subchapter V and creating a new Subchapter VI in Chapter 3.28 of the Seattle Municipal Code.

Summary and background of the Legislation: If passed, this legislation would codify the Seattle Police Department's policies protecting the rights of public observers of police activity, and would create a cause of action against the City for interference with the observation of or recording of such activity.
