If one nominee receives five or more votes that individual is appointed to fill Position 4, and will assume office immediately after accepting the position and taking the Oath of Office. If the nominee does not receive five votes, the next nominee will be considered. If no nominee receives five votes, the process will repeat until one nominee receives five or more votes.
