



WHEREAS, Ordinance 125291, which took effect May 14, 2017, amended the Official Land
12	Use Map (Chapter 23.32 of the Seattle Municipal Code), to rezone properties identified
13	on pages 99, 100, 101, 102, 108, 109, 110, 115, 116, 117, and 215 of the Official Land
14	Use Map in Downtown, South Lake Union, and adjacent IC zones; and
15	WHEREAS, a typographical error was identified on Exhibit A to Ordinance 125291 that affects
16	pages 100 and 108 of the Official Land Use Map in a Downtown zone; and
17	WHEREAS, a technical error was identified on Map A for Section 23.58B.050; and
18	WHEREAS, The City of Seattle wants to correct these technical errors to ensure amendments to
19	the Seattle Municipal Code and amendments to the Official Land Use Map are labeled
20	and implemented as intended; NOW, THEREFORE,
21	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
22	Section 1. The Official Land Use Map, Chapter 23.32 of the Seattle Municipal Code, is
23	amended to fix typographical errors on pages 100 and 108 of the Official Land Use Map as
24	shown on Exhibit A attached to this ordinance.
25	Section 2. Map A for Section 23.58B.050 of the Seattle Municipal Code, which section
26	was last amended by Ordinance 125291, is amended as follows:
