THIS SECOND AMENDMENT (the "2<sup>nd</sup> Amendment") to the PROPERTY USE AND SEVELOPMENT AGREEMENT recorded under King County Recording Numbers 20030617002439 and 20130618002453 (the "PUDA") is executed this 4<sup>th</sup> day of JUNE 2015, in favor of the CITY OF SEATTLE (the "City"), a Washington municipal corporation, by the HOUSING AUTHORITY OF THE CITY OF SEATTLE, a public body corporate and politic (the "Owners").

All terms not defined herein shall have the same meaning as in the PUDA.


1. A new Section 7 is added to the PUDA to read as follows:

Section 7. Notwithstanding the ten-year expiration provision in Section 2 and the two-year extension provision in Section 6, this Agreement is extended for an additional period of two years from the effective date of the ordinance accepting this 2<sup>nd</sup> Amendment and extending the rezone.

2. No Other Changes. Except as set forth herein, the PUDA shall remain in full force and effect.

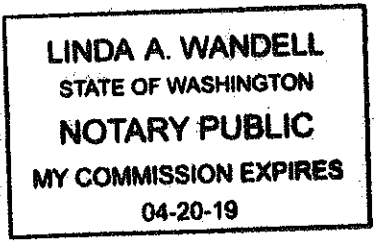
