**1. BILL SUMMARY**

**Legislation Title:** A RESOLUTION relating to the Seattle Park District; establishing the Community Oversight Committee and setting its membership and terms of office; and ratifying and confirming certain prior acts.

**Summary and background of the Legislation:** The Seattle Park District was approved by the voters on August 5, 2014. Ordinance 124468, relating to an interlocal agreement with the Seattle Park District, directed the establishment of a Community Oversight Committee to provide advice to the Mayor, City Council, and Superintendent of Parks and Recreation and provide oversight of projects, programs and services undertaken by the Seattle Parks District. Though appointments of Committee members has taken place since 2015, the formal establishment of this committee via resolution did not happen. This legislation formally authorizes the establishment of this Committee and sets the membership and terms of office of this Committee.
