1. BILL SUMMARY

1. Legislation Title: AN ORDINANCE relating to the electric system of The City of Seattle; adopting a system or plan of additions and betterments to and extensions of the existing municipal light and electric power generation, transmission, and distribution system of the City; authorizing the issuance and sale of municipal light and power revenue bonds for the purposes of providing funds to pay part of the cost of carrying out that system or plan, providing for the reserve fund requirement (if any), and paying the costs of issuance of the bonds; providing parameters for the bond sale terms including conditions, covenants, and other sale terms; describing the lien of the bonds and authorizing their issuance as either senior lien parity bonds or as junior lien bonds; and ratifying and confirming certain prior acts.

2. Summary and background of the Legislation:

This legislation provides the legal authorization to issue up to \$255 million of bonds to fund a portion of capital expenditures for Seattle City Light’s system, as set forth by the 2019-2024 capital plan.

Although the budget, capital plan and rates make specific assumptions about the use of debt financing for a certain share of the capital program, separate authorization for the issuance of bonds is technically required.

A City Light bond sale for \$255 million of fixed rate debt is anticipated to occur in July 2019. The bond proceeds combined with internally generated funds will support City Light’s capital program for about one year. The bond proceeds will also be used to make a deposit to the bond reserve fund and to pay issuance costs.

Bonds would have a maximum maturity of 30 years. In its financial plan, City Light has assumed a 4.5% annual interest rate and annual debt service (principal and interest payments) of about \$15.6 million starting in 2020. No debt service payments are forecast for 2019. All costs resulting from this bond issue were incorporated in the 2019-2024 strategic plan and proposal for 2020 retail rates.

Major projects supported by the bond issue include: Boundary Licensing Mitigation, Alaskan Way Viaduct and Seawall Replacement Utility Relocations, and Boundary Unit 54 Generator Rebuild. For further information about City Light’s capital projects, please see the 2019-2024 capital plan.
