ORDINANCE 126398
COUNCIL BILL 120127

AN ORDINANCE approving and confirming the plat of “The Pines at Northgate” in the portions of Northeast Quarter of Southeast Quarter of Section 29, Township 26 North, Range 4 East, W.M. in King County, Washington.

WHEREAS, a proposed plat of “The Pines at Northgate” has been submitted for approval to the Seattle Department of Construction and Inspections (SDCI) and given the Permit No. 3032523; and

WHEREAS, following review and recommendations by the various City departments that have jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of Seattle on September 2, 2020, the Hearing Examiner approved the preliminary plat of “The Pines at Northgate” subject to certain conditions on September 21, 2020; and

WHEREAS, SDCI has confirmed that the preliminary plat conditions have been satisfied; and

WHEREAS, the Director of Transportation and the Director of SDCI have, subject to Council approval, approved the final plat and have reported that the final plat now meets all of the requirements of the State platting law (chapter 58.17 RCW) and of the Seattle Municipal Code (Chapter 23.22), except for the execution of the required certifications by the King County Assessor and the King County Finance Division; and

WHEREAS, the Director of Transportation and the Director of SDCI report that the plat of “The Pines at Northgate,” a copy of which is in Clerk File 314456, is now complete and ready for City Council approval; NOW, THEREFORE,

1 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

2 Section 1. The plat of “The Pines at Northgate,” in the portions of Northeast Quarter of
3 Southeast Quarter of Section 29, Township 26 North, Range 4 East, W.M. in King County,
4 Washington is legally described as follows:

5 PARENT LOT LEGAL DESCRIPTION

6 Parcel A, B and C of the City of Seattle Lot Boundary Adjustment No. 3022189 under
7 King County recording no. 2016102900005 and amended by recording no.
8 20170816000024

9 Section 2. With respect to the plat of “The Pines at Northgate,” together with any interest
10 in abutting streets, as executed by Harinder Nayyar as Managing Member and approved by the
11 Director of Transportation and the Director of the Seattle Department of Construction and
12 Inspections, the following findings are hereby made:

13 (a) The final plat is in substantial conformance with the approved preliminary plat;
14 and

15 (b) When both the King County Assessor and King County Finance Division have
16 affixed their certifications as required by RCW 58.17.160(4), the requirements of State law and
17 City ordinances that were in effect at the time of preliminary plat approval will also have been
18 satisfied by the subdivider; and


19 (c) The public use and interest will be served by the establishment of the plat, and the
20 plat makes appropriate provision for the public health, safety, and general welfare.

21 Section 3. The plat of “The Pines at Northgate,” in the portions of Northeast Quarter of
22 Southeast Quarter of Section 29, Township 26 North, Range 4 East, W.M. in King County,
23 Washington, is in all respects approved and the plat confirmed and accepted, subject to
24 certification by the King County Assessor and King County Finance Division, and the City Clerk

1 is hereby authorized and directed to execute a certificate upon the face of such plat attesting to
2 the approval thereof as evidenced by enactment of this ordinance.


3 Section 4. This ordinance shall take effect and be in force 30 days after its approval by
4 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
5 shall take effect as provided by Seattle Municipal Code Section 1.04.020.
