**COUNCIL BILL** 118737

AN ORDINANCE relating to the Seattle City Employees' Retirement System; creating a separate retirement plan for City employees whose membership in the Retirement System begins on or after January 1, 2017; clarifying certain provisions and making technical corrections; and adding new Sections 4.36.005, 4.36.607, and 4.36.608 to, and amending Sections 4.36.010, 4.36.020, 4.36.030, 4.36.040, 4.36.050, 4.36.060, 4.36.070, 4.36.080, 4.36.090, 4.36.500, 4.36.505, 4.36.510, 4.36.515, 4.36.520, 4.36.525, 4.36.530, 4.36.540, 4.36.545, 4.36.550, 4.36.555, 4.36.560, 4.36.565, 4.36.567, 4.36.570, 4.36.575, 4.36.580, 4.36.585, 4.36.590, 4.36.595, 4.36.600, 4.36.605, 4.36.610, 4.36.615, 4.36.620, 4.36.625, 4.36.630, 4.36.635, 4.36.640, 4.36.645, 4.36.650, 4.36.655, 4.36.660, 4.36.665, 4.36.670, 4.36.675, 4.36.680, 4.36.690, 4.36.695, 4.36.705, 4.36.710, 4.36.715, 4.36.720, and 4.36.900 of, the Seattle Municipal Code.

WHEREAS, the City of Seattle through its organized labor agreements has provided for a new retirement system (Plan 2) for civilian employees hired on or after January 1, 2017; and

WHEREAS, Plan 2 must be defined and incorporated into Seattle Municipal Code Chapter 4.36 – City Employees' Retirement System; and

WHEREAS, doing so presents the opportunity to clarify and make technical corrections to certain provisions in SMC 4.36 that are applicable to both Plan 1 and Plan 2. It is the intent of the City Council that such clarifications and technical corrections will not make substantive legal changes to member rights and benefits existing at the time this ordinance is passed; NOW, THEREFORE,

**BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

Section 1. A new Section 4.36.005 is added to the Seattle Municipal Code as follows:

**4.36.005 Provisions Applicable to Plan 1 and Plan 2**

Except where otherwise specified therein, Sections 4.36.010 through 4.36.595 and 4.36.610 through 4.36.900 are applicable to members of both Plan 1 and Plan 2 of the retirement system in

1 this Chapter 4.36. Sections 4.36.600 and 4.36.605 are applicable only to Plan 1 members.  
2 Sections 4.36.607 and 4.36.608 are applicable only to Plan 2 members.

3 Section 2. Section 4.36.010 of the Seattle Municipal Code, enacted by Ordinance 78444,  
4 is amended as follows:

5 **4.36.010 Purpose ((-))**

6 The purpose of this ((chapter)) Chapter 4.36 is to ((continue the)) maintain a retirement and  
7 pension system for ((superannuated)) retired and disabled officers and employees of the City and  
8 of the Seattle Public Library as authorized by Article XXII, Section 13 of the Charter and by  
9 state law and established by Ordinance ((No-)) 57075 (as amended) and to establish a system of  
10 death benefits for such officers and employees.

11 Section 3. Section 4.36.020 of the Seattle Municipal Code, enacted by Ordinance 78444,  
12 is amended as follows:

13 **4.36.020 Employees' Retirement Fund created ((-))**

14 A fund is created and established to be known as the "Employees' Retirement Fund" and shall  
15 consist of all the moneys paid into it in accordance with the provisions of this ((chapter)) Chapter  
16 4.36, whether such moneys shall take the form of cash, securities, or other assets.

17 Section 4. Section 4.36.030 of the Seattle Municipal Code, last amended by Ordinance  
18 124574, is amended as follows:

19 **4.36.030 Definitions – ((Alphabetical)) “A” ((through)) and “B”**

20 Unless a different meaning is plainly required by the context the terms used in this  
21 ((chapter)) Chapter 4.36 shall have the following meanings:



1           (~~"Accumulated additional contributions" means the sum of all additional contributions~~  
2 ~~deducted from the compensation of a member, standing to the credit of his individual account,~~  
3 ~~together with regular interest thereon.))~~

4           "Accumulated contributions" means accumulated normal contributions pursuant to  
5 Section 4.36.540 plus ((accumulated additional)) contributions by the member pursuant to this  
6 Chapter 4.36, together with regular interest thereon, but shall not include death benefit  
7 assessments.

8           "Accumulated normal contributions" means the sum of all normal contributions pursuant  
9 to Section 4.36.540, deducted from the compensation of a member, standing to the credit of  
10 ~~((his))~~ the member's individual account, together with regular interest thereon.

11           "Actuarial equivalent" means a benefit of equal value when computed upon the basis of  
12 such mortality tables and regulations as shall be adopted by the Board.

13           "Actuarial present value" means the value of an amount or series of amounts payable or  
14 receivable at various times, determined as of a given date by the application of a particular set of  
15 actuarial assumptions.

16           "Annuity" means the payments derived from contributions made by a member as  
17 provided in Sections 4.36.605, 4.36.608, and 4.36.650.

18           (~~"Basic pension" means the annuity derived from normal contributions of members and~~  
19 ~~the pension derived from matching contributions of the City.))~~

20           "Beneficiary" means any person ~~((in receipt of)),~~ other than a member, who is entitled to  
21 receive a pension, annuity, retirement ((allowance)) benefit, disability ((allowance)) benefit, or  
22 any other benefit provided in this Chapter 4.36.

23           "Board" means "Board of Administration" as provided in Section 4.36.500.

1 Section 5. Section 4.36.040 of the Seattle Municipal Code, last amended by Ordinance  
2 124575, is amended as follows:

3 **4.36.040 Definitions – ((Alphabetical)) “C” ((through)) and “D”**

4 Unless a different meaning is plainly required by the context the terms used in this  
5 ((chapter)) Chapter 4.36 shall have the following meanings:

6 "City" means The City of Seattle or another employer with employees eligible by law to  
7 be members of the retirement system.

8 "City contractor" means any person or entity performing services for the City pursuant to  
9 any agreement, including but not limited to agreements for public works as defined in RCW  
10 ((39.040.010)) 39.04.010; consultant as defined in Section 20.50.010; supplies, material,  
11 equipment, or services as defined in Chapter 20.60; or legal (including indigent public defense)  
12 and other professional services.

13 "City service" means service rendered to the City for compensation, and for the purpose  
14 of this chapter, a member shall be considered as being in the "City service" only while he or she  
15 is receiving compensation for such service or is on leave of absence on account of sickness or  
16 injury, or on family or medical leave under Chapter 4.26 and makes contributions covering such  
17 period as provided in ((subsection)) Section 4.36.565.

18 "Code" means the Internal Revenue Code of 1986, as amended.

19 "Compensation" means the salary or wage, exclusive of overtime, indicated on payrolls  
20 and/or vouchers. With respect to plan years beginning on and after July 1, 2002, the annual  
21 compensation of a plan member that exceeds \$200,000 (as adjusted for cost-of-living increases  
22 in accordance with Code § 401(a)(17)(B)) may not be included in determining benefits or  
23 contributions for any plan year. Annual compensation means compensation during the plan year

1 or such other consecutive 12-month period over which compensation is otherwise determined  
2 under the plan, referred to as the determination period. The cost-of-living adjustment in effect for  
3 a calendar year applies to annual compensation for the determination period that begins with or  
4 within such calendar year. If the determination period consists of fewer than 12 months, the  
5 annual compensation limit is an amount equal to the otherwise applicable annual compensation  
6 limit multiplied by a fraction, the numerator of which is the number of months in the short  
7 determination period, and the denominator of which is 12. If the compensation for any prior  
8 determination period is taken into account in determining a plan member's contributions or  
9 benefits for the current plan year, the compensation for such prior determination period is subject  
10 to the applicable annual compensation limit in effect for that prior period. This restriction does  
11 not apply to any individual who was a member prior to January 1, 1996.

12 "Continuous service" means ~~((uninterrupted))~~ employment by the City that is not  
13 interrupted by a voluntary or involuntary termination of employment~~((, except that~~  
14 ~~discontinuance))~~ . Discontinuance of City service of a member caused by a leave of absence,  
15 layoff, sick leave under Chapter 4.24, family or medical leave under Chapter 4.26, ((leave of  
16 absence, suspension, or dismissal, followed by reentrance into City service within one year;)) or  
17 other events not constituting a termination of employment shall not count as a break in the  
18 continuity of service~~((; provided, that for the purpose of establishing membership in the~~  
19 ~~retirement system continuous service shall mean six months' service in any one year))~~.

20 "Creditable service" means such City service as is evidenced by the record of normal  
21 contributions received from the employee if credit for same is still intact or not lost through  
22 withdrawal of accumulated normal contributions as provided in Section 4.36.665.

1 "Death benefit" means the payment upon proof of death of a member provided for in  
2 Section 4.36.690.

3 "Death benefit assessment" means the payments required of members of the death benefit  
4 system under Sections 4.36.690 and 4.36.695.

5 "Disability benefit" means a benefit payable pursuant to Section 4.36.645.

6 "Domestic partner" as used in this Chapter 4.36 means an individual designated by an  
7 unmarried City officer or employee in an affidavit filed pursuant to Sections 4.30.020 and  
8 4.36.595 and qualified under Section 4.30.010.

9 Section 6. Section 4.36.050 of the Seattle Municipal Code, last amended by Ordinance  
10 124575, is amended as follows:

11 **4.36.050 Definitions – ((Alphabetical)) "E" through "M"**

12 Unless a different meaning is plainly required by the context, the terms used in this  
13 ((chapter)) Chapter 4.36 shall have the following meanings:

14 "Employee" means all officers and employees of the City and of the Seattle Public  
15 Library eligible to membership in the retirement system pursuant to law. The term "employee"  
16 does not include an officer or employee of a City contractor, whether or not the contractor is  
17 providing mandatory or discretionary governmental services, and whether or not the contractor is  
18 a for-profit or non-profit entity.

19 "Final compensation" for Plan 1 members means the average annual compensation  
20 earned during a member's 52 highest consecutive biweekly pay periods prior to termination of  
21 employment with the City. "Final compensation" for Plan 2 members means the average annual  
22 compensation earned during a member's 130 highest consecutive biweekly pay periods prior to  
23 termination of employment with the City. However, for Plan 2 members only, the member's

1 highest consecutive biweekly pay periods shall include biweekly pay periods in which the  
2 member is on leave from work (so long as such leave does not constitute a break in the member's  
3 continuous service), regardless of whether compensation is earned during such periods.

4 "Fiscal year" means any year commencing with January 1((st)) and ending with  
5 December 31((st)) next following.

6 "Funding Ratio" means the ratio of the actuarial value of assets over the actuarial accrued  
7 liabilities as determined by an actuarial valuation ordered by the Retirement Board.

8 "Indexed benefit" means the initial benefit payable on behalf of a member, adjusted for  
9 inflation in an amount equal to the ratio of the June Seattle-Tacoma-Bremerton ("STB")  
10 Consumer Price Index for Urban Wage Earners and Clerical Workers ("CPI-W") for the current  
11 year over the STB CPI-W for the first half of the calendar year in which a benefit payable on  
12 behalf of a member was first paid. If the benefit was first paid during a year in which this index  
13 did not exist, the Board shall establish a similar index value to represent the June index value  
14 based on published Consumer Price Index information for the Seattle area.

15 "Initial benefit" means the retirement ((allowance)) benefit as calculated to be effective  
16 on the date of the member's retirement. It takes into account any reductions based on options  
17 selected by the member under Section 4.36.610. It shall also mean payments of accumulated  
18 contributions made under subsection 4.36.680.B, and payments received by a beneficiary as a  
19 result of an option selected under Section 4.36.610.

20 "Member" means any person included in the retirement system as provided in Sections  
21 4.36.525 ((and)) through 4.36.535.

1           “Membership date” means the earliest date that an officer or employee became a member  
2 of the retirement system and for which the member has retained creditable service under Sections  
3 4.36.525 through 4.36.535 and Sections 4.36.567 through 4.36.575.

4           Section 7. Section 4.36.060 of the Seattle Municipal Code, last amended by Ordinance  
5 124574, is amended as follows:

6 **4.36.060 Definitions – ((Alphabetical)) “N” through “Q”**

7 Unless a different meaning is plainly required by the context the terms used in this ((chapter))  
8 Chapter 4.36 shall have the following meanings:

9           "Normal contribution" means contribution at the rate provided for in subsection  
10 4.36.540.A or subsection 4.36.540.B.

11           "Pension" means payments derived from any contributions made by the City.

12           “Plan 1” means the Seattle City Employees’ Retirement System, Plan 1, providing  
13 benefits and covering persons whose membership date in the retirement system is prior to  
14 January 1, 2017 or who have retained Plan 1 membership under subsection 4.36.525.K.

15           “Plan 1 member” means a person whose membership date in the retirement system is  
16 prior to January 1, 2017 or who has retained Plan 1 membership under subsection 4.36.525.K.

17           “Plan 2” means the Seattle City Employees’ Retirement System, Plan 2, providing  
18 benefits and covering persons whose membership date in the retirement system is on or after  
19 January 1, 2017.

20           “Plan 2 member” means a person whose membership date in the retirement system is on  
21 or after January 1, 2017.

22           Section 8. Section 4.36.070 of the Seattle Municipal Code, last amended by Ordinance  
23 123871, is amended as follows:

1 **4.36.070 Definitions – ((Alphabetical)) “R” through “Z”**

2 Unless a different meaning is plainly required by the context the terms used in this chapter shall  
3 have the following meanings:

4 "Regular interest" means interest compounded annually at such rate as shall have been  
5 adopted by the Board of Administration in accordance with the provisions of this Chapter 4.36.

6 "Retirement ((allowance)) benefit" means the ((annual)) amount payable to ((the)) a  
7 member pursuant to Section 4.36.605 or Section 4.36.608((, and shall be equal to the sum of the  
8 member's pension plus the annuity)).

9 "Retirement fund" means "Employees' Retirement Fund" created and established in  
10 Section 4.36.020.

11 "Retirement system" means the "City Employees' Retirement System" provided for in  
12 Section 4.36.080 and the system of death benefits established therein.

13 Section 9. Section 4.36.080 of the Seattle Municipal Code, enacted by Ordinance 78444,  
14 is amended as follows:

15 **4.36.080 Continuance of City Employees' Retirement System ((-))**

16 The retirement system created and established effective July 1, 1929 by Ordinance ((No-)) 57075  
17 (as amended) known as the "City Employees' Retirement System" is continued in full force and  
18 effect.

19 Section 10. Section 4.36.090 of the Seattle Municipal Code, enacted by Ordinance  
20 78444, is amended as follows:

21 **4.36.090 Death benefit system created ((-))**

22 There is created and established ((in addition to)) within the retirement system a death benefit  
23 system to become effective January 1, 1950.

1 Section 11. Section 4.36.500 of the Seattle Municipal Code, last amended by Ordinance  
2 124574, is amended as follows:

3 **4.36.500 Retirement System Board of Administration**

4 A. There is created and established a Retirement System Board of Administration  
5 ~~((which)) that shall~~~~((, under the provisions of this chapter and the direction of the City Council,))~~  
6 administer the retirement ~~((and death benefit systems))~~ system and the retirement fund created by  
7 this ~~((chapter))~~ Chapter 4.36 for retirement and death benefits. ~~((Under and pursuant to the~~  
8 ~~direction of the City Council, the))~~ The Board as trustee shall provide for the proper investment  
9 of the moneys in the retirement fund. The Board of Administration shall consist of seven  
10 members as follows:

- 11 1. The Chair of the Finance ~~((and Culture))~~ Committee of the City Council, or  
12 ~~((this committee's))~~ the Committee's successor;
- 13 2. The City Director of Finance;
- 14 3. The Seattle Human Resources Director;
- 15 4. Two persons who are members of the retirement system and one person who is  
16 a retired member, all of whom shall be elected by the members of the retirement system  
17 including retired members; provided, that persons who have elected upon termination of their  
18 employment to leave all their contributions in the retirement fund pursuant to the provisions of  
19 ~~((Section 4.36.655.A))~~ subsection 4.36.665.A shall not be eligible to vote for or be elected to  
20 such positions; and provided, further, that at the time of such member's election to the Board, no  
21 more than one elected member may be employed in any single City department or other  
22 employment unit. In the event that a Board member who was elected as a retirement system



1 member retires during ~~((his or her))~~ the term as a Board member, ~~((he or she))~~ that member shall  
2 remain a Board member until the expiration of ~~((his or her))~~ the term; and

3           5. One member who shall be appointed by the other six members; provided that  
4 such appointed member shall not be a City employee or a retired City employee and shall not  
5 have membership in the retirement system.

6           B. Elected members and the appointed member shall serve for a three year term ending  
7 July 1~~((st))~~ of the third year of such term.

8           C. Elections for the members of the Board who are elected as provided in this ~~((section))~~  
9 Section 4.36.500 shall be administered by the Board. Ballots shall be accepted only if received  
10 by the Board's designated ballot counter on or before its close of business on the first Monday in  
11 June of each calendar year.

12           D. Any vacancy occurring in an elected position shall be filled by the City Council by  
13 appointment to such position of a member eligible to be elected thereto, and provided the  
14 member so appointed shall be retired or shall come from the same employing unit as the vacating  
15 member. The member so appointed shall serve until such vacancy is filled by the election for the  
16 unexpired term of a member eligible to be elected for a full term to such position at the next  
17 succeeding first Monday in June, unless the vacancy occurred less than one year before the  
18 expiration of the term of such elected member, in which case the member so appointed shall  
19 serve for the remainder of the unexpired term. Any vacancy occurring in the appointed member  
20 position~~((s))~~ shall be filled by appointment by the City Council for the unexpired term.

21           E. The Chair of the Finance ~~((and Budget))~~ Committee of the City Council, or the chair  
22 of the Committee's successor, shall be ex officio ~~((chair))~~ Chair, the Seattle Human Resources  
23 Director ex officio Secretary, and the Director of Finance ex officio Treasurer of the Board.

1 F. The investment of all or any part of the retirement fund shall be in accordance with  
2 RCW 35.39.060.

3 G. Subject to such provisions as may be prescribed by law for the deposit of municipal  
4 funds in banks, cash belonging to the retirement fund may be deposited in any licensed national  
5 bank or banks in this state, or in any bank, banks, or corporations authorized or licensed to do a  
6 banking business and organized under the laws of this state, and a clearing account may be  
7 maintained with a depository which holds securities as a nominee for funds received pending  
8 transmission to the retirement system as contemplated by RCW 35.39.070.

9 H. The Director of Finance (~~and Administrative Services~~) shall be the custodian of the  
10 retirement fund. All payments from said fund shall be made upon warrant duly issued by the  
11 Director of Finance (~~and Administrative Services~~) or, if the fund is solvent at the time payment  
12 is ordered, by check. As custodian, the Director of Finance (~~and Administrative Services~~) with  
13 the approval of the Board of Administration, may cause securities of the retirement system to be  
14 registered in the name of a nominee and authorize the safekeeping of retirement system securities  
15 in the physical custody of the Federal Reserve System, a depository trust company, or a bank as  
16 contemplated by RCW 35.39.070.

17 I. Except as herein provided, no member and no employee of the Board shall have any  
18 interest, direct or indirect, in making of any investments from the retirement fund, or in the gains  
19 or profits accruing therefrom. And no member or employee of the Board, directly or indirectly,  
20 (~~for himself~~) on the member's or employee's own behalf or as an agent or partner of others,  
21 shall borrow any of its funds or deposits or in any manner use the same except to make such  
22 current and necessary payments as are authorized by the Board; nor shall any member or

1 employee of the Board become an endorser or surety or become in any manner an obligor for  
2 moneys invested by the Board.

3 J. No City employee who is elected to the Board shall suffer a monetary loss or other  
4 penalty on account of ~~((his/her))~~ absence from ~~((his/her))~~ the employee's regular position during  
5 regular hours while attending meetings of the Board or its sub-committees.

6 Section 12. Section 4.36.505 of the Seattle Municipal Code, last amended by Ordinance  
7 124574, is amended as follows:

8 **4.36.505 Powers and duties of Board**

9 The administration of the ~~((Retirement and Death Benefit System))~~ retirement system and  
10 retirement fund, including all benefits provided by this Chapter 4.36, is vested in the Board of  
11 Administration created in Section 4.36.500~~((, The Board))~~ , which shall exercise the powers and  
12 duties conferred upon it by ~~((said section, and in addition thereto))~~ Section 4.36.500.

13 Additionally:

14 A. The Board shall keep in convenient form such data as shall be necessary for the  
15 actuarial valuation of the retirement fund created by this ~~((chapter))~~ Chapter 4.36. ~~((At the end of~~  
16 ~~the three year period beginning with the year 1974, and at the end of every three year period~~

13           G. The Board may adopt rules deemed appropriate to carry out this chapter, including  
14 delegating any of its powers and duties to a committee consisting of at least three members of the

16 delegate to the Executive Director powers and duties for efficient administration of the

1 H. The Board is authorized to execute any and all contracts and agreements necessary or  
2 convenient for the proper investment of the moneys in the retirement system after receiving  
3 advice of legal counsel. The Board may, by resolution, delegate the authority to sign any such  
4 agreements to any Board member or to the Executive Director.

5 Section 13. Section 4.36.510 of the Seattle Municipal Code, last amended by Ordinance  
6 124574, is amended as follows:

8 A. A decision of the Board of Administration shall be final and conclusive on the  
9 following matters subject only to review by a court of record, and reversal if the decision is

22 B. The Board may delegate the hearing of any of the foregoing to a committee consisting  
23 of at least three members of the Board. A member, the Executive Director, if affected, or a City

1 department aggrieved by a committee decision may appeal the committee's decision to the Board  
2 by submitting a written request to the Executive Director within ten business days after receipt  
3 thereof, and the ((board)) Board shall hear the matter de novo.

4 Section 14. Section 4.36.515 of the Seattle Municipal Code, last amended by Ordinance  
5 124574, is amended as follows:

6 **4.36.515 Borrowing of money**

7 The Board, for and on behalf of the retirement system, is authorized to borrow money from time  
8 to time, in amounts not to exceed \$1,000,000 outstanding at any one time, and at interest rates  
9 not to exceed six percent per year and to execute the necessary notes and pledge as collateral  
10 securities held by the retirement system, all in connection with the investment of moneys in the  
11 retirement fund authorized by Section 4.36.500. Such notes or other evidence of indebtedness

18 A. A member may not withdraw from membership in the system while in City  
19 employment.

20 B. 1986 ~~((Nonmembers))~~ nonmembers. An officer or employee~~((;))~~ who, on June 21,  
21 1986, held an appointive position exempt from the classified civil service with a right to elect to  
22 join or rejoin the retirement system from June 21, 1986 to December 31, 1986 and who is not  
23 currently a member of the retirement system, may join the retirement system while holding a



1 position exempt from civil service as authorized by subsection 4.36.525.E. ~~((of this section and))~~  
2 However, such members may acquire creditable service only for City service performed after the  
3 date of ~~((his or her))~~ the member's membership. This subsection 4.36.525.B does not apply to  
4 officers or employees covered by subsections 4.36.525.C, 4.36.525.D, ~~((and))~~ or 4.36.525.F of  
5 this ~~((section,))~~ 4.36.525 or, subject to RCW 41.04.120, officers or employees re-entering City  
6 service after December 31, 1986.

7 C. Elective ~~((Officials))~~ officials. An elective official may elect to join the retirement  
8 system at any time during ~~((his or her))~~ the official's City service, and may contract for credit for  
9 continuous City service performed prior to the date of the official's election to join in accord with  
10 ~~((Seattle Municipal Code))~~ Section 4.36.567, provided that credit for such prior City service shall  
11 not cover any period during which the City made payments to another retirement system on the  
12 official's behalf; nor, after December 31, 1987, shall a contract authorize more than five years'  
13 service credit for such prior City service. If an elective official makes an election to join the  
14 retirement system on or after January 1, 2017 and is then eligible to contract for credit for City

16 join Plan 2 of this retirement system, and the official's rights to purchase service credit and

21 City Employees' Retirement System, arrange with the Seattle Human Resources Director for a

1 E. Election by ~~((Officers Exempt from Civil Service))~~ officers exempt from civil service.

2 An officer, who holds a position exempt from the civil service system and is not already a  
3 member of the City Employees' Retirement System, may become a member of the system by  
4 filing with the Executive Director of the City Employees' Retirement System ~~((his or her))~~ an  
5 election to participate in the system. Such an officer shall receive "creditable service" for  
6 retirement system purposes only for City service accruing from and after the date of ~~((his or her))~~  
7 the officer's membership. ~~((However, a))~~ If an officer or employee exempt from the civil service  
8 system makes an election to join the retirement system on or after January 1, 2017 and is then  
9 eligible to purchase credit for City service performed prior to January 1, 2017, the officer shall  
10 have a one-time election whether to join Plan 2 of this retirement system, and the officer's rights  
11 to purchase service credit and membership in in Plan 1 or Plan 2 shall be determined under  
12 subsection 4.36.525.K. An eligible member may purchase creditable service for City service

20 employee who is a member of the retirement system at the time of ~~((his or her))~~ appointment or

22 F. Re-Entry. An officer or employee who withdrew ~~((his or her))~~ the officer's or  
23 employee's deposit in the retirement system before or upon ~~((his or her))~~ separation from City

1 service, and later re-enters City service, shall either (a) resume (~~his or her~~) membership by  
2 making a redeposit as contemplated by Section 4.36.567, or (b) rejoin the retirement system with  
3 creditable service accruing thereafter. An officer or employee, who maintains (~~his or her~~) the  
4 officer's or employee's deposit in the retirement system during a separation from City service,  
5 shall continue (~~his or her~~) membership upon re-entry into City service. If a former member  
6 reenters City service on or after January 1, 2017, and (1) as permitted in Section 4.36.665, the  
7 member has previously withdrawn the member's contributions, (2) the member's withdrawn  
8 contributions include contributions made under Plan 1 under subsection 4.36.540.A, and those  
9 contributions have not been redeposited as of the date of the member's reentry, the member shall  
10 have a one-time election whether to join Plan 2 of this retirement system, and rights to purchase

13 G. The following employees shall not become members of the retirement system, except

17 2. Members of the Fire Department entitled to the benefits of the (~~Firemen's~~)  
18 Firefighters' Relief and Pension Fund under State law;

21 4. Employees in positions established primarily (~~to provide~~) for training leading

1 H. The head of each office or department of the City shall give ~~((immediate))~~ notice in  
2 writing to the Board as soon as is practicable of the change in status of any member of ~~((his))~~ the  
3 office or department, resulting from transfer, promotion, leave-of-absence, family and medical  
4 leave, resignation, reinstatement, dismissal, or death. The head of each office or department shall  
5 furnish such other information concerning any member as the Board may require.

6 I. Each member shall be subject to all the provisions of this ~~((chapter))~~ Chapter 4.36 and  
7 the rules and regulations of the Board. Should any member be, in the opinion of the Board,  
8 permanently separated from City service, or should the member die, ~~((he or she))~~ that member

10 J. Maintenance of ~~((Membership))~~ membership. A temporary, interim, intermittent,  
11 provisional worker or ~~((part-time))~~ worker in a part-time position who joins the retirement  
12 system shall maintain ~~((his or her))~~ membership in the retirement system for the duration of his  
13 or her City service until retirement. A member of the retirement system, who has not retired from  
14 the City and who accepts temporary, intermittent, or part-time work, shall continue to make ~~((his~~  
15 ~~or her))~~ contributions to the retirement system.

16 K. Plan 1 membership and one-time option to elect to join Plan 2 for certain members. In  
17 the case of a member entering or reentering City service who has a one-time election to join Plan  
18 2 pursuant to subsections 4.36.525.C, 4.36.525.E, 4.36.525.F, or 4.36.530.B, and who has never  
19 previously had such an election, the member shall be considered a continuing Plan 1 member but  
20 shall be eligible for a one-time option to elect to join Plan 2 and forfeit Plan 1 membership and  
21 all prior rights to redeposit, purchase and/or repurchase contributions, and/or service credit. This  
22 one-time option for members qualifying under this subsection 4.36.525.K to elect to join Plan 2  
23 shall operate as follows: qualifying members will be eligible, solely within the first 60 calendar

1 days after reentering City service or electing to join the retirement system, to elect to join Plan 2  
2 by completing a form provided for this purpose by the retirement system. Such an election to  
3 join Plan 2 shall be irrevocable and shall constitute an election to completely and permanently  
4 forfeit the member's pre-existing rights and status as a Plan 1 member, including but not limited  
5 to forfeiture of the ability to make a redeposit or purchase or repurchase of any of the member's  
6 contributions or service credit earned prior to the election to join Plan 2. A member eligible to

8 allowed time period shall have no further election to join Plan 2, and will irrevocably remain a

11 Section 17, Section 4.36.530 of the Seattle Municipal Code, last amended by Ordinance

15 This ((section)) Section 4.36.530 and Section 4.36.575 provide the exclusive methods for  
16 temporary, interim, intermittent, or provisional workers, ((or)) and workers in part-time positions  
17 ((of less than 20 hours per week over a one year period)) exempt from the Civil Service to  
18 become members of the retirement system.

19 A. Opportunities. A worker in active City service on ((and))or after January 1, 1989, who  
20 has a position that is classified as temporary, interim, ((or)) intermittent, or provisional, or a part-  
21 time position ((of less than 20 hours per week over a one year period)) exempt from the Civil  
22 Service, has the ((three)) following opportunities to join the retirement system:

1                   1. Within six calendar months of completion of 1,044 hours of continuous

6 "straight-time service" means regular hours worked, including premium hours but excluding paid  
7 overtime hours.

8                   In addition to the opportunities described in this subsection 4.36.530.A, an employee is  
9 required to join the system upon appointment to an eligible full-time position or a part-time  
10 position covered by the Civil Service unless the position is elective or exempt under  
11 ~~((Subsection))~~ subsection 4.36.525.C or 4.36.525.E or the worker has an election under a  
12 statutory right under ~~((Section))~~ subsection 4.36.525.D.

13                   B. Buy-in ~~((Option))~~ option. If the worker elects to join the retirement system under  
14 subsection~~((s))~~ 4.36.530.A.1 or 4.36.530.A.2 ~~((of this section))~~ or becomes a member upon  
15 mandatory appointment to an eligible position, the worker may choose whether or not to acquire  
16 ("buy in") service credit for the hours of compensated service earned after first becoming eligible  
17 to join the system. If the worker elects to join the retirement system on or after January 1, 2017  
18 and is then eligible to purchase credit for City service performed prior to January 1, 2017, the  
19 worker shall have a one-time election whether to join Plan 2 of this retirement system, and rights  
20 to purchase service credit and membership in Plan 1 or Plan 2 shall be determined under  
21 subsection 4.36.525.K. The~~((se))~~ options for members eligible to purchase prior service credit  
22 are described in Section 4.36.575.

1 C. Exercise of ~~((Option))~~ option. To exercise an option to join the retirement system, a  
2 worker must file the documents reasonably required by the Board of Administration before the  
3 expiration date.

4 D. Expiration. If a worker covered by subsection 4.36.530.A does not exercise~~((d,))~~ the  
5 opportunity to join the retirement system under subsection 4.36.530.A.1 ~~((of this section expires~~  
6 ~~six calendar months after the worker becomes eligible; if not exercised, the opportunity under~~  
7 ~~subsection A.2 expires six calendar months after the worker becomes eligible and))~~ or  
8 4.36.530.A.2, ((such a)) the worker may only become a member of the retirement system  
9 thereafter by appointment to an eligible full- or part-time position or by serving as an elective  
10 officer. ~~((If the opportunity under subsection A.2 of this section has expired, the worker shall not~~  
11 ~~receive creditable service for his or her City service in a temporary, interim, intermittent position~~  
12 ~~or a part-time position of less than 20 hours per week over a one-year period.))~~

13 Section 18. Section 4.36.540 of the Seattle Municipal Code, last amended by Ordinance  
14 124574, is amended as follows:

15 **4.36.540 Contributions – members**

16 A. Effective January 4, 2012, members of Plan 1 of the retirement system shall make  
17 contributions to the retirement fund at the rate of 10.03 percent of the compensation of each such  
18 member, exclusive of overtime; provided that any member whose rate of contribution prior to  
19 June 23, 1972, was less than 6 percent and whose rate was increased by 2.03 percent pursuant to  
20 Ordinance 111303 shall have such rate further increased by 1 percent, exclusive of overtime,  
21 effective January 5, 2011, and by an additional 1 percent, exclusive of overtime, effective  
22 January 4, 2012; provided, further, that any reinstated member who has redeposited ~~((his/her))~~  
23 withdrawn contributions plus interest as provided in ~~((subsection))~~ Section 4.36.567, who was a

1 member of the retirement system at any time prior to June 23, 1972, and whose rate of  
2 contribution at such prior time was less than 6 percent and whose rate was increased by 2.03  
3 percent of the compensation of such member pursuant to Ordinance 111303 shall have such rate  
4 further increased by 1 percent, exclusive of overtime, effective January 5, 2011, and by an  
5 additional 1 percent, exclusive of overtime, effective January 4, 2012.

6 B. Members of Plan 2 of the retirement system shall make contributions to the retirement  
7 fund at the rate of 7.0 percent of compensation.

8 C. Member contributions as provided in ~~((subsection 4.36.540.A))~~ this Section 4.36.540  
9 shall be deducted by the Director of Finance ~~((and Administrative Services))~~ and shall be paid  
10 into the retirement fund, provided for in this ~~((chapter))~~ Chapter 4.36, and shall be credited by  
11 the Board together with regular interest.

13 Every member shall be deemed to consent and agree to the contribution made and provided for  
14 in this ~~((section))~~ Section 4.36.540, and ~~((shall receipt))~~ to have been provided in full ~~((for))~~ ~~((his~~  
15 ~~or her))~~ the member's salary or compensation. Payment of such salary or contribution less said  
16 contributions shall be a full and complete discharge of all claims and demands whatsoever for  
17 the service rendered by such person during the period covered by such payment, except ~~((his or~~  
18 ~~her))~~ the member's claim to the benefits to which ~~((he or she))~~ the member may be entitled under  
19 the provisions of this ~~((chapter))~~ Chapter 4.36.

20 Section 19. Section 4.36.545 of the Seattle Municipal Code, last amended by Ordinance  
21 124574, is amended as follows:

22 **4.36.545 Contributions – City**



1 The City shall match the normal contributions of members described in ~~((Section))~~ subsection  
2 4.36.540.A and provide for payment of the matching contributions into the retirement fund at the  
3 earliest time possible. The City shall also contribute, in excess of the matching contributions, the  
4 actuarially determined City contribution to provide the moneys necessary to guarantee benefits  
5 payable under Sections 4.36.605, 4.36.608, and 4.36.650, as well as all other benefits allowable  
6 to members and their beneficiaries under the provisions of this chapter including death benefits,  
7 except such as are provided by the accumulated contributions and death benefit assessments of  
8 members. All contributions of the City from all of its departments are available for payment of  
9 obligations of the retirement system without segregation by employing departments.

10 Section 20. Section 4.36.550 of the Seattle Municipal Code, last amended by Ordinance  
11 124574, is amended as follows:

12 **4.36.550 City obligations**

13 A. The payments of the City due the retirement fund as provided for in this chapter are  
14 made obligations of the City except as provided in subsection 4.36.550.B ~~((of this section))~~. The  
15 Board shall annually, ~~((on or))~~ before ~~((the tenth day of July))~~ August each year, prepare and  
16 submit to the City Council an estimate of the amounts necessary to meet such obligations, and  
17 the City Council shall provide for the raising of such amounts as are necessary to make such  
18 payments.

19 B. The City may at any time change, modify, or repeal this ~~((chapter))~~ Chapter 4.36 or

1 ~~effect as provided in this chapter, and that the City's obligation to those members not receiving~~

5 ~~obligation as actuarially determined under Section 4.36.545 to the date of such change,~~  
6 ~~modification or repeal)) the extent permitted by law.~~

7 Section 21. Section 4.36.555 of the Seattle Municipal Code, last amended by Ordinance  
8 124575, is amended as follows:

9 **4.36.555 Determination of creditable service**

10 A. A member who has served continuously in a full-time position and not realized any  
11 time loss will accrue a creditable year of service for 12 months' service. No additional credit is  
12 given for ~~((Leap Year's Day))~~ February 29.

13 B. For all other members, a creditable year of service is measured as 2,088 hours of  
14 compensated service at straight-time pay.

15 C. When shown on the City's payroll, paid vacation, sick leave, military leave, funeral  
16 leave, and, if the employee pays ~~((his or her))~~ contribution, "time loss" on worker's compensation  
17 or time during family and medical leave under Chapter 4.26, are counted. Overtime (whether or  
18 not paid), unpaid leave, time not worked during a layoff, strike or disciplinary suspension, and  
19 service as a volunteer are not counted. Service on a temporary City assignment to another  
20 government or organization may be counted, in the discretion of the Board, if the member or the  
21 member's employer pays the employee contribution.

22 D. Creditable service is calculated by an employee's hours or time worked, as certified by  
23 the Director of Finance ~~((and Administrative Services))~~ to the retirement system. When payroll

1 records are available, the Director of Finance (~~((and Administrative Services))~~) shall multiply the  
2 hours worked by a temporary, interim, seasonal, or provisional worker, or by (~~((and))~~) a worker in  
3 a part-time position (~~((of less than 20 hours per week over a one year period))~~) exempt from the  
4 Civil Service by a factor of 1.135 in reporting creditable service to the retirement system, to  
5 account for paid leave which was not received and for premium pay which may be substituted  
6 for paid leave. The Director of Finance (~~((and Administrative Services))~~) shall reduce the hours or  
7 days determined by application of the multiplier by the amount of any paid leave actually  
8 provided to the employee and counted in the hours or days worked.

9 E. No creditable service may accrue for City employment during which the City  
10 contributes to another retirement system on the employee's behalf or for a member's City  
11 employment after (~~((he or she))~~) that employee or member retires on a service retirement and,  
12 except for the annual death benefit assessment, no deduction shall be made from (~~((his or her))~~)  
13 that employee or member's pay for retirement purposes.

14 Section 22. Section 4.36.560 of the Seattle Municipal Code, last amended by Ordinance  
15 124574, is amended as follows:

16 **4.36.560 Estimate length of service**

17 If it shall be impracticable for the Board to determine from the records the length of service, the  
18 compensation, or the age of any member, the Board may estimate, for the purpose of this  
19 (~~((chapter))~~) Chapter 4.36, such length of service, compensation, or age.

20 Section 23. Section 4.36.565 of the Seattle Municipal Code, last amended by Ordinance  
21 124574, is amended as follows:

22 **4.36.565 Modification of (~~((allowance))~~) benefits for service**

1 Subject to the following and all other provisions of this (~~chapter~~) Chapter 4.36, including such  
2 rules and regulations as the Board shall adopt in pursuance thereof, the Board, subject to the  
3 approval of the City Council, shall determine and may modify (~~allowance~~) benefits for service  
4 as provided in this Section 4.36.565.

5  
6 Time during leave on account of sickness or injury, time during family and medical leave under  
7 Chapter 4.26, (~~or~~) time served in either the Police or Fire Departments, (~~or~~) time during  
8 which a member was under temporary or provisional appointment before becoming a member, or  
9 time during which a member was on extended leave of absence while serving as an officer of a  
10 labor organization the membership of which includes City employees, may be allowed in  
11 computing creditable service, provided such members shall pay into the retirement fund an  
12 amount equal to the normal contributions covering the period for which creditable service is  
13 claimed; and provided, further, that as to employees who commenced City service on or before  
14 December 31, 1987, the first six (~~6~~) months of such members' employment shall be allowed  
15 in computing creditable service without such payment. Time during which a member is absent  
16 on leave without pay for reasons other than those specified in this (~~section~~) Section 4.36.565  
17 shall not be allowed in computing creditable service.

18  
19 Each member shall file with the Board such information affecting (~~his or her~~) the member's  
20 status as a member of the retirement system as the Board may require.

21 Section 24. Section 4.36.567 of the Seattle Municipal Code, enacted by Ordinance  
22 124574, is amended as follows:

23 **4.36.567 Purchase of creditable service**

1           A. Redeposit of ~~((Creditable Service))~~ creditable service for eligible employees  
2 reentering City service who had previously withdrawn contributions as provided for in Section  
3 4.36.665.

4           1. ~~((Any))~~ Except as provided in subsection 4.36.567.D, any member or former  
5 member who reenters City service may redeposit in the retirement fund an amount equal to that  
6 which ~~((he or she))~~ the member or former member previously withdrew therefrom, or some part  
7 thereof, plus compound interest, at the actuarial assumed rate of investment return, which would  
8 have accumulated on the amount, as determined by the Board, between the date of ~~((his or her))~~  
9 last termination of ~~((his or her))~~ membership and the date of redeposit. Within two years after  
10 ~~((his or her))~~ re-entry into City service, a former member must redeposit the entire sum  
11 determined to be due to purchase all, or part of, their former creditable service, or sign and file  
12 with the Board a redeposit contract in accord with subsection ~~((4.36.567.B))~~ 4.36.567.C in order  
13 to reestablish all or part of ~~((his or her))~~ the former creditable service. In the event such redeposit  
14 is made by a member, the City shall reinstate all or that part of the former creditable service  
15 purchased by the member.

16           2. ~~((If))~~ Except as provided in subsection 4.36.567.D, if a member ~~((within two~~  
17 years after reentering the retirement system after a termination of his or her membership does not  
18 make such a redeposit or file a properly executed redeposit contract)) otherwise eligible to make  
19 a redeposit or enter a redeposit contract does not do so as provided above in subsection  
20 4.36.567.A.1 within two years from reentry into City service, ~~((he or she))~~ the member may  
21 purchase all, or some part of, ~~((his or her))~~ the member's former creditable service ~~((only by~~  
22 paying into the retirement fund the amount, or some part thereof, he or she previously withdrew  
23 plus compound interest as determined by the Board. The following provisions apply to redeposits

1 ~~made pursuant to this subsection 4.36.567.A.2))~~ by redepositing the amount withdrawn as  
2 follows:

3 a. Determination of applicable interest rates. The interest rate for each year  
4 since the date of withdrawal of contributions shall be the greater of the rate the retirement fund  
5 has earned, net of fees, as reported by the Retirement System's Investment Performance  
6 Consultant, or the interest rate equivalent to the actuarial assumed rate of investment return at the  
7 time of executing the redeposit contract.

8 b. Calculation of "accumulated contributions." For purposes of  
9 determining a member's accumulated contributions pursuant to Section 4.36.030, only a portion  
10 of the total amount deposited shall be considered. The portion to be considered as the member's  
11 accumulated contributions shall be only the amount previously withdrawn as the member's  
12 contributions including interest, plus interest calculated at the actuarial assumed rate of  
13 investment return.

14 c. Withdrawal of contributions limited. The total amount deposited for the  
15 purchase of said former creditable service will be available for withdrawal by the member only if  
16 the member terminates employment with the City and withdraws his or her total accumulated  
17 contributions prior to retirement or dies and benefits are not payable under subsections  
18 4.36.680.B and 4.36.680.C. In the event such redeposit is made by a member, ~~((his))~~ the  
19 member's rate of contribution shall be as determined under ~~((subsection))~~ Section  
20 4.36.540((-A)), and the City shall reinstate all, or that part of, the former creditable service  
21 purchased by the member.

22 B. Purchase of ~~((Creditable Service))~~ creditable service

1                   1. Unless otherwise stated, members allowed to purchase creditable service  
2 pursuant to Chapter 4.36 shall pay, as a single lump sum payment at the time of retirement, the  
3 actuarial present value of the resulting increase in their benefit as provided in this subsection  
4 4.36.567.B.1.

5                   a. The actuarial present value shall be calculated by the Retirement Board  
6 using the current actuarial assumptions as approved by the Retirement Board.

7                   b. For purposes of determining the member's accumulated contributions  
8 pursuant to Section 4.36.030, only a portion of the total amount deposited shall be considered.  
9 The portion to be considered as the member's accumulated contributions shall be calculated at  
10 the employee's current hourly rate times the current contribution rate times the number of hours  
11 to be purchased.

12                   c. If a member elects to pay at resignation from City service, the actuarial  
13 present value will be estimated at the time of resignation and adjusted at retirement for factors  
14 existing at the time of retirement, if necessary, according to rules established by the Retirement  
15 Board.

16                   d. In the event such payment is made by a member, the City shall consider  
17 such City service previously rendered as creditable service for the member.

18                   2. Unless otherwise stated, the purchase price for the purchase of creditable  
19 service must be paid in full to the retirement fund prior to the time of resignation from City  
20 service or retirement, whichever occurs first.

21                   C. Redeposit and (~~Purchase Contracts~~) purchase contracts. These terms and conditions  
22 govern redeposit contracts for reentering City officers and employees, deposit contracts of

1 officers and employees joining the system under subsections 4.36.525.C, 4.36.525.E, and  
2 4.36.525.F ((of Section 4.36.525)) and the purchase of creditable service for past City service.

3           1. The unpaid balance shall accrue interest at the assumption rate established by  
4 the Board for actuarial purposes and in effect at the time the redeposit agreement is signed;

5           2. The redeposit must be completed within ten years from the date of the  
6 member's re-entry into City service;

7           3. After deducting any immediate redeposit, the balance shall be payable in  
8 approximately equal installments every pay period, computed by amortizing interest over the  
9 contract term, unless the Board by rule authorizes redeposit in installments of equal payments of  
10 principal with interest computed on declining balances;

11           4. Installment payments shall be deducted from the member's pay during each pay  
12 period; and

13           5. Redeposit agreements shall be subject to the approval of the Board. The Board  
14 of Administration in its discretion may include supplemental terms and conditions by rule or by  
15 approving a form of agreement on the following subjects, among others:

16                   a. A minimum installment payment per pay period;

17                   b. The deferral of a redeposit of an installment during a member's layoff,  
18 military leave, or other approved leave, with catch-up redeposits upon the member's resumption  
19 of pay status;

20                   c. Allocation of payments between interest and principal;

21                   d. Appropriate arrangements in the event of a member's suspension or  
22 separation from City service, including the making of set-offs, acceleration of payments,



1 continuation of payments from other sources during the interim, or adjusting creditable service  
2 being purchased on a pro-rata basis;

3 e. Other terms and conditions as the Board may deem appropriate.

4 D. No redeposit or repurchase rights for periods of service forfeited under subsection  
5 4.36.525.K. Notwithstanding anything to the contrary in this Chapter 4.36, a member who has  
6 made an election under subsection 4.36.525.K to join Plan 2 shall not retain any rights to  
7 redeposit contributions or to purchase or repurchase service credit for any of the member's  
8 contributions or service credit earned prior to the election to join Plan 2, nor shall such a member  
9 otherwise be eligible restore any creditable service or membership status under Plan 1.

10 Section 25. Section 4.36.570 of the Seattle Municipal Code, last amended by Ordinance  
11 124574, is amended as follows:

12 **4.36.570 Purchase of creditable service for initial six months of City service for employees**  
13 **hired during 1988 through 1998 period**

14 ~~((Buy-back.))~~ Employees who were hired during the period 1988 through 1998 who have not  
15 purchased creditable service for the initial six months of employment may purchase said  
16 creditable service by paying into the retirement fund, at the time of resignation or retirement  
17 from City service, the actuarial present value of the resulting increase in their benefit. The terms  
18 and conditions of purchase shall be in accordance with the provisions of ~~((Subsection))~~  
19 subsection 4.36.567.B.

20 Section 26. Section 4.36.575 of the Seattle Municipal Code, last amended by Ordinance  
21 124574, is amended as follows:

22 **4.36.575 Buy-in of creditable service by temporary, interim, intermittent, or provisional**  
23 **workers and ~~((part-time))~~ workers in part-time positions**

1 These terms and conditions apply to workers acquiring ("buying in") creditable service under  
2 Section 4.36.530 for earlier work in temporary, interim, intermittent, or ((and)) provisional  
3 positions, and ((or)) part-time positions ((of less than 20 hours per week during the course of the  
4 year)) exempt from the Civil Service.

5 A. Eligible ((Services)) services. The first 1,044 hours of City service are not eligible for  
6 purchase of creditable service. Only hours in continuous City service as shown on City payrolls  
7 can be counted subject to the multiplier in Section 4.36.555. A break in the continuity of City  
8 service excludes hours before the break. Such a break in on-call, seasonal, or intermittent service  
9 occurs if a worker:

10 1. Removes ((his or her)) that worker's name from a roster or listing for work  
11 assignments;

12 2. In seasonal employment, declines the opportunity to work for a season; or, in  
13 other employment, fails to work at least 100 hours in any 12 month period;

14 3. Takes other actions indicating that ((he or she)) the worker has stopped or  
15 suspended for a year providing ((his or her)) services to the City; or

16 4. Is discharged from City employment.

17 B. Amount of ((Creditable Service)) creditable service. Creditable service shall be  
18 granted only for the hours for which both the worker and the City make contributions to the  
19 retirement system at the rate contemplated by Section 4.36.540. To receive creditable service for  
20 prior City service, ((such a)) the worker shall deposit into the retirement system an amount  
21 determined by the Board of Administration equal to the sum, or some part thereof, that ((he or  
22 she)) the worker would have paid had ((he or she)) the worker become a member when first  
23 eligible and had deductions been made from ((his or her)) the worker's pay warrants, through the

1 years, for creditable service, together with interest thereon. Interest shall accrue at the Board's  
2 assumption rate established for actuarial purposes from the date of the wage or salary payment to  
3 the date of deposit and shall be compounded annually.

4 C. Waiting (~~(Period, Service Before)~~) period, service before 1988. A worker, who began  
5 (~~his or her~~) continuous City service on or before December 31, 1987 and has not already  
6 received such credit, shall receive creditable service for the first 1,044 hours, or portion thereof,  
7 of continuous service (~~that he or she~~) worked before January 1, 1988. This is a transitional  
8 exception to subsection 4.36.530.B (~~of Section 4.36.530~~).

9 D. Administration. The Board, in its discretion, may delegate to the Executive Director  
10 the calculation of the amount of contribution for such ((a)) worker to acquire ("buy in") in prior  
11 creditable service and may authorize its Executive Director to use an approximate formula to  
12 simplify computations and/or to determine credit for vacation and other paid leave when City  
13 records are not available therefor. For example, for hourly workers, who have held the same or  
14 similar positions over the duration of the buy-back period, the Board may determine the amount  
15 due by:

16 1. (~~Classifying~~) classifying the worker's creditable hours by the contribution rate  
17 in effect at the time the hours were worked;

18 2. (~~Multiplying~~) multiplying the creditable hours in each rate classification by  
19 the worker's current hourly wage rate and by the applicable contribution rate; and

20 3. (~~Adding~~) adding the total of the products of all such classifications together.

21 E. Deposit Contract. The Board may authorize such ((a)) worker to (~~make his or her~~)  
22 deposit under an agreement for installment payments under the following terms and conditions:

1                   1. The deposit must be completed within ten years from the date of the member's  
2 eligibility to join the retirement system.

3                   2. After deducting any immediate deposits, the balance shall be payable in  
4 approximately equal amortized installments unless the Board authorizes otherwise. Installments  
5 shall be deducted from the worker's pay whenever ~~((practical))~~ practicable. By rule the Board  
6 may establish a minimum initial deposit and allowable installment payment and may include  
7 other appropriate terms and conditions in the agreement.

8                   3. A member may accelerate and prepay all or part of ~~((his or her))~~ the deposits at  
9 any time before ~~((he or she))~~ the member dies, retires, or discontinues City service, whichever  
10 may be sooner. ~~((In the event of))~~ If extenuating circumstances ~~((that))~~ preclude an earlier  
11 payment, the Executive Director may allow a member up to ten days after ~~((his or her))~~  
12 retirement or discontinuance of City service to make a lump sum payment of the balance.

13                   4. If a member dies, retires, or discontinues city service before completion of the  
14 contract, the member shall receive creditable service on ~~((his or her))~~ the member's buy-in on a  
15 pro rata basis.

16                   5. The member is responsible for making any adjustments appropriate under the  
17 Internal Revenue Code with respect to individual retirement accounts and privately administered  
18 retirement plans.

19                   F. City ~~((Matching Money))~~ matching money. The City shall match the member's  
20 contributions and deposits, including interest, in the same manner as other members. If the  
21 worker provided services in two or more departments, at the request of the Director of Finance,  
22 the City Budget Director shall apportion the amount of the City contribution among the  
23 employing departments. The Director of Finance's determination of apportionment shall be final.

1 G. If not exercised, the opportunity described in this section 4.36.575 for a worker to  
2 acquire ("buy in") service credit for prior City service in a temporary, interim, intermittent, or  
3 provisional position, or a part-time position (~~(of less than 20 hours per week over a one-year~~  
4 ~~period)) exempt from the Civil Service, expires six calendar months after the worker becomes  
5 eligible for membership in the retirement system. Members who have otherwise failed to  
6 exercise an option to purchase creditable service for prior service previously rendered as a  
7 temporary worker, as that term is defined ~~((at))~~ in Section 4.04.030, shall be allowed to purchase  
8 creditable service for service previously rendered but not credited as a temporary worker, by  
9 paying into the retirement fund, at the time of resignation from City service or at retirement, the  
10 actuarial present value of the resulting increase in ~~((his or her))~~ benefit. The terms and conditions  
11 of purchase shall be in accordance with the provisions of ~~((Subsection))~~ subsection 4.36.567.B,  
12 and purchases of service credit will not be permitted to the extent forfeited under subsections  
13 4.35.525.K and/or 4.36.567.D.~~

14 Section 27. Section 4.36.580 of the Seattle Municipal Code, last amended by Ordinance  
15 124574, is amended as follows:

16 **4.36.580 Creditable service for military service – purchases and ~~((allowance.))~~ grants**

17 A. A member may purchase creditable service for past active duty in the armed forces of  
18 the United States of America or the State of Washington, by paying into the Retirement Fund, at  
19 the time of resignation from City service or at the time of retirement, the actuarial present value  
20 of the resulting increase in ~~((his or her))~~ benefit. Terms and conditions of purchase shall be in  
21 accordance with the provisions of ~~((Subsection))~~ Section 4.36.567. In no instance shall military  
22 service in excess of five ~~((5))~~ years be credited under this ~~((chapter))~~ Chapter 4.36.

1           B. Any member who shall make ((his)) normal contributions to the retirement system  
2 while on leave of absence under Section 1 of Ordinance 69816 or while absent in the active  
3 service of the United States Public Health Service in fulfillment of military service obligations  
4 under laws of the United States, or who after ((his)) returning to City service shall make the same  
5 in full or in monthly payments equal to ((his)) the member's current normal contribution, shall  
6 for the period of such leave of absence be entitled to all rights, privileges, and benefits allowable  
7 under such system, including the ((allowance)) grant of such time as creditable service. In  
8 addition, any member in the City service on December 27, 1972, who heretofore or who  
9 hereafter enters the active military or naval service after having been laid off from City  
10 employment and who reentered or reenters City service subsequent to such active military or  
11 naval service shall be entitled to all rights, privileges, and benefits allowable under such system,  
12 including the ((allowance)) grant of such period of military or naval service as creditable service  
13 provided that such member pay to the retirement system his normal contributions for such  
14 period.

15           Section 28. Section 4.36.585 of the Seattle Municipal Code, last amended by Ordinance  
16 124574, is amended as follows:

17           A. Direct ((Transfers)) transfers. Effective January 1, 2002, the retirement fund possesses  
18 the specific authority to enter into direct transfer of assets agreements with the trustees of an  
19 eligible plan under Section 457 of the ((Internal Revenue)) Code ((which)) that is maintained by  
20 a state, political subdivision of a state, or any agency or instrumentality of a state or political  
21 subdivision of a state, or from a plan under Section 403(b) of the ((Internal Revenue)) Code, for  
22 the purchase of creditable service otherwise available pursuant to ((SMC)) Chapter 4.36.

1 B. Other (~~(Rollovers)~~) rollovers. Effective January 1, 2002, the retirement fund may  
2 accept participant rollover contributions and/or direct rollovers of distributions from other  
3 retirement plans which are eligible retirement plans described in (~~(Internal Revenue)~~) Code  
4 Section 402(c)(8)(B) to the extent allowed by the (~~(Internal Revenue)~~) Code. The fund may  
5 accept rollovers from such sources and may develop such procedures and rules as it deems  
6 necessary or desirable to comply with the requirements and guide its decisions regarding  
7 participant rollover contributions and/or direct rollovers of distributions it will accept. Such  
8 rollover contributions and direct rollovers may be used for the purchase of service credit  
9 otherwise available pursuant to (~~(SMC)~~) Chapter 4.36.

10 Section 29. Section 4.36.590 of the Seattle Municipal Code, last amended by Ordinance  
11 124574, is amended as follows:

12 **4.36.590 Election to participate in chapter 41.54 RCW (~~(Chapter 41.54)~~)**

13 A. As authorized by (~~(RCW)~~) chapter 41.54(~~(.061)~~) RCW, the City irrevocably elects to  
14 participate in the portability of public retirement systems as contemplated by (~~(RCW Chapter)~~)  
15 chapter 41.54 RCW, which provisions as amended are incorporated herein by reference, and to  
16 pay for the additional cost it may incur as a result of the benefits provided.

17 B. The eligibility of members for the portability of public retirements benefits, the  
18 benefits available thereunder, the limitations (including RCW 41.54.080), and the procedures  
19 (~~(shall be)~~) as set out in chapter 41.54 RCW (~~(Chapter 41.54- A)~~) shall establish whether a  
20 member may aggregate service credit in two or more retirement systems for the purpose of  
21 determining the percentage factor to be used in calculating a service retirement (~~(allowance)~~)  
22 benefit pursuant to subsection 4.36.605.B or Section 4.36.608.

1 C. Beginning January 1, 2003, a dual member, as defined ~~((at))~~ in RCW 41.54.010(4),  
2 who has failed to restore creditable service pursuant to RCW 41.54.020(2), or to redeposit during  
3 the period of December 1, 2001 through December 31, 2002 as provided in Section 9 of  
4 Ordinance 120684, may redeposit in the retirement fund an amount equal to ~~((that which he or~~  
5 ~~she))~~ the amount previously ~~((withdrew))~~ withdrawn therefrom plus compound interest as  
6 determined by the Board. The terms and conditions of purchase shall be in accordance with the  
7 provisions of subsection 4.36.567.B.

8 Section 30. Section 4.36.595 of the Seattle Municipal Code, last amended by Ordinance  
9 124574, is amended as follows:

10 **4.36.595 Beneficiaries – Domestic partners**

11 An unmarried officer or employee may designate ~~((his or her))~~ the officer's or employee's  
12 domestic partner as ~~((his or her))~~ beneficiary for purposes of the benefits set forth in Sections  
13 4.36.600, 4.36.605, 4.36.607, 4.36.608, 4.36.610, 4.36.650, ~~((4.36.610,))~~ 4.36.680, and 4.36.690  
14 ~~((of this chapter))~~ upon the following terms and conditions.

15 A. The officer ~~((of))~~ or employee shall file an affidavit of domestic partnership as  
16 described in Sections 4.30.010 and 4.30.020 and file a copy of said affidavit with the Executive  
17 Director of the Retirement System. If the member is no longer an officer or employee of the  
18 City, ~~((he or she))~~ the member may designate ~~((his or her))~~ a domestic partner by signing an  
19 affidavit as described in Section 4.30.020 and filing said affidavit with the Executive Director of  
20 the Retirement System.

21 B. A member who is married may not file an affidavit of domestic partnership. If a  
22 member has filed an affidavit of domestic partnership and is married, or thereafter becomes  
23 married, such affidavit shall be ~~((considered))~~ void. A member who has filed an affidavit of



1 domestic partnership pursuant to this ~~((section))~~ 4.36.595 shall immediately notify the Executive  
2 Director in writing if ~~((he or she))~~ the member has married and shall promptly file with the  
3 Executive Director a termination of the affidavit of domestic partnership. Termination of  
4 domestic partnership shall otherwise be as provided in Section 4.30.030, provided that the  
5 member shall also file a notice of termination of domestic partnership with the Executive  
6 Director.

7 C. Nothing in this ~~((chapter))~~ Chapter 4.36 shall be construed as granting to a domestic  
8 partner a property right to retirement benefits of a member. A member who has filed an affidavit  
9 of domestic partnership with the Executive Director does not need the consent of ~~((his or her))~~  
10 the member's domestic partner to take action with respect to ~~((his or her))~~ retirement benefits,  
11 including selection of a retirement option.

12  
13 The Retirement Board is authorized to promulgate such rules as it deems necessary to implement  
14 this ~~((section))~~ Section 4.36.595.

15 Section 31. Section 4.36.600 of the Seattle Municipal Code, last amended by Ordinance  
16 124574, is amended as follows:

17 **4.36.600 Retirement of a Plan 1 member for service by Board**

18 Retirement of a Plan 1 member for service shall be made by the Board as follows:

19 A. Any Plan 1 member in the City service may retire by filing with the Board a written

21 least 30 days prior to date of retirement; provided, however, that the member, at the time

1 years of City service, and shall have attained the age of 57 years, or shall have completed 20  
2 years of City service and shall have attained the age of 52 years, or shall have completed 30  
3 years of City service as defined in this ~~((chapter))~~ Chapter 4.36. Permanent discontinuance of  
4 City service after the Plan 1 member has become eligible for a retirement ~~((allowance))~~ benefit  
5 under the provisions of this ~~((chapter))~~ Chapter 4.36 shall entitle such member to his retirement  
6 ~~((allowance))~~ benefit: Provided that if discontinuance of City service is caused by  
7 ~~((intemperance, wilful))~~ willful misconduct or violation of law on the part of the member, of  
8 which the Board shall be the judge, the Board of Administration, in its discretion, may pay to the  
9 member, in one lump sum, ~~((his))~~ the member's accumulated contributions, in lieu of a  
10 retirement ~~((allowance))~~ benefit, and such payment shall constitute full satisfaction of all  
11 obligations of the City or the retirement system to such member, and upon receipt of such  
12 payment ~~((he))~~ the member shall cease to be a member of the system.

13 B. Any Plan 1 member of the retirement system who, upon termination of ~~((his))~~  
14 employment with the City after earning at least five ~~((years' membership))~~ years of creditable  
15 service in the retirement system, elects to leave all ~~((his))~~ the member's contributions in the  
16 retirement fund pursuant to ~~((Subsection))~~ Section 4.36.665 shall be eligible to receive a  
17 retirement ~~((allowance))~~ benefit upon reaching the age of 62 years; provided, that if such  
18 member completed ten years of service prior to termination of ~~((his))~~ employment, ~~((he))~~ the  
19 member shall be eligible to receive a retirement ~~((allowance))~~ benefit upon reaching the age of  
20 57 years, and if such member completed 20 years of service prior to termination of ~~((his))~~  
21 employment, ~~((he))~~ the member shall be eligible to receive a retirement ~~((allowance))~~ benefit  
22 upon reaching the age of 52 years. Such person shall file with the Board a written application,

2 awarded a retirement ((allowance)) benefit as provided for members in Section 4.36.605, and

4 that any person leaving the City service prior to qualifying for retirement under subsection  
5 4.36.600.A ((of this section)) shall not be eligible to receive any disability retirement  
6 ((allowance)) benefit under Sections 4.36.650, 4.36.655, and 4.36.660, nor shall ((his)) that  
7 person's estate or ((his)) beneficiaries receive the death benefit provided in Section 4.36.690;  
8 provided further, that persons leaving the City service prior to qualifying for retirement under  
9 subsection 4.36.600.A ((of Section 4.36.600)) shall, if and when eligible to receive a retirement  
10 ((allowance)) benefit as provided in this subsection 4.36.600.B, be eligible for the alternative  
11 ((allowance)) benefit computation provided in subsection 4.36.605.B ((of Section 4.36.605)),  
12 based upon ((his)) the member's age at the time of commencement of payment of such member's  
13 retirement ((allowance)) benefit, and in the event any such former employee dies before  
14 commencement of ((his)) the member's retirement ((allowance)) benefit pursuant to this  
15 subsection 4.36.600.B, the provisions of ((Subsection)) subsection 4.36.680.C shall be applicable  
16 to such person's spouse or domestic partner, if named as beneficiary, and if there is no surviving  
17 spouse or domestic partner, the provisions of ((Subsection)) subsection 4.36.680.C.2 shall be  
18 applicable to such person's child or children under the age of 18 years, if named as beneficiary.

19 C. Any former employee who prior to March 1, 1977, discontinued ((his)) City service to  
20 accept other public employment and who, because of such subsequent public employment, was  
21 permitted to leave ((his)) the employee's contributions in the retirement fund ((;)) shall be  
22 eligible to receive a retirement ((allowance)) benefit upon reaching the age of 65 years; provided,  
23 that if such former employee completed five years of City service, ((he)) the employee shall be

1 eligible to receive a retirement ((allowance)) benefit upon reaching the age of 62 years, and if  
2 such former employee completed ten years of City service, ((he)) the employee shall be eligible  
3 to receive a retirement ((allowance)) benefit upon reaching the age of 57 years; and if such  
4 former employee completed 20 years of City service, ((he)) the employee shall be eligible to  
5 receive a retirement ((allowance)) benefit upon reaching the age of 52 years. Such person shall  
6 file with the Board a written application, stating the date when ((he)) the person wishes the  
7 payment of ((his)) retirement ((allowance)) benefit to commence, at least ((thirty)) 30 days prior  
8 to said date. ((He)) Such person shall thereupon be awarded a retirement ((allowance)) benefit as  
9 provided for members in Section 4.36.605, and shall be eligible to elect in lieu thereof any of the  
10 options provided in Section 4.36.610; provided, that any former employee to whom this  
11 subsection is applicable shall not be eligible to receive any disability retirement ((allowance))  
12 benefit under Sections 4.36.650, 4.36.655, and 4.36.660, nor shall ((his)) the employee's estate  
13 or ((his)) beneficiaries receive the death benefit provided in Section 4.36.690; provided further,  
14 that such former employees shall, if and when eligible to receive a retirement ((allowance))  
15 benefit as provided in this subsection, be eligible for the alternative ((allowance)) benefit  
16 computation provided in subsection 4.36.605.B, based on ((his or her)) the employee's age at the  
17 time of commencement of payment of such member's retirement ((allowance)) benefit, and, in  
18 the event any such person dies before commencement of ((his)) retirement ((allowance)) benefit  
19 pursuant to this subsection 4.36.600.B, the provisions of subsection 4.36.680.B shall be  
20 applicable to such person's spouse or domestic partner, if named as beneficiary, and if there is no  
21 surviving spouse or domestic partner, the provisions of subsection 4.36.680.C shall be applicable  
22 to such person's child or children under the age of 18 years, if named as beneficiary.

11 purchased by the accumulated ((normal)) contributions of the Plan 1 member ((-)) ; or

12 B. The benefit determined by using the "percentage" scale in the following ((Table  
13 4.36.605.B)) Table A for 4.36.605, ((may be used in fixing the amount of a service retirement  
14 allowance, to be)) computed by multiplying the number of years of creditable service by the  
15 indicated percentage of final compensation. ((; provided that such scale may also be used in  
16 determining benefits of surviving spouses and domestic partners of employees receiving  
17 disability retirement benefits under Subsection 4.36.650.D provided, further, that such scale may  
18 also be used in determining benefits payable under Subsection 4.36.680.C to the surviving  
19 spouse and domestic partner of any member who was at least 48 years of age at the time of such  
20 member's death.)) This scale shall also be used in determining benefits of surviving spouses and  
21 domestic partners of Plan 1 members receiving disability retirement benefits under subsection  
22 4.36.650.D, and in determining benefits payable under subsection 4.36.680.C to the surviving  
23 spouse and domestic partner of any Plan 1 member. Use of ((this)) the scale is subject to the

1 limitation that the retirement ((allowance)) benefit of such a Plan 1 member shall not exceed 60  
 2 percent of the member's final compensation. ((The retirement allowance payable over and above  
 3 the basic pension shall be purchased by contributions of the City. The application of the scale  
 4 herein established shall be at the option of the member.))

11 member has become eligible for a retirement benefit under the provisions of this Chapter 4.36  
12 shall entitle such member to the retirement benefit; provided that if discontinuance of City  
13 service is caused by willful misconduct or violation of law on the part of the member, of which  
14 the Board shall be the judge, the Board of Administration, in its discretion, may pay to the  
15 member, in one lump sum, the member's accumulated contributions, in lieu of a retirement  
16 benefit, and such payment shall constitute full satisfaction of all obligations of the City to such  
17 member, and upon receipt of such payment the member shall cease to be a member of the  
18 system.

19 B. Any Plan 2 member of the retirement system who, upon termination of employment  
20 with the City after earning at least five years of creditable service in the retirement system, elects  
21 to leave all the member's contributions in the retirement fund pursuant to Section 4.36.665 shall  
22 be eligible to receive a retirement benefit upon reaching the age of 60 years; provided, that if  
23 such member completed ten years of service prior to termination of employment, he shall be

1 eligible to receive a retirement benefit upon reaching the age of 57 years, and if such member  
2 completed 20 years of service prior to termination of his employment, he shall be eligible to  
3 receive a retirement benefit upon reaching the age of 55 years. Such member shall file with the  
4 Board a written application, stating the date when the member wishes the payment of retirement  
5 benefit to commence, at least 30 days prior to said date. The member shall thereupon be awarded  
6 a retirement benefit as provided for Plan 2 members in Section 4.36.608, and shall be eligible to  
7 elect in lieu thereof any of the options provided in Section 4.36.610; provided, that any person  
8 leaving the City service prior to qualifying for retirement under subsection 4.36.607.A shall not  
9 be eligible to receive any disability retirement benefit under Sections 4.36.650, 4.36.655, and  
10 4.36.660, nor shall such person's estate or beneficiaries receive the death benefit provided in  
11 Section 4.36.690; provided further, that in the event any such former employee dies before  
12 commencement of retirement benefit pursuant to this subsection 4.36.607.B, the provisions of  
13 subsection 4.36.680.C shall be applicable to such person's spouse or domestic partner, if named  
14 as beneficiary, and if there is no surviving spouse or domestic partner, the provisions of  
15 subsection 4.36.680.C.2 shall be applicable to such person's child or children under the age of 18  
16 years, if named as beneficiary.

17 Section 34. A new Section 4.36.608 is added to the Seattle Municipal Code as follows:

18 **4.36.608 Plan 2 retirement benefits designated**

19 The percentage scale in Table A for 4.36.608 shall be used in fixing the amount of a service  
20 retirement benefit for a Plan 2 member, to be computed by multiplying the number of years of  
21 creditable service by the indicated percentage of final compensation. This scale shall also be  
22 used in determining benefits of surviving spouses and domestic partners of Plan 2 members  
23 receiving disability retirement benefits under subsection 4.36.650.D, and in determining benefits

Section 35. Section 4.36.610 of the Seattle Municipal Code, last amended by Ordinance 124574, is amended as follows:

**4.36.610 Optional ((lesser)) reduced retirement ((allowances and distribution of benefits upon death of a member who has been retired for service)) benefits and beneficiary benefits**

A. Election of ((Optional Lesser Retirement Allowances)) optional reduced retirement benefits. A member may elect to receive, in lieu of the retirement ((allowance)) benefit provided for Plan 1 members in Section 4.36.605 or Plan 2 members in Section 4.36.608, its actuarial equivalent in the form of a ((lesser)) reduced monthly retirement ((allowance)) benefit, payable in accordance with the terms and conditions of one of the options set forth in Options A through E ((of this Section)) , subsections 4.36.610.C.1 through 4.36.610.C.5. In addition, Options F and/or G (subsections 4.36.610.C.6 and 4.36.610.C.7) may be elected alone or in conjunction with one of ((the options set forth in)) Options A through E. The election of Option F or G will result in the actuarial equivalent of the retirement ((allowance)) benefit otherwise payable. Option G includes the lump sum payment of a partial refund. If a combination is elected, the ((lesser)) reduced retirement ((allowance)) benefit shall be determined by first applying the Option G factor, ((if applicable,)) then the Option F factor, ((if applicable,)) and then finally the Option A – E factor, as applicable.

Election of any option must be made by written application filed with the Board of Administration at least 30 days in advance of retirement as provided in Section 4.36.600 or

1 4.36.607, and shall not be effective unless approved by the Board (~~(prior to retirement of the~~  
2 ~~member)~~). The amount paid to a member, a beneficiary, or a surviving spouse shall be reduced  
3 by payments made to an alternate payee under a court or department order as contemplated by  
4 Section 4.36.630.

5 B. Distribution of (~~(Benefits Upon Death of a Retired Member)~~) benefits upon death of a  
6 retired member. Upon the death of a retired member, any death benefits will be payable in  
7 accordance with the provisions of the options elected under this (~~(section)~~) Section 4.36.610, if  
8 any.

9 C. Options A through G (~~(-)~~)

10 1. OPTION A. The (~~(lesser)~~) reduced monthly retirement (~~(allowance)~~) benefit

7 written estimate of Social Security retirement benefits, may elect to have ~~((his))~~ the member's  
8 retirement ~~((allowance))~~ benefit payable ~~((during his or her life only, increased prior to the age at~~  
9 ~~which the member could elect an unreduced Social Security retirement benefit and reduced after~~  
10 ~~such age by amounts which have equivalent actuarial values. Prior to retirement, the member~~  
11 ~~shall obtain, and provide to the Board, a written estimate of his Old Age Benefit for the age at~~  
12 ~~which the member could elect an unreduced Social Security benefit))~~ over the member's lifetime  
13 in a greater amount prior to Social Security retirement age and a lesser amount after Social  
14 Security retirement age, with the goal of providing a reasonably level amount of combined  
15 retirement benefits under this retirement system and Social Security. Under this option, the  
16 benefit payable under the retirement system before the member's age of eligibility for unreduced  
17 Social Security benefits is increased, and the member's benefit payable after such age is  
18 decreased, with the difference between those two amounts to be the estimated amount of benefits  
19 payable to the member in unreduced Social Security retirement benefits. The amounts payable  
20 before and after unreduced Social Security retirement eligibility are determined on an actuarial  
21 basis, to provide an actuarially equivalent benefit to what the member would receive if not  
22 selecting this option, and based on an estimated Social Security retirement benefit that assumes  
23 that the member will continue to work and earn credit for Social Security retirement benefits

1 until the member's date of eligibility for unreduced Social Security retirement. If selected,  
2 benefits payable under this option will change at the member's predetermined date of eligibility  
3 for unreduced Social Security retirement benefits, regardless of whether the member elects  
4 Social Security benefits at an earlier or later date, and benefits under this system will not change  
5 based on any differences between estimated and actual Social Security benefits. If Option F is  
6 electd and the member's death occurs prior to the age at which the member could have elected  
7 an unreduced Social Security retirement benefit, any death benefit payable under any other

10           7. OPTION G. The member may elect to receive a lump sum payment upon

5 Section 37. Section 4.36.620 of the Seattle Municipal Code, last amended by Ordinance  
6 124574, is amended as follows:

8 A pension, annuity, or a retirement ~~((allowance))~~ benefit granted under the provisions of  
9 this ~~((chapter))~~ Chapter 4.36, unless otherwise specified herein, shall be payable in monthly  
10 installments, and each installment shall be for the current calendar month.

11 Section 38. Section 4.36.625 of the Seattle Municipal Code, last amended by Ordinance

21 commence when benefits or a withdrawal of contributions is made to or on account of the  
22 member. The amount paid shall not exceed the benefits payable under this ~~((chapter))~~ Chapter

2 accumulated contributions, the amount on deposit to the credit of the member.

3           2. A payment to the alternate payee shall cease if the payment to a member would

5 4.36.608, ((through)) or 4.36.610) or the member's reemployment (Sections 4.36.655 and  
6 4.36.635) in the absence of the order. The Director may not, on account of such an order, limit or  
7 coerce the decision of an eligible member to accept a disability ((allowance)) benefit (Sections  
8 4.36.645 through 4.36.650) or, if on disability retirement, to return to City employment (Sections  
9 4.36.655 and 4.36.660), or to convert to a service retirement ((allowance)) benefit (Section  
10 4.36.655); to withdraw accumulated contributions or to leave his or her contributions on deposit  
11 (Section 4.36.665), or to select a payment option (Sections 4.36.605, 4.36.608, ((through)) or  
12 4.36.610).

13           C. Formula for ((Determination.)) determination

14           1. If the member is already receiving benefits or has arranged to receive payment  
15 at a proximate date, the order must identify the alternate payee and the amount to be paid as:

16                   a. ((A)) a precise sum to be paid in a single payment or in equal monthly  
17 installments and the duration of the installment payments; or

18                   b. ((A)) a fixed percentage of the member's "disposable earnings" as  
19 defined in RCW 74.20A.090 or "disposable benefits" as defined in RCW 41.50.500(2), which  
20 are payable under the payment option that the member has selected.

21           2. If the member is not yet receiving benefits or has not arranged to receive  
22 payment at a proximate date, the order may also determine the amount payable to an alternate  
23 payee by a formula or ratio that becomes complete upon the Director supplying the member's

1 creditable or gross contributions; for example, a ratio that measures the member's creditable  
2 service on the date of the order to the member's creditable service at the time of retirement, or  
3 the member's contributions at a stated date, or a stipulated amount to the member's total  
4 contributions at the time benefits commence, or a withdrawal of accumulated contributions  
5 occurs. The City will not increase payments by an interest factor or adjust dollar values by a  
6 price index in calculating the payment to an alternate payee.

7 D. Rounding of ~~((Numbers))~~ numbers. A percentage of disposable benefits or a ratio on a  
8 formula must be capable of being expressed as a decimal to no more than three places; fractions  
9 extending beyond the third decimal place will be rounded to the nearest number at the third  
10 decimal place and the amount of any warrant rounded to the nearest cent.

11 E. Filing of ~~((Orders for Future Use))~~ orders for future use. The Director may keep orders  
12 on file until such time as the member makes a withdrawal of accumulated contributions or draws  
13 benefits. If such an order is on file as to a member, the Director may delay payment of benefits  
14 or of accumulated contributions for up to 30 days beyond the date payments would otherwise be  
15 made in order to determine whether or not the order is current and in effect.

17 responsibility of supplying and maintaining with the Director a current mailing address for  
18 making payments; if payments are to commence upon occurrence of an event, informing the  
19 Director when the event occurs; and in the event of an erroneous overpayment, returning such  
20 overpayment to the City ~~((the warrant or check))~~ for issuance of another payment in the correct  
21 amount. ~~((Warrants or checks))~~ Forms of payment returned on account of an incorrect address  
22 may be held as unclaimed property.

1 Section 40. Section 4.36.635 of the Seattle Municipal Code, last amended by Ordinance

4 Annuity payments funded by the member's accumulated contributions shall be paid to a retired

21 Section 42. Section 4.36.645 of the Seattle Municipal Code, last amended by Ordinance  
22 124574, is amended as follows:

3 ~~accidental,))~~ occurring while in City service upon examination as hereinafter set forth, if such  
4 employee meets either of the following requirements:

17 permanently and totally incapacitated, either physically or mentally, for the performance of duty  
18 in any position in City service and ought to be retired. If such medical examination shows, to the  
19 satisfaction of the Board, that the member is permanently and totally incapacitated either  
20 physically or mentally for the performance of duty in any position in City service and ought to be  
21 retired, the Board shall retire the member for disability forthwith.

1 C. The Board shall secure such medical services and advice as it may deem necessary to  
2 carry out the purpose of this ~~((section))~~ Section 4.36.645 and of Section 4.36.655, and shall pay  
3 for such medical services and advice such compensation as the Board shall deem reasonable.

6 Section 43. Section 4.36.650 of the Seattle Municipal Code, last amended by Ordinance  
7 124574, is amended as follows:

8 **4.36.650 Disability ~~((allowances))~~ benefits designated**

9 A. Upon retirement for disability, as provided in Section 4.36.645, provided the disability  
10 is not due to ~~((intemperance,))~~ willful misconduct or violation of law, of which the Board shall  
11 be the judge, a member shall receive a retirement ~~((allowance))~~ benefit calculated as follows:

12 For a member, making application for disability retirement after December 31, 2012,  
13 with less than ~~((10))~~ ten years of actual City service, but who otherwise qualifies for a disability  
14 retirement under the portability provisions of RCW 41.54.032, 1 1/2 percent of final  
15 compensation multiplied by years of creditable City service. For all other members with at least

6 cancelled. Should any such disability ((beneficiary)) retiree engage in a gainful occupation,  
7 ((he)) the retiree shall immediately report ((his)) gross monthly income to the Board and upon  
8 receipt of such information the Board shall reduce the ((retirement allowance)) disability benefit  
9 to an amount ((, which)) that, when added to the compensation earned ((by him)) in such

15 for the period of time necessary to make up for disability ((retirement allowance)) benefit  
16 payments drawn by ((him)) the person during the time suspension should have been in effect,  
17 and should such a ((beneficiary)) person die before suspended disability ((retirement allowance))  
18 benefit payments have equaled payments illegally drawn, the Board shall recover such payments

12 If, in the judgment of the Board, a disability ~~((beneficiary))~~ retiree has failed to properly  
13 report ~~((his))~~ earnings from gainful occupation, the Board may cancel ~~((his))~~ the retiree's  
14 disability ~~((retirement allowance))~~ benefit.

15 E. Should any disability ~~((beneficiary))~~ retiree, who was eligible to receive a ~~((service))~~  
16 retirement ~~((allowance))~~ benefit at the time ~~((he))~~ the person was retired for disability, desire to  
17 convert ~~((his))~~ disability ~~((retirement allowance))~~ benefit into the ~~((service))~~ retirement  
18 ~~((allowance))~~ benefit for which the person ~~((he))~~ was eligible ~~((to))~~ at time of retirement on  
19 disability, the Board may grant ~~((his))~~ the petition ~~((so))~~ to do so.

20 Section 45. Section 4.36.660 of the Seattle Municipal Code, last amended by Ordinance  
21 124574, is amended as follows:

1 **4.36.660 Temporary total disability**

2 A. Any member who has not attained the age of 65 and who also has at least ten years of  
3 City service over a period of not to exceed 15 years may, upon ~~((his))~~ the member's application  
4 therefor, be retired by the Board for temporary total disability occurring while in City service.  
5 Such temporary total disability shall include only a physical or mental incapacity which the  
6 Board finds and determines temporarily and totally incapacitates such member for the  
7 performance of duty in any position in City service.

8 B. Temporary total disability retirement ~~((allowances))~~ benefits shall be computed and  
9 paid until such disability has ceased, in the same manner and amounts as for permanent and total  
10 disability, and shall commence immediately after termination of all payments to the member on  
11 account of sick leave, vacation, accumulated time, industrial insurance benefits, and disability  
12 payments ~~((under Charter Article XVI, Section 24)),~~ or any other such benefits.

13 C. Upon determining that any such temporary total disability has ceased, the Board shall  
14 terminate the temporary total disability retirement, and the ~~((retirement allowance))~~ disability  
15 benefit therefor shall be cancelled; or if a member is otherwise eligible, the Board shall convert  
16 such temporary total disability ~~((retirement))~~ benefit to a permanent total disability ~~((retirement))~~  
17 benefit or a ~~((service))~~ retirement benefit.

18 D. In determining eligibility for temporary total disability retirement and termination  
19 thereof, the Board may secure such medical assistance as it deems necessary. The Board shall  
20 have the authority to require a medical re-examination of a member retired for temporary total  
21 disability at least once every 24 months following the effective date of the temporary total  
22 disability retirement until such time as the member has attained regular service retirement age,  
23 and at any time if there is reason to believe the temporary total disability has ceased.

1 E. Upon termination of any temporary total disability retirement, a member who returns  
2 to active City service shall be reinstated as a nonretired member of the retirement system and  
3 ((his)) the member's accumulated contributions less annuity payments shall be credited to ((his))  
4 the member's account and ((he)) the member shall contribute at the rate applicable to him at the  
5 time ((he)) the member was retired. Any member who does not return to City service after  
6 termination of temporary total disability retirement shall be entitled to ((his)) the member's  
7 accumulated contributions less any annuity payments made to ((him)) the member.

8 F. Periods during which a member is retired for temporary total disability shall not be  
9 recognized as creditable service on any subsequent retirement.

10 Section 46. Section 4.36.665 of the Seattle Municipal Code, last amended by Ordinance  
11 124574, is amended as follows:

12 **4.36.665 Discontinuance of eligible employee**

13 A. Should the City service of a member not eligible for retirement under the provisions of  
14 this chapter ((;)) be discontinued, except by death, prior to completion of five ((years<sup>2</sup>  
15 membership)) years of creditable service in the retirement system, ((he)) the member shall be  
16 paid ((six months after the date of discontinuance such part of his)) the member's accumulated  
17 contributions ((as he shall demand)) upon request ((; provided, however, that such member may  
18 apply to the Board and by unanimous vote the Board may grant a request for immediate  
19 withdrawal of contributions)). If in the opinion of the Board such member is permanently

3 ~~months after such termination))~~ to leave ~~((his))~~ the member's accumulated contributions in the  
4 retirement fund, and thereafter, upon reaching the required age and making application therefor,  
5 ~~((he))~~ the member shall receive a retirement ~~((allowance))~~ benefit as provided in Section  
6 4.36.600 ~~((€))~~ or 4.36.607; provided, that if discontinuance of City service is caused by  
7 ~~((intemperance, wilful))~~ willful misconduct or violation of law on the part of the member, of  
8 which the Board shall be the judge, the Board, in its discretion, may pay to the member, in one  
9 lump sum, ~~((his))~~ the member's accumulated contributions, in lieu of all other rights, privileges,

11 of all obligations of the City to such member, and upon receipt of such payment ~~((he))~~ the

13 B. Any member eligible for retirement under ~~((subsections 4.36.600.A and B))~~ Section  
14 4.36.600 or 4.36.607 whose City service has been discontinued, except by death, and any  
15 member whose City service has been discontinued and who has elected to leave ~~((his))~~ the  
16 member's accumulated contributions in the retirement fund, may, in the manner hereinabove  
17 provided, apply to the Board for withdrawal of contributions. ~~((, but in such case the Board may,~~  
18 ~~in its discretion, approve such request or disapprove the same and, if such member then be~~  
19 ~~eligible, authorize his retirement. Upon withdrawal of contributions the full amount deposited by~~  
20 ~~the City in the retirement fund for such member's benefit, plus interest, shall be available to meet~~  
21 ~~the obligations of the City under this chapter.))~~

1 Section 47. Section 4.36.670 of the Seattle Municipal Code, last amended by Ordinance  
2 124574, is amended as follows:

3 **4.36.670 Election to rollover to an eligible retirement plan**

4 ~~((1.))~~ A. This ~~((section))~~ Section 4.36.670 applies notwithstanding any contrary provision  
5 that would otherwise limit a distributee's ability to make a rollover election. A distributee may  
6 elect, at the time and in the manner prescribed under this ~~((chapter))~~ Chapter 4.36, to have any  
7 portion of an eligible rollover distribution paid directly to an eligible retirement plan specified by  
8 the distributee in a direct rollover.

9 ~~((2.))~~ B. The following definitions apply to this Section 4.36.670:

15 defined in ~~((Section 414(p) of the Internal Revenue Code))~~ Code § 414(p), are distributees with  
16 regard to the interest of the spouse or former spouse.

17 ~~((c.))~~ 3. "Eligible retirement plan" means an individual retirement account  
18 described in Code § 408(a), an individual retirement annuity described in Code § 408(b), an  
19 annuity plan described in Code § 403(a), a qualified trust described in Code § 401(a), an  
20 arrangement described in Code § 403(b), an eligible governmental deferred compensation plan  
21 described in Code § 457(b), or for distributions made after December 31, 2007, a Roth IRA  
22 described in Code § 408A(b).

1                    ~~((d.))~~ 4. “Eligible rollover distribution” means any distribution of all or any  
2 portion of the member’s benefits under this chapter, except: (a) any distribution which is one of a  
3 series of substantially equal periodic payments (not less frequently than annually) made for the  
4 life (or life expectancy) of the member or the joint lives (or joint life expectancies) of the  
5 member and the member’s Designated Beneficiary, or for a specified period of ten years or  
6 more; (b) any distribution to the extent required under Code § 401(a)(9); (c) the portion of any  
7 distribution which is not includible in gross income; (d) any hardship distribution; (e) a  
8 corrective distribution; (f) a deemed distribution resulting from a defaulted member loan which  
9 is not also an offset distribution; (g) any other distributions described in Treas. Reg. § 1.402(c)-2;  
10 and (h) as to a direct rollover, any distributions during that calendar year that are reasonably  
11 expected to total less than \$200.

13 (“IRA”) described in Code § 408(a) or an individual retirement annuity described in Code  
14 § 408(b), and, as the context requires, includes a Roth IRA or a Roth individual retirement

16                    ~~((3.))~~ C. ~~((Non-Spouse-Designated-Beneficiary-Direct-Rollover))~~ Non-spouse designated  
17 beneficiary direct rollover. For distributions made after December 31, 2006, a non-spouse  
18 designated beneficiary (including a trust which qualifies as a designated beneficiary), may, by  
19 direct rollover, roll over an eligible rollover distribution to an eligible retirement plan; provided  
20 that for this purpose, an eligible retirement plan is an individual retirement plan that the non-  
21 spouse designated beneficiary establishes for purposes of receiving the distribution and which is  
22 treated as an inherited IRA under Code § 408(d)(3)(C). If a ~~((non-Spouse-Designated~~

4 before 2010. Although a ~~((non-Spouse Designated Beneficiary))~~ non-spouse designated  
5 beneficiary may roll over directly a distribution as provided in this ~~((section))~~ Section 4.36.670,  
6 any distribution made prior to January 1, 2010, is not subject to the ~~((Direct Rollover))~~ direct  
7 rollover requirements of Code § 401(a)(31) (including Code § 401(a)(31)(B)), the notice  
8 requirements of Code § 402(f), or the mandatory withholding requirements of Code § 3405(c).

9 ~~((5.))~~ E. Effective January 1, 2006, in the event of a mandatory lump sum distribution in  
10 an amount greater than \$1,000, if the participant does not elect to have such distribution paid

12 the distribution directly, then such distribution shall be paid in a direct rollover to an individual  
13 retirement plan designated by the Board.

14 Section 48. Section 4.36.675 of the Seattle Municipal Code, last amended by Ordinance  
15 124574, is amended as follows:

17 A. Authority. The Board of Administration may in its discretion authorize an employee to  
18 discontinue ~~((his or her))~~ the employee's membership in the City Employee's Retirement System

20 interest thereon, if the employee makes written application therefor and all the conditions in

22 B. Conditions and ~~((Application))~~ application. The member's application shall be  
23 accompanied by the following documents:



1                   1. Competent medical evidence that the member is suffering from a terminal

3 death within two years, and the member's prospects of recovery or a longer life span are low;

4                   2. The member's acknowledgment that, by discontinuing ~~((his or her))~~

6 benefits under the system; for death benefits under Sections 4.36.690 ~~((—))~~ through 4.36.695;  
7 and for reentry into the system under Section 4.36.567 for one year, and then may reenter only  
8 with consent of the Board; that, if the member has a spouse or domestic partner, discontinuing  
9 membership will render ~~((his or her))~~ the member's spouse or domestic partner ineligible for  
10 spousal or domestic partner benefits upon a member's death or disability; and that refund of ~~((his~~  
11 ~~or her))~~ the member's contributions may result in withholdings, taxes, and penalties under the  
12 Internal Revenue Code; and

13                   3. If the member is married, a signed written consent of the member's spouse to  
14 ~~((his or her))~~ the member's discontinuance of membership and withdrawal of contributions,  
15 including an acknowledgment that discontinuing the employee's membership may forgo spousal  
16 benefits in event of the employee's death.

17                   C. Examination. The Board may require an applicant to undergo a physical examination  
18 by a physician selected by the Board and/or require the applicant to permit verification of ~~((his or~~  
19 ~~her))~~ the applicant's medical condition by allowing an examination of the applicant's medical  
20 records or an interview with ~~((his or her))~~ the applicant's doctor or caregiver.

21                   D. ~~((Reentry/Redeposit))~~ Reentry/redeposit. After the lapse of one year, the Board of  
22 Administration may in its discretion allow a member who has discontinued membership and  
23 recovers from ~~((his or her))~~ terminal illness to reenter the City Employee's Retirement System. If

1 the member's application is granted, the member upon commencement of making contributions  
2 to the retirement fund shall accrue service credit from the date of ~~((his or her))~~ reentry into the  
3 system, provided, that if the member's application for reentry occurs within three years after the  
4 date of the member's discontinuance of ~~((his or her))~~ membership, the Board may allow the  
5 member to make redeposit into the retirement fund of ~~((his or her))~~ the member's withdrawn  
6 contributions plus interest in the manner contemplated by Section 4.36.567, and, upon  
7 completing all such payments, thereby acquire creditable service for the earlier period.

8 E. Discretionary ~~((Determination))~~ determination. This ~~((section))~~ Section 4.36.675  
9 confers enabling authority on the Board to be exercised in extraordinary circumstances and it  
10 imposes no duty upon the Board to grant any particular application. The Board's decision upon  
11 an application shall be final.

12 Section 49. Section 4.36.680 of the Seattle Municipal Code, last amended by Ordinance  
13 124574, is amended as follows:

15 A. Distribution of benefits upon the death of a member who has been retired for service.

9 C. Distribution of benefits upon the death of a member who has not been retired.

10 1. Upon the death of any member who has not been retired, such member's  
11 accumulated contributions less any payments therefrom already made to such member shall be  
12 paid to such member's surviving spouse or domestic partner; or if the deceased member does not  
13 have a surviving spouse or domestic partner, or if the surviving spouse prior to the death of such  
14 member consented in writing to the naming as hereafter provided of a different beneficiary or  
15 beneficiaries and waived in writing all rights to benefits under this subsection 4.36.680.C, then to  
16 such member's estate, or to such person or persons as the member shall have nominated by  
17 written designation duly executed and filed with the Board.

18 ((+)) 2. Any surviving spouse or domestic partner, of a member not retired but  
19 having at the date of death at least ten years of creditable service as defined in this ((chapter))  
20 Chapter 4.36, who is entitled to receive such deceased member's accumulated contributions as  
21 provided in this subsection ((4.36.680.B)) 4.36.680.C, may elect to receive, ((and thereupon shall  
22 be paid)) in lieu of applicable benefits under subsection ((4.36.680.B)) 4.36.680.C.1, a benefit  
23 the equivalent of a survivor's "Option E" retirement ((allowance)) benefit based on the amount

1 payable if the member would have been eligible for this benefit based on age and years of  
2 creditable service at death. The spouse or domestic partner may, however, elect to receive in lieu  
3 of either the above retirement ((allowance)) benefit or the benefits under subsection  
4 ((4.36.680.B)) 4.36.680.C.1, a ((lesser)) reduced monthly retirement ((allowance)) benefit to

8 ((3.)) 2. The amount paid to a member's estate, beneficiary, or surviving spouse  
9 or domestic partner may be reduced by payments made to an alternate payee under a court or  
10 department order as contemplated by Section 4.36.630.

11 ((4.)) 3. If the member's estate is not being probated, the Board, in its discretion,  
12 may as an alternative to making payment to ((his or her)) the estate ((,)) authorize payment to an  
13 heir who would inherit if the estate were probated, such as a surviving spouse named under a  
14 community property agreement or in the member's will.

15 Section 50. Section 4.36.690 of the Seattle Municipal Code, last amended by Ordinance  
16 124574, is amended as follows:

17 **4.36.690 Death benefits—Payment**

18 A. Upon proof of the death of a member of the retirement system who has paid all death  
19 benefit assessments as hereinafter provided, the sum of \$2,000 as a death benefit shall be paid to  
20 such member's surviving spouse or domestic partner; or if such deceased member does not have  
21 a surviving spouse or domestic partner, or if the surviving spouse prior to the death of such  
22 member consented in writing to the naming as hereinafter provided of a different beneficiary or  
23 beneficiaries, then to such member's estate or to such person or persons as such member shall

1 have nominated by written designation duly executed and filed with the Board. If the member's  
2 estate is not being probated, the Board, in its discretion, may as an alternative to making payment  
3 to ~~((his or her))~~ the member's estate ((;)) authorize payment to an heir who would inherit if the  
4 estate were probated, such as a surviving spouse named under a community property agreement  
5 or in the member's will.

6 B. Any member of the retirement system may elect to continue ~~((in the))~~ eligibility for a  
7 death benefit ~~((system and pay))~~ by paying the death benefit assessments: provided, that such  
8 payment shall not be required of a member retiring for disability ~~((until age 60, whereupon such~~  
9 ~~member shall be required to pay all death benefit assessments thereafter accruing if he or she~~  
10 ~~desires to continue in the death benefit system))~~. Upon proof of the death of such member, the  
11 payment shall be \$2,000.

12 Section 52. Section 4.36.695 of the Seattle Municipal Code, last amended by Ordinance  
13 124574, is amended as follows:

14 **4.36.695 Death benefits—Specifications**

15 A. All moneys paid into or out of the retirement fund on account of ~~((the))~~ death benefit  
16 ~~((system))~~ shall be accounted for by double entry separately in the records of the retirement  
17 system in such a manner as to reveal currently the amount of money held for payment of death  
18 benefits.

19 B. Death benefit assessments shall become due and payable January ~~((1st))~~ 1 of each year  
20 and collectible by payroll deduction or otherwise as directed by the Board. In order to insure  
21 coverage of members laid off or on leave of absence or on family or medical leave under Chapter  
22 4.26, the Board is authorized to transfer amounts necessary to pay assessments due from such  
23 members from their normal contributions as temporary loans to be repaid by such members on

1 return to City service. Death benefit assessments shall be in such amount as shall be determined  
2 by the Board but shall not exceed the sum of \$12 in any calendar year.

3 C. An employee becoming a member of the system during the year shall pay the death  
4 benefit assessment fixed for that year if such membership is effective prior to October ~~((1st))~~ 1,  
5 which assessment shall be collectible by payroll deduction when the first normal contribution is  
6 made. Employees becoming members in October, November, ~~((and))~~ or December shall pay  
7 only 1/2 of that annual assessment.

8 D. The City shall match all death benefit assessments collected from members and such  
9 matching payments shall become due and payable immediately following determination of the  
10 amount necessary, and should ~~((the))~~ death benefit ~~((system))~~ amount require payments by the  
11 City of more than the amount necessary to match an assessment of not to exceed \$12, as  
12 determined by the Board on advice of its actuary, the same may be made from undivided  
13 earnings of the City and the ~~((employee))~~ member in the retirement fund is not otherwise  
14 obligated. All payments by the City shall be due and payable annually on January ~~((1st))~~ 1.  
15 Assessments collected from retired members shall be matched by funds from departments from  
16 which such members retired.

17 E. Membership ~~((in the))~~ eligibility regarding death ~~((benefit system))~~ benefits shall  
18 terminate when any member resigns, quits, or is discharged and no refund of any portion of death  
19 benefit assessments shall be made by reason thereof. Should the Board determine that a member  
20 of the retirement system not in City service was maintaining membership for the sole purpose of  
21 possibly receiving retirement benefits in the future, the Board shall deny ~~((participation in the))~~  
22 death ~~((benefit system))~~ benefits to such member.

1 F. The Board of Administration shall make all rules and regulations necessary to  
2 supplement the death benefit provisions of this ((chapter)) Chapter 4.36.

3 Section 52. Section 4.36.705 of the Seattle Municipal Code, last amended by Ordinance  
4 124574, is amended as follows:

5 **4.36.705 Trust fund**

6 A. The retirement fund shall be a trust fund for the exclusive benefit of the members of  
7 the City Employees' Retirement System and their beneficiaries. No part of the corpus or income  
8 of the retirement fund shall be used for, or diverted to, purposes other than for the exclusive  
9 benefit of the members of the system or their beneficiaries and the payment of fees and expenses  
10 of maintaining and administering the system.

11 B. This ((section)) Section 4.36.705 shall be interpreted to allow the following:

12 1. A return of a contribution to the City within one year after the payment of the  
13 contribution or, alternatively, its application as a credit on future contributions, after the Board  
14 determines that the City has paid or overpaid the contribution under a mistake of fact, excluding,  
15 however, any interest earnings on such mistaken contributions and deducting any losses;

16 2. The making of refunds required by law; and

17 3. Termination of the retirement system and distribution of its assets after all  
18 liabilities with respect to the members of the retirement system and their beneficiaries have been  
19 satisfied.

20 C. The Board in its discretion may authorize trust-to-trust transfers of assets from the  
21 retirement fund to another retirement trust fund to the extent the Board determines that  
22 contributions received by the retirement fund should be credited to another retirement trust fund.



1 Section 53. Section 4.36.710 of the Seattle Municipal Code, last amended by Ordinance  
2 124574, is amended as follows:

3 **4.36.710 Status of benefits in event of termination of system**

4 If the City terminates or partially terminates the retirement system, members shall have a  
5 nonforfeitable right to benefits accrued prior to the date of such termination or partial  
6 terminations to the extent funded as of that date, or the amounts credited to the employees'  
7 accounts. As used in this ~~((section))~~ Section 4.36.710, "terminate" means to discontinue the  
8 system completely without a comparable replacement plan; "partially terminate" means to  
9 exclude a segment of employees from coverage without the provision of a comparable  
10 replacement; and "nonforfeitable" means that a member's or beneficiary's right to an immediate  
11 or deferred benefit that arises from the member's City service is unconditional and legally  
12 enforceable against the retirement system to the extent then accrued, except that rights to a  
13 benefit based upon the City's contribution and completion of a minimum term of City service  
14 may be lost by death of the member before the term has expired.

15 Section 54. Section 4.36.715 of the Seattle Municipal Code, last amended by Ordinance  
16 124574, is amended as follows:

17 **4.36.715 Compliance with Internal Revenue Code**

18 A. In ~~((General))~~ general. This ~~((chapter))~~ Chapter 4.36 shall be administered in a manner  
19 to comply with the applicable requirements of 26 U.S.C. ~~((Section))~~ § 401(a), and the Board is  
20 authorized to promulgate rules as it deems necessary to effectuate such compliance.

21 B. Compliance with Code § 401(a)(2) – Exclusive ~~((Benefit))~~ benefit. See Section  
22 4.36.705.

1 C. Compliance with Code § 401(a)(9) – ~~((Required Minimum Distributions))~~ required  
2 minimum distributions

3 1. The requirements of this ~~((section))~~ Section 4.36.715 will take precedence over  
4 any inconsistent provisions of this ~~((chapter))~~ Chapter 4.36.

5 2. All benefits and distributions required under this ~~((section))~~ Section 4.36.715  
6 will be determined and paid in accordance with a reasonable and good faith interpretation of the  
7 requirements of Code § 401(a)(9) and the regulations thereunder, as applicable to a governmental  
8 plan within the meaning of Code § 414(d).

9 3. Distributions to a member and ~~((his or her))~~ the member's beneficiaries under  
10 this ~~((section))~~ Section 4.36.715 shall only be made in accordance with the incidental death  
11 benefit requirements of IRC § 401(a)(9)(G) and the Treasury Regulations thereunder.

12 4. The Board will begin distributions of a member's retirement benefits under this  
13 ~~((chapter))~~ Chapter 4.36 no later than the member's "required beginning date." A member's  
14 "required beginning date" is the later of the April ~~((1st))~~ 1 following the close of the calendar  
15 year in which the member leaves City employment or ~~((5))~~ the April ~~((1st))~~ 1 following the close  
16 of the calendar year in which the member attains the age of 70 1/2.

17 5. If the member dies before distributions begin, the member's retirement benefits  
18 must begin to be distributed, no later than as follows:

19 i. If the member's surviving spouse is the member's sole designated  
20 beneficiary, then distributions to the surviving spouse will begin by December 31 of the calendar  
21 year immediately following the calendar year in which the member died, or by December 31 of  
22 the calendar year in which the member would have attained age 70 1/2, if later.

1                   ii. If the member's surviving spouse is not the member's sole designated  
2 beneficiary, then distributions to the designated beneficiary will begin by December 31 of the  
3 calendar year immediately following the calendar year in which the member died.

4                   iii. If there is no designated beneficiary as of September 30 of the year  
5 following the year of the member's death, the member's entire interest will be distributed by  
6 December 31 of the calendar year containing the fifth anniversary of the member's death.

7                   iv. If the member's surviving spouse is the member's sole designated  
8 beneficiary and the surviving spouse dies after the member but before distributions to the  
9 surviving spouse begin, this ((subparagraph)) subsection 4.36.715.C.5.iv (rather than  
10 ((subparagraph)) subsection 4.36.715.C.5.i ((above))) will apply as if the surviving spouse were  
11 the member. For purposes of this subsection 4.36.715.C.5, unless this ((subparagraph))  
12 subsection 4.36.715.C.5.iv applies, distributions are considered to begin on the member's  
13 required beginning date. If this ((subparagraph)) subsection 4.36.715.C.5.iv applies, distributions  
14 are considered to begin on the date distributions are required to begin to the surviving spouse  
15 under ((subparagraph)) subsection 4.36.715.C.5.i ((above)). If distributions under an annuity  
16 purchased from an insurance company irrevocably commence to the member before the  
17 member's required beginning date or to the member's surviving spouse before the date  
18 distributions are required to begin to the surviving spouse, the date distributions are considered  
19 to begin is the date distributions actually commence.

20                   If the member's interest is distributed in the form of an annuity purchased from an  
21 insurance company, distributions thereunder will be made in accordance with the requirements  
22 of Code § 401(a)(9) and the Treasury Regulations thereunder.

1 D. Compliance with Code § 401(a)(17) – Compensation (~~(Limit)~~) limit. The  
2 compensation limit is addressed under the definition of “Compensation” in Section 4.36.040.

3 E. Compliance with Code § 401(a)(31) – Eligible (~~(Rollover Distributions)~~) rollover  
4 distributions. See Section 4.36.670.

5 F. Compliance with Code § 414(p) – Qualified Domestic Relations Orders (QDRO). The  
6 treatment of QDROs under this (~~(chapter)~~) Chapter 4.36 is described under Section 4.36.630.

7 G. Compliance with Code § 415. See subsection 4.36.640.A.

8 H. Compliance with the Uniformed Services Employment and Reemployment Rights Act  
9 of 1994 (USERRA) and the Heroes Earnings Assistance and Relief Tax Act of 2008 (HEART  
10 Act)

11 1. HEART Act Death Benefits. In the case of a death occurring on or after  
12 January 1, 2007, if a member dies while performing qualified military service (as defined in  
13 Code § 414(u)(5)), the member’s beneficiary is entitled to any additional benefits (other than  
14 benefit accruals relating to the period of qualified military service) provided under this  
15 (~~(chapter)~~) Chapter 4.36 as if the member had resumed employment and then terminated  
16 employment on account of death. Moreover, the member’s qualified military service will count  
17 as service for vesting purposes, as though the member had resumed employment under USERRA  
18 immediately prior to the member’s death.

19 2. Effective January 1, 2009, to the extent required by Code §§ 414(u)(12) and  
20 3401(h), any member receiving a differential wage payment (as defined under Code  
21 § 3401(h)(2)) from an employer will be treated as employed by that employer, and the  
22 differential wage payment will be treated as compensation for purposes of applying the limits on

1 annual additions under Code § 415(c). This provision shall be applied to all similarly situated  
2 individuals in a reasonably equivalent manner.

3 Section 55. Section 4.36.720 of the Seattle Municipal Code, last amended by Ordinance  
4 124574, is amended as follows:

5 **4.36.720 Administration of chapter—Construction—Severability**

6 A. The retirement plan created by this ((chapter)) Chapter 4.36 shall be administered  
7 so as to comply with the federal Internal Revenue Code, Title 26 U.S.C., where applicable, and  
8 specifically with plan qualification requirements imposed on governmental plans by Section  
9 401(a) of the Internal Revenue Code.

10 B. Any section or provision of this ((chapter)) Chapter 4.36 which may be  
11 susceptible to more than one construction shall be interpreted in favor of the construction most  
12 likely to satisfy requirements imposed on governmental plans by Section 401(a) of the Internal  
13 Revenue Code.

14 C. If any section or provision of this ((chapter)) Chapter 4.36 is found to be in  
15 conflict with the plan qualification requirements for governmental plans in Section 401(a) of the  
16 Internal Revenue Code, the conflicting part of this ((chapter)) Chapter 4.36 is hereby inoperative  
17 solely to the extent of the conflict, and such finding shall not affect the operation of the  
18 remainder of this ((chapter)) Chapter 4.36.

19 Section 56. Section 4.36.900 of the Seattle Municipal Code, last amended by Ordinance  
20 124574, is amended as follows:

21 **4.36.900 Outdated provisions**

22 The following provisions no longer apply to current or possible future members of the  
23 system, or involve benefits already conferred on existing members. These provisions remain in

1 effect only to the extent necessary to determine already conferred benefits and for purposes of  
2 compliance with requirements of the Internal Revenue Code. None of these provisions is  
3 effective with respect to current or future members of the retirement system as of ~~((the effective~~  
4 ~~date of this Ordinance, introduced as Council Bill 118199))~~ October 19, 2014. References to  
5 enacting and amending ordinances follow each provision.

6 A. Former subsection 4.36.103.E which reads as follows:

7 “Coverage and Exclusions. This section extends to workers in active City service on or  
8 after January 1, 1989. Workers in active City service in temporary, interim, intermittent, and  
9 part-time positions of less than twenty (20) hours per week, who have exceeded the hours in  
10 Section 4.36.103 A3 on the effective date of Ordinance 114592 shall have six (6) months  
11 thereafter to acquire service credit for prior service in such positions. This section and Section  
12 4.36.195 provide the exclusive methods for temporary, interim, intermittent, provisional workers  
13 or workers in part-time positions of less than twenty (20) hours per week over a one (1) year  
14 period to become members of the retirement system.”

1 completion of six (6) months' continuous service, as follows, except that six (6) months'  
2 continuous service shall not be required for officers and employees to whom subsection L of this  
3 section applies:

4 A. Mandatory Membership. Every officer or employee of the City and of the Seattle  
5 Public Library, who enters City service on or after June 21, 1986, shall become a member of the  
6 retirement system upon completion of six (6) months' continuous service, except:

- 7 1. Elective officials exempt under subsection D of this section;
- 8 2. Individuals with a statutory right to continuation of their membership in a  
9 Washington State or federal government retirement system under subsection E of this section;
- 10 3. Certain officers in positions exempt from civil service under subsections C and  
11 F of this section;
- 12 4. Employees who are excluded under subsection H4 of this section; and
- 13 5. Temporary, interim, intermittent, provisional and part-time workers under  
14 Sections 4.36.103 and 4.36.195."

23 form with the Board of Administration on or before December 31, 1986, ("Option (1)"), or (2)

1 after the effective date of this ordinance may elect to join or rejoin the retirement system as  
2 authorized by subsection E of Section 4.36.535 (“Option (2)”). Option (1) also extended to  
3 officers and employees, who held such position before June 21, 1986, and on or before  
4 December 31, 1986, with respect to such a position (a) were recalled from a layoff status; (b)  
5 returned from an approved leave; or (c) completed six (6) months’ continuous City service. An  
6 officer or employee within Option (1) could, on or before December 31, 1986, contract for credit  
7 for “prior service” (creditable service before December 31, 1986) in the retirement system in  
8 accord with subsection A of Section 4.36.567.”

16 introduced as Council Bills 114257, 114258, or 114313 may purchase up to four (4) years of  
17 service credit from the Retirement System. To acquire such service credit:

18 1. The member shall, within fourteen (14) days of payment of the net proceeds of  
19 the separation incentive payment, pay a lump sum into the retirement fund representing the  
20 employee’s and the employer’s contributions otherwise required to receive such service credit  
21 pursuant to Seattle Municipal Code Chapter 4.36; and

22 2. The member may include in this lump sum additional personal resources to the  
23 extent permitted by law in order to purchase the full four (4) years of service credit. Direct



1 transfers and other rollovers of funds from other retirement plans under Municipal Code Section  
2 4.36.585 must be made prior to the member's separation from City employment."

10 who was retired for service or disability prior to January 1, 1974, shall be increased as of January  
11 1, 1975, by the percentage indicated in the following table opposite the year of retirement of the  
12 member upon whose service such benefits are based:

1 F. Subsection 4.36.191. B. C and D, which read as follows:

2 "One year window for purchase of creditable service for initial six months of City service  
3 for employees hired during 1988 through 1998 period

4 1. During a window period of one (1) year, beginning on the effective date of  
5 this section, employees who were hired during the period 1988 through 1998 who have not  
6 purchased creditable service for the initial six (6) months of City employment may purchase said  
7 creditable service by paying the purchase price, as determined by the Board, into the retirement  
8 fund, or signing a creditable service purchase contract pursuant to Subsection 4.36.567 C and  
9 filing it with the Retirement Board. The creditable service may be purchased based on the  
10 following price formula:

11 Current City Employees

12 (current hourly rate) × (current member contribution rate) × (amount of hours to be  
13 purchased).

14 Former City Employees

15 (final hourly rate as determined by the Board and adjusted for inflation) × (contribution  
16 rate in effect for new members as of effective date of Section 4.36.570) × (amount of hours to be  
17 purchased).

18 2. Purchases by former city employees made pursuant to Subsection 4.36.900 F.1  
19 must be paid in full by lump sum payment by the end of the window period established in said  
20 subsection or the date of retirement, whichever occurs first.

21 3. City Matching Contributions under Subsection 4.36.900 F.1. As matching  
22 contributions pursuant to Subsection 4.36.540 A, each year the employing department shall pay  
23 into the retirement fund the matching amount equivalent to any member lump sum payment

1 made pursuant to this section or, if a member purchased pursuant to a contract under Subsection  
2 4.36.567 C, the member's current year buy back payments all as billed by the Retirement office."

3 (Ord. 121365 § 6, 2003; Ord. 120684 § 6, 2001.)

4 G. Subsection 4.36.196, which reads as follows:

5 "Special option for purchase of creditable service by employees of the Seattle  
6 Firefighter's Pension Fund hired prior to January 1, 2007.

7 1. An officer or employee of the Seattle Firefighter's Pension Fund who was  
8 hired as an employee or officer thereof on or before the effective date of this Ordinance and who  
9 thereafter becomes and continues his or her service as an employee of the City may elect to join  
10 the City's retirement system and contract to purchase credit for prior service performed for the  
11 Seattle Firefighter's Pension Board by completing and filing an election form with the Board,  
12 and paying the purchase price, as determined by the Board, into the retirement fund on or before  
13 thirty days after the effective date of this ordinance. The creditable service may be purchased  
14 based on the following price formula:

15 (hourly rate) × (current member contribution rate (8.03% × (amount of hours to be  
16 purchased) × (interest factor as calculated below).

17 Creditable service shall be based on the employee's or officer's actual hours and salary in  
18 the period of time going back no more that 10 years from the effective date of this ordinance.  
19 The interest factor applied to the purchase price will be determined by approximating the net  
20 investment returns of the retirement fund that occurred during the period of time that relates to  
21 the buyback, with a minimum interest factor no less than the actuarially assumed rate of  
22 investment return for the same periods. The purchase price shall be calculated using an  
23 annualized interest rate, compounded bi-weekly. Notwithstanding the above purchase price

1 interest factor, the amount credited to the individual member accounts will be calculated by  
2 applying an interest rate 5.75% to approximate what the creditable amount would have been had  
3 the individual been a contributing member of the retirement system all along. Only the amount  
4 credited to the individual member accounts will be included in any benefit calculation or any  
5 future withdrawal.

6           2. An officer or employee subject to this section who fails to exercise his or her  
7 option under this subsection on or before thirty days after the effective date of this ordinance,  
8 may not thereafter purchase such credit provided, however, that nothing in this section shall  
9 affect such an officer or employee's right to elect to join the retirement system or to purchase  
10 creditable service earned subsequent to the effective date of this ordinance or at any time  
11 thereafter in the manner provided under Section 4.36.525 E of the Seattle Municipal Code.

12           3. The Seattle Firefighter's Pension Fund shall pay into the retirement fund the  
13 matching amount equivalent to any member lump sum payment made pursuant to this Section."

14           (Ord. 122591, § 4, 2007.)

15           H. Subsection 4.36.230.B, which reads as follows:

16           "The disability allowances of all members retired for disability prior to January 1, 1971,  
17 shall on January 1, 1971, be increased by Twenty Dollars (\$20) per month over the monthly  
18 benefit payable immediately prior to January 1, 1971, but no such pension of members retired for  
19 disability shall be less than One Hundred Forty Dollars (\$140) per month as of such date.

20 Nothing in this subsection shall affect the amount of any bonus dividend declared pursuant to  
21 Section 4.36.900 E. Such increases shall be paid from available retirement system funds or from  
22 contributions of the City; provided, that such increases shall not be applicable to persons retired  
23 for disability on and after September 1, 1970 and on and before December 31, 1970 who

1 pursuant to Ordinance 99271 select benefits applicable to persons who retire on and after January  
2 1, 1971.”

11 purchase creditable service after termination of City employment.

12 B. The creditable service purchase provisions established by Council Bill 113988,  
13 Ordinance 120684, shall be available to said employees until December 31, 2002 except for the  
14 purchase provisions of Section 4.36.191(B) which shall be available to said employees during  
15 the entire window period described therein.


16 C. Creditable service purchased pursuant to this Section must be paid in full by lump sum  
17 payment by the earlier of December 31, 2002, or by the date of retirement except purchases  
18 made pursuant to 4.36.191(B). Purchases made pursuant to 4.36.191(B) must be paid in full by  
19 lump sum payment by the end of the window period established in said subsection or the date of  
20 retirement, whichever occurs first.”


