1. BILL SUMMARY

Legislation Title:

A RESOLUTION relating to the Equitable Development Implementation Plan and Equitable Development Financial Investment Strategy; voicing support for certain community-initiated projects contained in the Plan and identifying next steps for implementation of those projects.

Summary and background of the Legislation:

This Resolution responds to the Equitable Development Implementation Plan (EDIP) and the Equitable Development Financial Investment Strategy (EDFIS). The Resolution voices Council support for the six community-identified projects included in the EDIP and asks the Office of Planning and Community Development and the City Budget Office to work with community groups in South Seattle, the Central Area and the Chinatown/International District to identify funds and resources to implement those projects. The Resolution asks OPCD to report annually on the projects identified in the EDIP. Finally, it asks the Office of Planning and Development to work with other communities with low access to opportunity and high risk of displacement to identify strategies to support jobs and economic development and reduce the threat of displacement in those communities.
