CB 119310 - Clarifying Immunity from Liability for Certain Deferred

Compensation Plan Investment Options

The Executive has proposed Council Bill (CB) 119310, which would clarify the protection provided to the City and other entities from liability for investment losses that Voluntary Deferred Compensation Plan participants may experience.

Background

The City of Seattle Voluntary Deferred Compensation Plan and Trust is a 457(b) deferred compensation plan offered as an optional benefit to City employees. Participants may contribute a portion of their salary into an individual retirement savings account on a pre- or post-tax basis. The Plan is administered by a Trust Committee (or "Plan Committee") subject to the provisions of a Plan Document. There are a range of investment options available to Plan participants. The investment options available at any given point in time are selected by the Trust Committee.

Socially responsible funds are structured to target investments expected to support desirable non-financial outcomes, avoid investments expected to produce disfavored outcomes, or both. While such funds will not necessarily achieve lower returns than conventional alternatives over a given period, they have more complex directives than funds whose sole goal is to maximize the monetary return on investments.

Summary of Bill

CB 119310 would amend Section 2.5 of the Plan Document to clarify existing immunity to associated parties (including the City, the Trustee, the Plan Committee, the third-party administrator, among others) from liability related to offering investment options that may

provide a lower rate of return but are considered more socially responsible. There is no direct fiscal impact to the City associated with this legislation. cc: Kirstan Arestad, Central Staff Executive Director Dan Eder, Central Staff Deputy Director
