The Seattle City Council's Sustainability and Transportation Committee, chaired by

Councilmember Mike O'Brien, will conduct a public hearing at the Seattle University Student Center on Tuesday, May 16, 2017, to solicit public comment on Council Bill 118963, regarding proposed legislation clarifying that a land use decision to waive or modify structure width or setbacks for a youth services center is a Type II decision that may be appealed to the City Hearing Examiner.

This legislation would add decisions to waive or modify structure width and setback development standards for youth service centers to the list of Type II decisions in Seattle Municipal Code 23.76.006 that are subject to appeal to the Hearing Examiner. This amendment would clarify that Master Use Permit decisions to waive or modify structure width or setback development standards and any associated SEPA decisions are Type II decisions that are subject to an administrative appeal to the Hearing Examiner. The bill would also make that change retroactive to April 1, 2017, the effective date of Ordinance 124610.

The hearing will begin at 6:00 p.m. and will continue until all in-person comments have been received. Individual comments will be limited to two (2) minutes or less.

Those wishing to provide public comment at the public hearings must sign-up on sheets provided at the public hearing. The sign-up sheets will be available starting at 5:30 p.m.
