NOTICE OF A SEATTLE CITY COUNCIL PUBLIC HEARING REGARDING THE INTERIM EXPANSION OF THE PIKE PLACE MARKET HISTORIC DISTRICT TO INCLUDE THE SHOWBOX THEATER

On August 13, 2018, the Seattle City Council adopted Council Bill 119330/Ordinance 125650, which expanded the Pike Place Market Historical District to include the Showbox Theater for ten months. The Ordinance was adopted to study whether to permanently expand the District to include the Showbox Theater. The Ordinance is authorized by RCW 36.70A.390.
