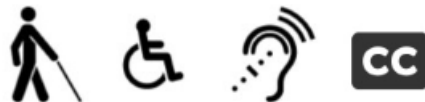

The Seattle City Council is considering legislation to amend Seattle's land use and zoning code and Comprehensive Plan to rezone property and apply Mandatory Housing Affordability (MHA) requirements in:

- existing multifamily and commercial zones in Seattle;
- areas currently zoned Single Family in existing urban villages; and
- areas zoned Single Family within expanded urban village boundaries.

The City Council's Select Committee on Mandatory Housing Affordability (MHA) will hold a public hearing on these proposed changes as proposed in Council Bill Nos. 119443, 119444, and 119445, and further potential changes as described in Land Use Information Bulletin

For those who wish to speak or provide public comment, sign-up sheets will be available starting at 5:00 p.m. The hearings will continue until all in-person comments have been received. Members of groups, organizations, or coalitions with similar interests are encouraged to combine their presentations. Group presentations with four (4) or more people will be limited to up to five (5) minutes to comment on all three items. Individual comments will be limited up to two (2) minutes to comment on all three items.
