Notice of Seattle City Council Public Hearing on 2023 General Revenue Sources & Mayor's 2023 and 2024 Proposed Budgets Tuesday, October 11, 2022, at 5:00 p.m.

The Seattle City Council's Select Budget Committee, chaired by Councilmember Teresa Mosqueda, will conduct a public hearing on Tuesday, October 11, 2022, to solicit public comment on the following: (1) the City's 2023 General Revenue Sources, including a possible property tax levy increase; and (2) the Mayor's 2023 and 2024 Proposed Budgets and 2022-2027 Capital Improvement Program.

The hearing will be held at Seattle City Hall, Council Chambers (600 4th Avenue Seattle, WA 98104), beginning at 5:00 p.m., and will continue until all those registered and present to provide public comment have participated. The hearing will include an opportunity for remote and in-person participation. Individual comments will be limited to two minutes or less.

This hearing will also be cablecast live on Seattle Channel 21 and webcast live at <u>https://www.seattle.gov/council/watch-council-live</u>.
