4 5 6 7 8 9	AN ORDINANCE relating to historic preservation; imposing controls upon 802 16th Avenue, a landmark designated by the Landmarks Preservation Board under Chapter 25.12 of the Seattle Municipal Code, and adding it to the Table of Historical Landmarks contained in Chapter 25.32 of the Seattle Municipal Code.
10	WHEREAS, the Landmarks Preservation Ordinance, Chapter 25.12 of the Seattle Municipal
11	Code (SMC), establishes a procedure for the designation and preservation of sites,
12	improvements, and objects having historical, cultural, architectural, engineering, or
13	geographic significance; and
14	WHEREAS, the Landmarks Preservation Board ("Board"), after a public meeting on January 20,
15	2021, voted to approve the nomination of the improvement located at 802 16th Avenue
16	and the site on which the improvement is located (which are collectively referred to as
17	"802 16th Avenue") for designation as a landmark under SMC Chapter 25.12; and
18	WHEREAS, after a public meeting on March 17, 2021, the Board voted to approve the
19	designation of 802 16th Avenue under SMC Chapter 25.12; and
20	WHEREAS, on May 19, 2021, the Board and 802 16th Avenue's owner agreed to controls and
21	incentives to be applied to specific features or characteristics of the designated landmark;
22	and
23	WHEREAS, the Board recommends that the City Council enact a designating ordinance
24	approving the controls and incentives; NOW, THEREFORE,
25	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
26	Section 1. Designation. Under Seattle Municipal Code (SMC) 25.12.660, the designation
27	by the Landmarks Preservation Board ("Board") of the improvement located at 802 16th Avenue

1	and the site on which the improvement is located (which are collectively referred to as "802 16th
2	Avenue") is acknowledged.
3	A. Legal Description. 802 16th Avenue is located on the property legally described as:
4 5 6	Lot 1, Block 23, Supplementary Plat of Edes & Knight Addition to the City of Seattle, according to the plat thereof recorded in Volume 2, Page 194 in King County, Washington.
7	B. Specific Features or Characteristics Designated. Under SMC 25.12.660.A.2, the Board
8	designated the following specific features or characteristics of 802 16th Avenue:
9	1. The site.
10	2. The exterior of the house (including the stained glass windows).
11	C. Basis of Designation. The designation was made because 802 16th Avenue is more
12	than 25 years old; has significant character, interest, or value as a part of the development,
13	heritage, or cultural characteristics of the City, state, or nation; has integrity or the ability to
14	convey its significance; and satisfies the following SMC 25.12.350 provisions:
15	1. It is associated in a significant way with a significant aspect of the cultural,
16	political, or economic heritage of the community, City, state or nation (SMC 25.12.350.C).
17	2. It embodies the distinctive visible characteristics of an architectural style, or
18	period, or of a method of construction (SMC 25.12.350.D).
19	3. It is an outstanding work of a designer or builder (SMC 25.12.350.E).
20	Section 2. Controls. The following controls are imposed on the features or characteristics
21	of 802 16th Avenue that were designated by the Board for preservation:
22	A. Certificate of Approval Process.
23	1. Except as provided in subsection 2.A.2 or subsection 2.B of this ordinance, the
24	owner must obtain a Certificate of Approval issued by the Board according to SMC Chapter
25	25.12, or the time for denying a Certificate of Approval must have expired, before the owner



1	may make alterations or significant changes to the features or characteristics of 802 16th Avenue
2	that were designated by the Board for preservation.
3	2. No Certificate of Approval is required for the following:
4	a. Any in-kind maintenance or repairs of the features or characteristics of
5	802 16th Avenue that were designated by the Board for preservation.
6	b. Removal of trees that are not included in any of the following
7	categories:
8	1) Significant to the property's history or design, as outlined in the
9	nomination application.
10	2) A designated Heritage Tree on the City of Seattle/Plant
11	Amnesty list.
12	3) An Exceptional Tree per City of Seattle regulations.
13	c. Planting of new trees in locations that will never obscure the view of
14	designated features of the landmark, nor physically undermine a built feature of the landmark.
15	d. Planting or removal of shrubs, perennials, or annuals, in locations that
16	will never obscure the view of designated features of the landmark, nor physically undermine a
17	built feature of the landmark.
18	e. Installation, removal, or alteration (including repair) of underground
19	irrigation and underground utilities, provided that the site is restored in kind.
20	f. Installation, removal, or alteration of the following site furnishings:
21	benches, chairs, tables, swings, movable planters, and trash/recycling receptacles.
22	g. Installation or removal of interior, temporary window shading devices
23	that are operable and do not obscure the glazing when in the open position.

1	B. City Historic Preservation Officer (CHPO) Approval Process.
2	1. The CHPO may review and approve alterations or significant changes to the
3	features or characteristics listed in subsection 2.B.3 of this ordinance according to the following
4	procedure:
5	a. The owner shall submit to the CHPO a written request for the alterations
6	or significant changes, including applicable drawings or specifications.
7	b. If the CHPO, upon examination of submitted plans and specifications,
8	determines that the alterations or significant changes are consistent with the purposes of SMC
9	Chapter 25.12, the CHPO shall approve the alterations or significant changes without further
10	action by the Board.
11	2. If the CHPO does not approve the alterations or significant changes, the owner
12	may submit revised materials to the CHPO, or apply to the Board for a Certificate of Approval
13	under SMC Chapter 25.12. The CHPO shall transmit a written decision on the owner's request to
14	the owner within 14 days of receipt of the request. Failure of the CHPO to timely transmit a
15	written decision constitutes approval of the request.
16	3. CHPO approval of alterations or significant changes to the features or
17	characteristics of 802 16th Avenue that were designated by the Board for preservation is
18	available for the following:
19	a. The installation, removal, or alteration of ducts, conduits, HVAC vents,
20	grills, pipes, panels, weatherheads, wiring, meters, utility connections, downspouts and gutters,
21	or other similar mechanical, electrical, and telecommunication elements necessary for the normal
22	operation of the building or site.

1	b. Removal of trees more than 6 inches in diameter measured 4-1/2 feet
2	above ground, when identified as a hazard by an International Society of Arboriculture (ISA)
3	Certified Arborist, and not already excluded from review in subsection 2.A.2.b of this ordinance.
4	c. Installation, removal, or alteration of exterior light fixtures, exterior
5	security lighting, and security system equipment. If proposed equipment is similar in size and
6	location to existing, staff may be able to determine it to be in-kind maintenance, provided the
7	fixture or equipment does not obscure designated features and is attached to a material that is
8	easily repairable.
9	d. Installation, removal, or alteration of exterior building and site signage.
10	e. Installation of improvements for safety or accessibility compliance.
11	f. Installation, removal, or alteration of fire and life safety equipment.
12	g. Changes to exterior paint colors when painting a previously painted
13	material. If the proposed color is similar to the existing, staff may be able to determine it to be
14	in-kind maintenance.
15	h. Replacement of non-original windows and doors when located in
16	original openings.
17	i. Emergency repairs or measures (including immediate action to secure
18	the area, install temporary equipment, and employ stabilization methods as necessary to protect
19	the public's safety, health, and welfare) to address hazardous conditions with adverse impacts to
20	the buildings or site as related to a seismic or other unforeseen event. Following such an
21	emergency, the owner shall adhere to the following:
22	1) The owner shall immediately notify the City Historic
23	Preservation Officer and document the conditions and actions the owner took.

1	2) If temporary structural supports are necessary, the owner shall
2	make all reasonable efforts to prevent further damage to historic resources.
3	3) The owner shall not remove historic building materials from the
4	site as part of the emergency response.
5	4) In consultation with the City Historic Preservation Officer and
6	staff, the owner shall adopt and implement a long-term plan to address any damage through
7	appropriate solutions.
8	Section 3. Incentives. The following incentives are granted on the features or
9	characteristics of 802 16th Avenue that were designated by the Board for preservation:
10	A. Uses not otherwise permitted in a zone may be authorized in a designated landmark by
11	means of an administrative conditional use permit issued under SMC Title 23.
12	B. Exceptions to certain of the requirements of the Seattle Building Code and the Seattle
13	Energy Code, adopted by SMC Chapter 22.101, may be authorized according to the applicable
14	provisions.
15	C. Special tax valuation for historic preservation may be available under chapter 84.26
16	RCW upon application and compliance with the requirements of that statute.
17	D. Reduction or waiver, under certain conditions, of minimum accessory off-street
18	parking requirements for uses permitted in a designated landmark structure may be permitted
19	under SMC Title 23.
20	Section 4. Enforcement of this ordinance and penalties for its violation are as provided in
21	SMC 25.12.910.
22	Section 5. 802 16th Avenue is added alphabetically to Section I, Residences, of the Table
23	of Historical Landmarks contained in SMC Chapter 25.32.
