10	Department of Construction and Inspections (SDCI) and given the Permit No. 3025996-

12	WHEREAS, following review and recommendations by the various City departments that have
13	jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of
14	Seattle on October 5, 2021, the Hearing Examiner approved the preliminary plat of "The
15	Dao" subject to certain conditions on October 7, 2021; and
16	WHEREAS, SDCI has confirmed that the preliminary plat conditions have been satisfied; and
17	WHEREAS, the Director of Transportation and the Director of SDCI have, subject to Council
18	approval, approved the final plat and have reported that the final plat now meets all of the
19	requirements of the State platting law (chapter 58.17 RCW) and of the Seattle Municipal
20	Code (Chapter 23.22), except for the execution of the required certifications by the King
21	County Assessor and the King County Finance Division; and
22	WHEREAS, the Director of Transportation and the Director of SDCI report that the plat of "The
23	Dao," a copy of which is in Clerk File 314450, is now complete and ready for City
24	Council approval; NOW, THEREFORE,

1	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
2	Section 1. The plat of "The Dao" in portions of the Northeast Quarter of Southeast
3	Quarter of Section 28, Township 24 North, Range 4 East, W.M., in King County, Washington, is

22	affixed their certifications as required by RCW 58.17.160(4), the requirements of State law and
23	City ordinances that were in effect at the time of preliminary plat approval will also have been
24	satisfied by the subdivider; and
25	(c) The public use and interest will be served by the establishment of the plat, and the
26	plat makes appropriate provision for the public health, safety, and general welfare.
