- GARBAGE, RECYCLE and COMPOST: USER shall remove and dispose all trash created by the event and/or the USER's food concession operation, the same day of operation in compliance with laws of the City of Seattle and policies of Seattle Parks and Recreation.  - a. Well-marked containers must be used for both vendors and attendees.
 - b. A clear plan must be developed by user and reviewed by Parks to separate and contain materials during the event for
 - i. Recycling
 - ii. composting
 - iii. garbage
 - c. In the event that primary sorting was not successful, a secondary plan is required where user will properly sort prior to transfer to garbage container. Plan must be reviewed in advance by Parks.
 - d. Failure to comply with garbage and recycling laws, policies and requirements will result in charges:
 - i. \$50 per day penalty paid to Seattle Public Utilities
 - ii. Payment for Parks staff time required to complete this work special rate of \$50 per hour with a two hour minimum
 - e. RECYCLE must comply with these standards: The user will collect the following materials for recycling:
 - i. Glass food and beverage containers
 - ii. Metal food and beverage containers
 - iii. Plastic food and beverage containers, lids and bottles
 - iv. Paper Cardboard and boxes, mixed and white paper, cartons (juice boxes, milk cartons)
 - f. COMPOST must comply with these standards: The user will collect the following materials for composting:
 - i. Food-soiled paper products: paper towels and napkins, paper plates and cups, tissue paper, pizza boxes, wax coated paper and wrappers, coffee filters and tea bags, wooden stir sticks and skewers
 - ii. Compostable serving ware must be certified compostable by the Biodegradable Products Institute (BPI)
 - iii. Raw and prepared food fruits and vegetables, meat, fish and bones, bread, pasta and baked goods, egg shells, dairy products and coffee grounds.
 - g. GARBAGE must comply with these standards: A dumpster for garbage can be located at a site designated by Aquatic Center Coordinator. The company must provide insurance to Seattle Parks and Recreation. Only products not identified as Recycle or Compost may go into garbage.
 - h. The user shall locate collection can groupings in front of the designated concession area(s) and spectator areas. The cans must be emptied periodically during operation of user's food concession and emptied at the end of each day of operation. Alongside each trash can, user

shall locate recycling and compost containers and will be responsible for the removal of these materials.
