# **1. BILL SUMMARY**

Legislation Title: AN ORDINANCE relating to the City's traffic code; amending Sections 11.14.055, 11.14.184, 11.23.380, 11.23.400, 11.31.020, 11.34.020, 11.56.020, 11.56.025, 11.56.320, 11.56.350, 11.56.355, 11.57.310, 11.72.065, and 11.84.380 of the Seattle Municipal Code, adding Section 11.58.435 to the Seattle Municipal Code, and repealing Section 11.14.185 of the Seattle Municipal Code to conform the Seattle Municipal Code with changes in state law and make technical corrections.

Summary and background of the Legislation: This legislation changes Seattle's traffic code to reflect changes made to identical state statutes by the 2015 Legislature and to correct other inconsistencies between state traffic statutes and our traffic code and incorrect references. It adds a definition of electric-assisted bicycle and modifies the definition of an electric personal assistive mobility device. With respect to disabled parking, it defines "unauthorized use" of a disabled parking placard, increases the classification of improper obtaining of disabled parking placard from an infraction to a crime, creates the infraction of improper display of disabled parking placard, creates the crime of selling disabled parking placard and authorizes a judge to forfeit the disabled parking placard of person who commits a disabled parking violation. With respect to the crime of Driving Under the Influence, this legislation expands the "safely off the roadway" defense to Physical Control to the crime of Minor Physical Control, authorizes a court to order a defendant to pay for the cost of pretrial electronic home monitoring, requires a court imposing an ignition interlock device (IID) as a condition of release to notify the Washington Department of Licensing and adds a mandatory condition of probation of not driving without a required IID. It also expands the crime of Driving While License Suspended 3<sup>rd</sup> degree to include driving after being suspended for failing to pay child support, expands the crime of Circumventing IID to include requesting another person to start the car, requires that a sentence for Circumventing IID run consecutively with a sentence for DUI, creates the traffic infraction of keeping, smoking or secreting marijuana in passenger compartment of car and allows bicycle or moped to disregard a traffic control light that fails to activate because of weight of the bicycle or moped.
