Winnie Stratton provided the following updates:

Results for fundraising event Party in the Park held on June 26, 2015: 552 attendees; Raffle Net Revenue \$13,750; Gross Revenue Total: \$501,250; Expenses \$197,353. The net revenue was \$303,897, the largest amount raised in the history of the event.

Call for approval of re-nomination of Robert Strong to the MDA (Museum Development Authority) Council. The motion was made, seconded and approved.

Winnie congratulated Lyn Grinstein and her husband Jerry as the recipients of the University of Washington 2015 Gates Volunteer Service Award.

Susan Brotman called for approval of new Trustee nomination for Johnpaul Jones. Jones is an architect and founding partner of Jones & Jones, located in Pioneer Square, was the overall lead design consultant for the Smithsonian's National Museum of the American Indian. Johnpaul was awarded the National Humanities Medal from the National Endowment for the Humanities (2014) conferred by President Barack Obama. Earning his Bachelor of Architecture from the University of Oregon in 1967, his design philosophy emerged from his Cherokee-Choctaw ancestors, which connects him to the natural world, animal world, spirit world, and human world. Johnpaul's work includes: Mukilteo Multimodal Ferry Terminal, Washington State Ferries; The Longhouse Education and Cultural Center, The Evergreen State College, Olympia; Mercer Slough Environmental Education Center, Bellevue; Japanese-American Nikkei World War II Exclusion Memorial, Bainbridge Island; Muckleshoot Indian Tribe Cultural Center & Museum Auburn; and The Confluence Project with Maya Lin, Washington. Johnpaul and his wife Marjorie live on Bainbridge Island.

The motion was made, seconded and approved.

Winnie Stratton thanked John Frank for connecting Johnpaul Jones with SAM's Board.

Susan Brotman called for approval of new Honorary Trustee nomination for Joseph Monsen.

Joseph served on the SAM Board of Trustees from 1966-1982. Joseph and his late wife Elaine gifted SAM several significant works, particularly the 12th c Amida Buddha which came into SAM's permanent collection in 2012. They also gave the museum several choice examples by some of the early 20th century master photographers, iconic works by Ansel Adams, Edward Weston, and others. They began collecting Asian art when they were in graduate school at the University of California at Berkeley. The

Monsens came to Seattle to join the faculty at the University of Washington. Joseph, an economist, was a professor in the School of Business.

The motion was made, seconded and approved.

Director's Report

- Kim Rorschach, Director and CEO, recognized Winnie Stratton for her work on the Board and especially all of the committee assignment work over the summer.
- Regan Pro was acknowledged and congratulated on her new position at SAM as the Kayla Skinner Deputy Director of Education and Public Programs.
- Kim Rorschach reported on the following:
 - o FY15 Admissions Totals: SAM 276,740; OSP 331,798; AAM 82,982. The grand total at all 3 sites is 691,520. The AAM total is the highest ever since it has been a museum devoted to Asian Art.
 - FY16 admissions Updates as of September 13, 2015 were reported as follows: SAM & AAM FY15 YTD Attendance: 96% of projection; Revenue: 86% of projection.
 - SAM's most recent special exhibition Disguise: Masks and Global African Art June 18 Sept 7, 2015: Final attendance totals were at 84% of projection; Revenue: 83% of projection. Kim noted that while this exhibition did not draw as many visitors as hoped, it was a very important and successful show for SAM in every other regard. It attracted a young and diverse audience to the museum, and it was very successful financially. Under SAM's name, the show will travel on to UCLA's Fowler Museum in LA, and then to the Brooklyn Museum in NY next spring.
 - Chiho Aoshima: Rebirth of the World May 2 Oct. 4, 2015 and Calligraphic Abstraction May 9 – Oct. 4, 2015, at the Asian Art Museum: Attendance to date is at 169% of projection; Revenue: 187% of projection.
 - SAM's Remix event on August 21, 2015 held at the Olympic Sculpture Park attracted the highest attendance in its event history with almost 3000 attendees. Kim thanked Trustee Cliff Burrows and Starbucks for sponsoring Remix. The next Remix event will be held on November 6, 2015 at SAM downtown.

SAM Forward - Renovation and Enhancement Campaign for the Asian Art Museum at Volunteer Park

- Kim Rorschach reviewed the SAM Forward (working title) VP Campaign preliminary architectural
 plans and showed a first cut video of a simulated walk through of the new building.
- Chris Landman, Director of Development, presented the soft phase campaign funding figures:
 - o Goal: \$46.2M; Total raised as of Sept. 2015: \$32,370,000
 - o Confirmed Planned Gift (possible acceleration) \$1,000,000
 - o Pending Requests \$3,800,000+

- Kim thanked Gursharan Sidhu for his Campaign Community leadership role with Mimi Gardner Gates.

Finance and Operations Report

- Richard Beckerman, COO, introduced SAM's new Controller Dawn Beck
- Richard Beckerman reviewed the FY15 Year End Close:
 - Net Income
 - Net Deficit of \$86k, which is \$566k better than planned; funded by excess leasing revenue Revenues
- FY15 revenues of \$22.4M were 2%, behind plan
- Earned revenue: The \$4.0M raised in FY15 was essentially in line with budget. Challenges in admissions were mitigated by outperformance by the Museum Shop, Group Admissions and the Rental/Sales Gallery.
- Contributed revenue: As a whole, contributed revenue came in \$385k behind plan or 97%.
 Challenges in membership and individual giving coupled with a smaller than anticipated contributions from the Fund for Special Exhibitions were the main drivers behind the lag. These were mitigated by positive variances in Events and Grant activity.

July FY16 Financial Report

YTD revenue was \$2,510,000 against a budget of \$2,614,000. YTD expense was \$1,942,000 against a budget of \$2,468,000, for a net YTD gain of \$568,000 against a budgeted net loss of (\$146,000).

Property Values for Insurance Coverage

Richard Beckerman presented the premium summary and estimated program cost figures.

- Expiring program estimated cost: \$261,650. Proposed program estimated costs: \$232,123 with Affiliated or \$221,500 with AIG. By reducing the property values by 14% and recognizing the additional insurance we already pay for through the Condominium Association, we were able to reduce the premium cost by as much as 15% (based on the AIG quote).
- A motion was made to accept the presented changes in property values for the property insurance coverage. The motion was made, seconded, and approved. The staff was directed to make a determination of which carrier to use.
- A request was made to review the collection insurance figures at a future Executive meeting.

Deferred Maintenance Financing

Lee Richardson, SAM's Director of Facilities, presented a Building Systems Repair and Replacements Report. SAM's goals are to:

- Replace or refurbish end of life system infrastructure
- Develop solutions that optimize performance while improving energy and water efficiency
- Innovate where applicable
- Identify alternative funding & financing

To result in the following solutions:

- With the Venturi mechanical system; new chillers and related equipment
- Throughout the Downtown Facility:
 - Update the computer control of the building management system
 - Optimizing heat recovery, metering and measurement of various water flows in mechanicals systems for improved monitoring and control
 - Upgrade to LED lighting, improve lighting efficiency, and update lighting controls
- Assist with securing favorable financing with QECB bonds (Qualified Energy Conservation Bonds) through the Washington State Housing Financing Commission and as part of the King County Green Communities Program.

Richard Beckerman then presented the following:

- Finance Committee has reviewed and recommends that we move ahead with arranging financing with their ongoing oversight
- The next step, if approved by Executive Committee, or the Board President to sign the Reimbursement Resolution, which is a declaration from SAM to use funds for intended purpose and to agree to repay the loan
- This Resolution allows SAM staff to begin putting financing into place without making a final
- Once financing is arranged, the Executive Committee reviews and votes on final approval at Nov. 4, 2015 Executive Committee meeting (or at a special meeting if needed)

A motion was made to call for approval of the Executive Committee Resolution of Waiver. The motion was made, seconded, and approved.
