1. BILL SUMMARY

Legislation Title: A RESOLUTION recognizing the obstacles faced by previously incarcerated individuals that often result in recidivism, and the potential to reduce recidivism rates, criminal justice costs, and incarceration's negative impacts on individuals, the community, and the City of Seattle; requesting the Mayor to establish a Prisoner and Community Corrections Re-entry Work Group composed of residents, City departments, the Seattle Municipal Court, and the Legislative Department to coordinate and strengthen the City's efforts to assist prisoner community re-entry.

Summary and background of the Legislation:

This Resolution recognizes the multiple barriers individuals with a past criminal conviction face in re-integrating into the community, often resulting in their recidivism, and that there are actions the City can take to reduce these barriers. This Resolution; 1) re-affirms the City's support for HS 1553, introduced in the State Legislature in 2015, which would remove state barriers to occupational licenses and certifications based on a conviction resulting in increased employment opportunities for people with criminal convictions, 2) requests the Mayor to convene a Prisoner and Community Corrections Re-entry Work Group (Work Group) including residents and representatives of the Mayor, Office of Housing, Seattle Office for Civil Rights, Human Services Department, Legislative Department and Seattle Municipal Court to identify ways the City can reduce or remove barriers to successful re-entry, strengthen coordination with other criminal justice agencies and recommend changes to or additional policies, ordinances, strategies or programs the City can implement. This work should include coordination with the Housing Affordability and Livability Advisory Committee (HALA) recommendations. The Work Group is requested to develop a schedule and anticipated deliverables and report regularly to the Council's Public Safety, Civil Rights and Technology Committee or Council committee with oversight of public safety.

The 2016 Adopted City Budget is anticipated to add an 1.0 FTE added to the Office for Civil Rights to work on both the Zero Detention efforts outlined in Resolution 31614 and the work on Prisoner and Community Corrections Re-entry identified in this Resolution. The position is a SA2 General Government position funded by GSF.
