1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to transportation; repealing and amending various sections of the Transit Master Plan as adopted by Resolution 31367 and adopting new sections.

Summary and background of the Legislation: Amendments to the Transit Master Plan incorporating a bus rapid transit network plan and investments to RapidRide corridors. This amendment allows projects funded by the Transportation Levy to Move Seattle to be adopted by City Council in anticipation of submittal to Puget Sound Regional Council (PSRC) allowing for future federal, state, and local funding in 2018 through 2020.

This legislation would facilitate SDOT securing future funding for transit corridor improvements that would provide 72% of Seattle residents with a 10 minute or better all-day, high quality transit service within a 10-minute walk from their home by 2025.
