

% saying they have ... in order to care for a child or family member




Notes: Based on those who have ever worked, "Fathers" and "mothers" include those with children of any age, including adult children (n=1,254).

SAFE COMMUNITIES

Safe Communities – Govt Entities

- Police Department Public safety, crime prevention, law enforcement.
- Office of Emergency Management Citywide emergency management, emergency preparedness, related grants, and operational readiness.
- Fire Department Fire protection and prevention, rescue, and emergency medical services through 33 fire stations.
- Municipal Court Court of limited jurisdiction adjudicating misdemeanor and gross misdemeanor crimes, infractions and civil violations under the Seattle Municipal Code.
- Law Department Criminal prosecution of traffic infractions, misdemeanors and gross misdemeanors in Seattle Municipal Court, representing the City in lawsuits and advising City officials, and liaisons to each police precinct.

Public Safety is over half of the General Fund (\$600M out of \$1.1B)

- Initiate and implement policies that maximize Seattle's social and economic recovery and minimize impacts of disasters.


