I am interested in being a member of the Seattle Planning Commission and ask that you consider me for one of the current openings. I believe that my employment experience, education, and involvement in the community will make me a valuable addition to the Planning Commission. Enclosed please find my resume for consideration for the Seattle Planning Commission.

After completing a graduate program in Urban Planning and Real Estate Development at the University of Michigan in 2008, I moved to Seattle to pursue a career in urban planning. I worked between 2008 and 2011 as a long range planner with the City of Puyallup. In 2011, I began work with the Growing Transit Communities team at the Puget Sound Regional Council (PSRC), and am now a Senior Planner on that project.

I feel that I would bring a valuable perspective to the Seattle Planning Commission as a public sector planner and resident of the Rainier Valley. I understand how economic and policy decisions impact people, but understand the role and limitations of cities. I have focused on learning more about equitable and diverse transit communities. In addition, I believe that, I have more than melded my professional beliefs and my personal life. During the majority of my tenure with Puyallup, I did not own a car, and chose to live in the International District (in Seattle) specifically because of the access to the Sounder train that enabled me to travel by public transportation to and from work. In 2011, I moved from the International District to one of the first transit-oriented development projects along the Central Link Light Rail line. From my new home in the Othello neighborhood in the Rainier Valley, I use the light rail to get to my PSRC job. Since moving to the Othello community, I have become active in the Othello Park Alliance, Angel-Morgan P-Patch, and other community groups.

In these roles, I have participated in analytical work, neighborhood planning, and numerous types of planning and other city and regional projects requiring a wide range of skills. While at the City of Puyallup I worked primarily on comprehensive planning, but also led a robust City program to install rain gardens and other low impact development projects throughout Puyallup neighborhoods. At PSRC my efforts have focused on increasing affordable housing opportunities for residents in transit communities by working to develop new financing and funding sources. In addition, I have developed a keen understanding of the Growth Management Act and comprehensive planning. I am a certified planner through the American Planning Association and have been active in both the statewide and national groups and conferences.

The path I have taken in my studies, work experience, and personal life has given me broad knowledge and various perspectives on planning. Through my time living in the International District and Othello neighborhoods I have learned about the impacts of planning on diverse cultures and neighborhoods. Seattle is my home, and I am excited about the chance to work on improving our City with the impressive group of professionals that make up the Planning Commission and Staff.

I appreciate your consideration of my application and welcome the opportunity to talk about it.
