Dear Vanessa Murdock and members of the Seattle Planning Commission Selection Committee:

Please accept this letter and attached resume as prove of my interest and qualifications to join the Commission.

I am a long term Seattle resident, I moved to Seattle 20 yrs. ago this February. I am a transit-dependent, Latino, gay male. I have strong grassroots community connections as proven by the work and volunteer opportunities I have pursued and stated in my resume.

My interest and expertise in environmental issues, environmental and climate justice are supported by the work I have done with Puget Sound Clean Air Agency (PSCAA) and my work as a member of Got Green's Volunteer Board of Directors and are what drive me to apply to the Planning Commission.

I have a strong civic engagement background. I have volunteered with organizations such as Entre Hermanos, a GLBTQ advocacy organization, Latino Educational Training Institute and Environmental People of Color, Seattle Chapter (EPOC- Seattle). Further prove of my civic inclination is the work I conducted with Social Justice Fund NW in the Gender Justice and Environmental Justice Giving Projects as a trainer and facilitator.

I am also a small business owner. Julio Sanchez and Associates, my consulting outlet, have provided facilitation services to King Co. Equity and Justice office. This opportunity and my work with PSCAA prepare me to work within and in collaboration with Government organizations, I think this is a definite plus as an aspiring commissioner.

My commitment and interest in leadership development moved me to seek, and be selected to Puget Sound Sage's Leadership Development Institute. A rigorous leadership development institute where I devoted over 100 hours to honing my expertise land-use and planning, affordable housing, equitable transit systems, labor systems, and climate justice. I also have a strong creative background which has prompted me to work in marketing, media productions and communications.

Before I joined Sage's CLI I did not recognize the importance of urban planning on our environment. As the civic and leadership training of the CLI progressed, I became exposed to the enormous impact

planning has on all aspects of our lives. I also realized why is critical that the most under-represented communities claim a place at the table: the negative effects of all aspects of planning are most unfairly and acutely felt by us. We are routinely absent from the table, and we often have less private resources and possibilities to ameliorate the impacts of these measures.

As a resident of Seattle, I have lived in the Central District for more that 10 yrs., as a person who is transit depended, as a person who is deeply connected to POC groups, immigrant communities and low income workers I believe I bring a strong and often overlooked perspective to the planning work the Commission handles.

If chosen, I would bring my personal perspective and the experiences of the communities I represent to the challenges faced by the Commissions. The process of implementing the comprehensive plan, developing an equity and environment initiative (or at least linking it to the city's planning work), implementing the city's Affordable Housing and Livability Agenda (HALA), need to be done with a strong Equity and Justice lens. That is what I can do if chosen as a commissioner.

Finally, my sense of humor, positive and team oriented collaborative style, together with my experience as a facilitator with a strong communications background will further strengthen my candidacy to the Commission.
