In preparation for the opening of the Roosevelt LINK light-rail station, developed a streetscape concept for safe pedestrian and bicycle station access. Concept included implementation of a neighborhood greenway and protected bicycle lane as identified in the SDOT Bicycle Master Plan.

## University District Alley Activation Plan, Seattle, WA

Prepared an alley activation plan analyzing short-term interventions and long-term transformations to foster active pedestrian and programmatic use of U-District alleys, including a street concept plan, prioritized recommendations and implementation process. Project included robust stakeholder engagement and community participation.
