The name of a portion of Broad Street between 9th Avenue N and Westlake 29 Avenue N is changed to Roy Street, superseding prior ordinances to the extent inconsistent. 30

Section 2. The name of a portion of Warren Place between Warren Avenue N and its east terminus, located in H.A. Raser's Addition as recorded in Volume 24 of Plats, page 35, is changed to Warren Place N.

Section 3. The name of a portion of S Della Street between 27th Avenue S and Martin Luther King Jr. Way S, located between Blocks 1 and 2 in plat Cascade View Addition as recorded in Volume 15 of Plats, page 75, is changed to S Walden Street.

Section 4. The name of a portion of Cloverdale Place S between Rainier Avenue S and Seward Avenue S is changed to S Cloverdale Place, superseding Ordinance 105740 to the extent inconsistent.

Section 5. The name of a portion of NW 35th Street between 1st Avenue NW and NW Canal Street, located between Block 51 and Block 50, Denny and Hoyt's Addition, as recorded in Volume 2 of Plats, page 136, is changed to NW Canal Street, superseding prior ordinances to the extent inconsistent.

Section 6. The name of a portion of 1st Avenue NW between the south margin of N Canal Street and N 35th Street, located between Block 47 and Block 50, Denny and Hoyt's Addition, as recorded in Volume 2 of Plats, page 136, is changed to N Canal Street, superseding prior ordinances to the extent inconsistent.

Section 7. The name of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE, between its south terminus at the shoreline and the south margin of NE Pacific Street, is changed to Eastlake Place NE, superseding Ordinance 61346 to the extent inconsistent.

Section 8. The name of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE, between the north margin of NE Pacific Street and the south margin of NE

Seattle, as recorded in Volume 7 of Plats, page 34, is named Yale Terrace E.

Section 12.
