A RESOLUTION	Legislation Title: A RESOLUTION proclaiming the City of Seattle's Support for the Standing Rock Sioux Tribe's Opposition to the Construction of the Dakota Access Pipeline.							
Summary and background of the Legislation: This resolution states the City's support for the Standing Rock Sioux Tribe's opposition to construction of the Dakota Access Pipeline (DAPL) across the Tribe's ancestral lands and waters. The resolution also calls upon the United States and the Army Corps of Engineers to consult with and obtain the free, prior and informed consent of the Standing Rock Sioux Tribe, prior to taking any federal action regarding the DAPL that would harm or destroy the Tribe's ancestral lands and waters and sacred sites. Finally, the resolution proclaims that the City of Seattle will commemorate and support the Standing Rock Sioux Tribe's opposition to the DAPL on October 10, 2016 (Indigenous Peoples' Day in the City of Seattle). 2.
