1. BILL SUMMARY

Legislation Title: A RESOLUTION to enter a partnership with the U.S. Fish and Wildlife Service to participate in the U.S. Fish and Wildlife Service's Urban Conservation Treaty for Migratory Birds Program encouraging the exploration and incorporation of bird-friendly policies, design, and best practices for creating, enhancing, and maintaining safe habitats for migratory birds and other urban wildlife.

Summary and background of the Legislation: The United States Fish and Wildlife contacted the City of Seattle about partnering with them through the Urban Conservation Treaty for Migratory Birds Program. This program provides grant funding and support for cities to use towards creating a better environment for migratory and non-migratory birds through infrastructure and education. The City of Seattle meets all of the necessary qualifications to receive this designation. Although, we are not requesting grant funding at this time, with this designation we would be eligible to apply for grants in the future.

Seattle sits in the Pacific Flyway, which is a major North-South migratory route for many species that travel from Patagonia to Alaska. Other major cities to join the Urban Bird Treaty in the Pacific Flyway are San Francisco, CA and Portland, OR.

The designation would not cost anything but would demonstrate our commitment to a healthy ecology.
