Budget Action description:

This budget action would add 6.0 FTEs funded with \$246,347 GSF in 2017 and \$507,829 GSF in 2018 for police communications call takers in the 911 Communications Center.

Since 2010, SPD reports an increase of 43 percent in Priority 1 calls for service and a 31 percent increase in overtime due to the additional demand for service. SPD reports that the call center failed to meet the State's call answering standards in one quarter of 2014, which jeopardized state funding. The call center then used 29,500 hours of overtime for shift backfill to meet the state standards in 2015. According to SPD, preliminary results from a departmental workload analysis appear to support the addition of at least 30 more call takers. The Mayor's proposed budget would

add 9 call takers in 2017 and also fund the ongoing costs of three dispatch supervisor positions added in the 2016 1st quarter supplemental ordinance. This proposal would increase call taker FTEs added in 2017 from 9.0 to 15.0. The six proposed call takers would be hired by mid-year in 2017, which is the estimated timeframe for bringing them on board with the 2017 recruit classes.

The 2018 Proposed Budget includes funding to hire an additional 10 call takers and 3 supervisors.
