This green sheet would add \$76,000 GSF in both 2017 and 2018 to the Human Services Department (HSD) for one legal navigator to serve Seattle residents from the downtown King County Courthouse. This navigator will be the point person to both assess the victim's civil legal needs and refer them to a civil legal aid provider to

provide legal assistance as appropriate to the victim's needs and circumstances. The goal is to serve 500 people in the initial 12 month period.

SERVICE MODEL

Legal assistance is an on-going need for domestic violence and sexual assault survivors, especially for those needing family law and protection order support. Annually, the King County Protection Order Office has 5,500 domestic violence related hearings; One-fifth (1/5) are for City of Seattle residents.

This investment would support partial/full funding for an individual (i.e. civil legal aid attorney, paralegal) provide on-site legal consultation, assistance, and/or "day of" representation for domestic violence and sexual assault survivors. Additional services may include legal clinics to provide training, assistance, and support for survivors, advocates, and attorneys on domestic violence protection order declarations, sexual assault protection orders, family law, immigration law, assistance with U Visas and related, referrals to other agencies and attorneys network.
