Yes. This legislation provides for annual increases of certain fees to generally keep pace with inflation costs.

Experience suggests that regular periodic changes in certain fees help to maintain cost recovery levels and improve public understanding of costs. SDOT is seeking to avoid the large step increases caused when fees are not updated for 5 years or more by authorizing smaller, annual increases.
