1. BILL SUMMARY

Legislation Title:

AN ORDINANCE conditioning the Seattle Department of Transportation's 2017 grant applications, and repealing Ordinance 118719.

Summary and background of the Legislation:

The Seattle Department of Transportation (SDOT) relies on a variety of state, federal, and external funding grants to fund transportation projects in the Capital Improvement Plan. In applying for grants, SDOT is signaling a City commitment to the project, which may have local match requirements or on-going operations and maintenance costs. Although Council may take action to support a specific grant application on a case-by-case basis, there is currently no formal requirement for Council approval of grant applications. Council action is required to accept the grant funds.

This legislation would authorize SDOT to apply for external grants for specific capital projects identified in the legislation. The legislation is permissive and would allow SDOT to seek grants for any of the projects listed, but does not require that SDOT apply for grants for any specific project. Unless listed in the legislation, SDOT would be prohibited from applying for project grants of more than \$5 million. This ordinance could be amended over the course of 2017 to reflect new grant opportunities or changes to capital priorities.

In 2014 and 2015, SDOT applied for 42 grants, 10 of which were for more than \$5 million of grant funding. Three of these large projects successfully secured grant funding:

- Broadway Streetcar Extension, \$10,000,000 request (2014 PSRC CMAQ and FTA Competitive Program)
- Center City Protected Bike Lanes, \$5,000,000 request (2014 PSRC CMAQ Program)
- Center City Connector Streetcar, \$75,000,000 request (2015 FTA Small Starts program)

Ordinance 118719 provided blanket authority for SDOT to seek and accept grants for projects in the CIP. The ordinance also included quarterly reporting requirements to Council. This has not been standard procedure for SDOT in recent years, and this legislation repeals the ordinance.
