## 1. BILL SUMMARY

**Legislation Title:** A RESOLUTION establishing a capital project oversight work program for the Budget Committee for 2017.

**Summary and background of the Legislation:** In recognition of the importance of capital project oversight for transparency, public accountability and fiscal responsibility, this resolution would establish a capital project oversight work program for the Budget Committee for 2017.

The work program will include developing phased appropriation requirements, establishing requirements for Council authorization of large capital project grant applications, and improving budgetary controls over capital project contingency usage. The work of the Budget Committee in 2017 will also include improving the utility of capital project information communicated to the Council via enhanced quarterly variance reporting, improved organization and content of capital project information transmitted with the proposed budget, and coordinated communication with the Executive Capital Subcabinet. An ad hoc panel of independent experts on capital budgeting and project oversight will be convened by the Council and Mayor to review current City practices and capital projects, and to make recommendations for improvement.

Altogether, the goal of the resolution is to create new rigor in capital project oversight and provide more public transparency.

Capital project oversight reduces the likelihood of projects expanding scope or running over schedule or budget.
