1. BILL SUMMARY

Legislation Title:

AN ORDINANCE relating to the City Light Department; declaring as surplus and authorizing the General Manager and Chief Executive Officer of the City Light Department to partially release three easements for electrical service in King County, Washington; and ratifying and confirming certain prior acts.

Summary and background of the Legislation:

Summary. This legislation will declare as surplus and authorize Seattle City Light to partially release three easements for electrical service.

Background. City Light requires that the owner of a new or altered electrical service provide The City of Seattle with a utility easement whenever City Light conductors must pass over, under, or through the property of another person, or when service equipment such as poles or vaults must be located either on the property being served or the property of a third person.

From time to time, the owner of a property will request that all or a portion of an electrical service easement be released, usually to facilitate new construction. Upon determination that all or a portion of the easement is no longer required to provide electrical service to the customer, and subject to approval by the City Council, City Light will provide a release of easement to accommodate the customer's request.
